A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Education Credit**

3 FOR the purpose of allowing a credit against the State income tax for contributions made
4 to certain student assistance organizations; requiring the Department of Economic
5 Competitiveness and Commerce to administer the tax credit; requiring an entity to
6 submit an application to be a student assistance organization by a certain date each
7 year; requiring a student assistance organization to meet certain qualifications;
8 requiring a business entity to submit a certain application within a certain time
9 period and to make a contribution to a student assistance organization and to provide
10 certain notice within a certain time period; requiring the Department to adopt
11 certain regulations; requiring the Department to approve certain applications within
12 a certain time period and in a certain manner; requiring the Department to rescind
13 certain tax credit certificates if certain notice is not provided within a certain time
14 period; providing limits on the amount of certain tax credits and the aggregate
15 amount of tax credits that may be approved by the Department in a calendar year;
16 establishing the Maryland Education Tax Credit Reserve Fund; authorizing the
17 Governor to include an appropriation to the Fund in the annual budget bill and
18 providing the intent of the General Assembly that the appropriation may not exceed
19 a certain amount each year; requiring the Comptroller to transfer certain amounts
20 from the Fund to the General Fund under certain circumstances; providing that
21 certain unused tax credits may not be carried forward; requiring the Department to
22 publish and update a certain list in a certain manner each year and report certain
23 information on the credit each year; requiring a certain addition modification under
24 the Maryland income tax if a certain tax credit is claimed; defining certain terms;

19 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
20 INDICATED.

21 (2) “BUSINESS ENTITY” MEANS:

22 (I) A PERSON CONDUCTING OR OPERATING A TRADE OR
23 BUSINESS IN MARYLAND; OR

24 (II) AN ORGANIZATION OPERATING IN MARYLAND THAT IS
25 EXEMPT FROM TAXATION UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE.

26 (3) “CONTRIBUTION” MEANS A MONETARY DONATION.

27 (4) “DEPARTMENT” MEANS THE DEPARTMENT OF ECONOMIC
28 COMPETITIVENESS AND COMMERCE.

29 (5) “ELIGIBLE SCHOOL” MEANS:

1 (I) A PUBLIC PREKINDERGARTEN PROGRAM, AN ELEMENTARY
2 PUBLIC SCHOOL, OR A SECONDARY PUBLIC SCHOOL; OR

3 (II) A NONPUBLIC PREKINDERGARTEN PROGRAM, AN
4 ELEMENTARY NONPUBLIC SCHOOL, OR A SECONDARY NONPUBLIC SCHOOL THAT:

5 1. HOLDS A CERTIFICATE OF APPROVAL FROM OR IS
6 REGISTERED WITH THE STATE BOARD OF EDUCATION;

7 2. DOES NOT CHARGE TUITION THAT IS GREATER THAN
8 THE STATEWIDE AVERAGE PER PUPIL EXPENDITURE BY THE LOCAL EDUCATION
9 AGENCIES CALCULATED BY THE STATE DEPARTMENT OF EDUCATION WITH
10 EXCEPTIONS FOR SPECIAL EDUCATION STUDENTS DETERMINED BY THE STATE
11 DEPARTMENT OF EDUCATION TO BE APPROPRIATE;

12 3. ADMINISTERS A NATIONALLY ACKNOWLEDGED
13 ACHIEVEMENT TEST TO THE STUDENTS; AND

14 4. COMPLIES WITH TITLE VI OF THE CIVIL RIGHTS ACT
15 OF 1964, AS AMENDED.

16 (6) "PREKINDERGARTEN PROGRAM" MEANS A PREKINDERGARTEN
17 EDUCATION PROGRAM THAT HAS OBTAINED A LICENSE, LETTER OF COMPLIANCE,
18 OR CERTIFICATE OF APPROVAL FROM THE STATE BOARD OF EDUCATION.

19 (7) (I) "QUALIFIED EDUCATION EXPENSES" MEANS QUALIFIED
20 ELEMENTARY AND SECONDARY EDUCATION EXPENSES AS DEFINED IN §
21 530(B)(3)(A) OF THE INTERNAL REVENUE CODE.

22 (II) "QUALIFIED EDUCATION EXPENSES" INCLUDES EXPENSES
23 FOR:

24 1. ACADEMIC TUTORING;

25 2. BOOKS, SUPPLIES, AND OTHER EQUIPMENT;

26 3. COMPUTER TECHNOLOGY, EQUIPMENT, OR INTERNET
27 ACCESS;

28 4. SPECIAL NEEDS SERVICES;

29 5. TRANSPORTATION;

1 **6. TUITION AND FEES; OR**

2 **7. UNIFORMS THAT ARE REQUIRED BY AN ELIGIBLE**
3 **SCHOOL.**

4 **(8) "STUDENT ASSISTANCE ORGANIZATION" MEANS AN ENTITY THAT:**

5 **(I) IS EXEMPT FROM TAXATION UNDER § 501(C)(3) OF THE**
6 **INTERNAL REVENUE CODE;**

7 **(II) PROVIDES FINANCIAL ASSISTANCE FOR QUALIFIED**
8 **EDUCATION EXPENSES TO STUDENTS ATTENDING ELIGIBLE SCHOOLS IN THE STATE;**
9 **AND**

10 **(III) MEETS THE REQUIREMENTS OF SUBSECTION (C)(1) OF THIS**
11 **SECTION.**

12 **(B) (1) SUBJECT TO THE PROVISIONS OF THIS SUBSECTION, A BUSINESS**
13 **ENTITY MAY CLAIM A CREDIT AGAINST THE STATE INCOME TAX IN AN AMOUNT**
14 **EQUAL TO 60% OF A CONTRIBUTION MADE TO A STUDENT ASSISTANCE**
15 **ORGANIZATION.**

16 **(2) A CREDIT CLAIMED BY A BUSINESS ENTITY UNDER THIS SECTION**
17 **MAY NOT EXCEED \$200,000 IN EACH TAXABLE YEAR.**

18 **(C) (1) TO QUALIFY AS A STUDENT ASSISTANCE ORGANIZATION, AN**
19 **ENTITY SHALL:**

20 **(I) APPLY TO THE DEPARTMENT ON OR BEFORE DECEMBER 1**
21 **EACH YEAR;**

22 **(II) PROVIDE FINANCIAL ASSISTANCE FOR QUALIFIED**
23 **EDUCATION EXPENSES TO STUDENTS ATTENDING ELIGIBLE SCHOOLS;**

24 **(III) PROVIDE FINANCIAL ASSISTANCE TO AT LEAST FOUR**
25 **DIFFERENT ELIGIBLE SCHOOLS IN EACH CALENDAR YEAR;**

26 **(IV) CONTRIBUTE OR IRREVOCABLY ENCUMBER AT LEAST 90%**
27 **OF ANNUAL CASH RECEIPTS RECEIVED AS THE RESULT OF CONTRIBUTIONS**
28 **APPROVED FOR TAX CREDITS UNDER THIS SECTION TOWARD FINANCIAL**
29 **ASSISTANCE FOR QUALIFIED EDUCATION EXPENSES TO STUDENTS AT ELIGIBLE**
30 **SCHOOLS AS PROVIDED UNDER THIS SECTION;**

1 (V) PROVIDE FINANCIAL ASSISTANCE FOR QUALIFIED
2 EDUCATION EXPENSES ON A PRIORITY BASIS FIRST TO STUDENT APPLICANTS WHO
3 ARE ELIGIBLE FOR FREE AND REDUCED-PRICE MEALS BASED ON ELIGIBILITY
4 REQUIREMENTS ESTABLISHED BY THE UNITED STATES DEPARTMENT OF
5 AGRICULTURE AND THEN TO OTHER STUDENT APPLICANTS BASED ON FINANCIAL
6 NEED;

7 (VI) SUBMIT TO THE DEPARTMENT THE APPLICATION AND
8 REVIEW PROCESS FOR ELIGIBILITY FOR FINANCIAL ASSISTANCE FOR QUALIFIED
9 EDUCATION EXPENSES BASED ON DEMONSTRATED FINANCIAL NEED; AND

10 (VII) ON OR BEFORE JANUARY 1 EACH YEAR, SUBMIT
11 VERIFICATION TO THE DEPARTMENT THAT ALL REQUIREMENTS FOR ELIGIBILITY
12 UNDER THIS PARAGRAPH HAVE BEEN MET IN THE PRIOR CALENDAR YEAR.

13 (2) IN THE APPLICATION REQUIRED UNDER PARAGRAPH (1) OF THIS
14 SUBSECTION, A STUDENT ASSISTANCE ORGANIZATION SHALL STATE IF THE
15 ORGANIZATION WILL PROVIDE FINANCIAL ASSISTANCE FOR QUALIFIED EDUCATION
16 EXPENSES TO:

17 (I) STUDENTS AT ELIGIBLE SCHOOLS THAT ARE PUBLIC; OR

18 (II) STUDENTS AT ELIGIBLE SCHOOLS THAT ARE NONPUBLIC.

19 (D) (1) AT LEAST 45 DAYS PRIOR TO MAKING A CONTRIBUTION TO A
20 STUDENT ASSISTANCE ORGANIZATION, A BUSINESS ENTITY SHALL APPLY TO THE
21 DEPARTMENT FOR AN INITIAL TAX CREDIT CERTIFICATE.

22 (2) THE APPLICATION FOR AN INITIAL TAX CREDIT CERTIFICATE
23 SHALL IDENTIFY IF THE STUDENT ASSISTANCE ORGANIZATION PROVIDES
24 FINANCIAL ASSISTANCE FOR QUALIFIED EDUCATION EXPENSES TO:

25 (I) STUDENTS AT ELIGIBLE SCHOOLS THAT ARE PUBLIC; OR

26 (II) STUDENTS AT ELIGIBLE SCHOOLS THAT ARE NONPUBLIC.

27 (E) THE DEPARTMENT SHALL:

28 (1) ADOPT REGULATIONS TO IMPLEMENT THIS SECTION, INCLUDING
29 THE METHOD FOR REPORTING BY STUDENT ASSISTANCE ORGANIZATIONS TO
30 ENSURE COMPLIANCE WITH THIS SECTION;

1 **(2) APPROVE ALL APPLICATIONS FOR TAX CREDITS UNDER THIS**
2 **SECTION ON A FIRST-COME, FIRST-SERVED BASIS;**

3 **(3) WITHIN 60 DAYS AFTER RECEIPT, APPROVE OR REJECT AN**
4 **ENTITY'S APPLICATION TO BECOME A STUDENT ASSISTANCE ORGANIZATION;**

5 **(4) WITHIN 45 DAYS AFTER RECEIVING AN APPLICATION, ISSUE AN**
6 **INITIAL TAX CREDIT CERTIFICATE AS PROVIDED UNDER THIS SECTION STATING THE**
7 **MAXIMUM AMOUNT OF THE TAX CREDIT FOR WHICH A BUSINESS ENTITY IS ELIGIBLE**
8 **OR PROVIDE NOTICE OF REJECTION OF THE APPLICATION THAT CONTAINS AN**
9 **EXPLANATION OF THE REASON FOR REJECTION;**

10 **(5) WITHIN 45 DAYS AFTER RECEIVING NOTICE OF A CONTRIBUTION**
11 **MADE TO A STUDENT ASSISTANCE ORGANIZATION, ISSUE A FINAL TAX CREDIT**
12 **CERTIFICATE AS PROVIDED UNDER THIS SECTION; AND**

13 **(6) PUBLISH AN ANNUAL LIST OF ALL STUDENT ASSISTANCE**
14 **ORGANIZATIONS APPROVED BY THE DEPARTMENT.**

15 **(F) (1) AFTER THE DEPARTMENT HAS ISSUED AN INITIAL TAX CREDIT**
16 **CERTIFICATE UNDER THIS SECTION, THE BUSINESS ENTITY SHALL HAVE 90 DAYS TO**
17 **MAKE A CONTRIBUTION TO A STUDENT ASSISTANCE ORGANIZATION UNDER THIS**
18 **SECTION.**

19 **(2) WITHIN 60 DAYS AFTER MAKING A CONTRIBUTION TO A STUDENT**
20 **ASSISTANCE ORGANIZATION, A BUSINESS ENTITY SHALL PROVIDE NOTICE TO THE**
21 **DEPARTMENT OF THE AMOUNT OF THE CONTRIBUTION.**

22 **(3) IF A BUSINESS ENTITY FAILS TO MAKE A CONTRIBUTION TO A**
23 **STUDENT ASSISTANCE ORGANIZATION WITHIN 90 DAYS AFTER RECEIVING AN**
24 **INITIAL TAX CREDIT CERTIFICATE, THE DEPARTMENT SHALL RESCIND THE INITIAL**
25 **TAX CREDIT CERTIFICATE.**

26 **(G) (1) IN THIS SUBSECTION, "RESERVE FUND" MEANS THE MARYLAND**
27 **EDUCATION TAX CREDIT RESERVE FUND ESTABLISHED UNDER PARAGRAPH (2) OF**
28 **THIS SUBSECTION.**

29 **(2) (I) THERE IS A MARYLAND EDUCATION TAX CREDIT RESERVE**
30 **FUND THAT IS A SPECIAL CONTINUING, NONLAPSING FUND THAT IS NOT SUBJECT**
31 **TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

1 **(II) THE MONEY IN THE RESERVE FUND SHALL BE INVESTED**
2 **AND REINVESTED BY THE STATE TREASURER, AND INTEREST AND EARNINGS SHALL**
3 **BE CREDITED TO THE GENERAL FUND.**

4 **(3) (I) EXCEPT AS PROVIDED IN PARAGRAPH (7) OF THIS**
5 **SUBSECTION, THE DEPARTMENT MAY NOT ISSUE INITIAL TAX CREDIT CERTIFICATES**
6 **FOR CREDIT AMOUNTS IN THE AGGREGATE TOTALING MORE THAN THE AMOUNT**
7 **APPROPRIATED TO THE RESERVE FUND FOR THAT FISCAL YEAR IN THE STATE**
8 **BUDGET AS APPROVED BY THE GENERAL ASSEMBLY.**

9 **(II) IF THE AGGREGATE CREDIT AMOUNTS UNDER INITIAL TAX**
10 **CREDIT CERTIFICATES ISSUED IN A FISCAL YEAR TOTAL LESS THAN THE AMOUNT**
11 **APPROPRIATED TO THE RESERVE FUND FOR THAT FISCAL YEAR, ANY EXCESS**
12 **AMOUNT SHALL REMAIN IN THE RESERVE FUND AND MAY BE ISSUED UNDER INITIAL**
13 **TAX CREDIT CERTIFICATES FOR THE NEXT FISCAL YEAR.**

14 **(III) IF THE AGGREGATE CREDIT AMOUNTS UNDER INITIAL TAX**
15 **CREDIT CERTIFICATES APPROVED FOR ELIGIBLE SCHOOLS THAT ARE PUBLIC**
16 **SCHOOLS IN A CALENDAR YEAR TOTAL LESS THAN 40% OF THE AMOUNT**
17 **APPROPRIATED TO THE RESERVE FUND FOR THAT FISCAL YEAR, THE EXCESS MAY**
18 **BE USED TO APPROVE INITIAL TAX CREDIT CERTIFICATES FOR ELIGIBLE SCHOOLS**
19 **THAT ARE NONPUBLIC SCHOOLS DURING THE NEXT CALENDAR YEAR.**

20 **(IV) FOR ANY FISCAL YEAR, IF FUNDS ARE TRANSFERRED FROM**
21 **THE RESERVE FUND UNDER THE AUTHORITY OF ANY PROVISION OF LAW OTHER**
22 **THAN UNDER PARAGRAPH (6) OF THIS SUBSECTION, THE MAXIMUM CREDIT**
23 **AMOUNTS IN THE AGGREGATE FOR WHICH THE DEPARTMENT MAY ISSUE INITIAL**
24 **TAX CREDIT CERTIFICATES SHALL BE REDUCED BY THE AMOUNT TRANSFERRED.**

25 **(4) (I) FOR EACH FISCAL YEAR, THE GOVERNOR MAY INCLUDE IN**
26 **THE BUDGET BILL AN APPROPRIATION TO THE RESERVE FUND.**

27 **(II) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT THE**
28 **APPROPRIATION UNDER THIS PARAGRAPH MAY NOT EXCEED:**

- 29 1. **\$5,000,000 FOR FISCAL YEAR 2017;**
- 30 2. **\$10,000,000 FOR FISCAL YEAR 2018; AND**
- 31 3. **\$15,000,000 FOR FISCAL YEAR 2019 AND EACH**
32 **FISCAL YEAR THEREAFTER.**

1 **(5) NOTWITHSTANDING THE PROVISIONS OF § 7-213 OF THE STATE**
2 **FINANCE AND PROCUREMENT ARTICLE, THE GOVERNOR MAY NOT REDUCE AN**
3 **APPROPRIATION TO THE RESERVE FUND IN THE STATE BUDGET AS APPROVED BY**
4 **THE GENERAL ASSEMBLY.**

5 **(6) (I) EXCEPT AS PROVIDED IN THIS PARAGRAPH, MONEY**
6 **APPROPRIATED IN THE RESERVE FUND SHALL REMAIN IN THE RESERVE FUND.**

7 **(II) 1. WITHIN 15 DAYS AFTER THE END OF EACH CALENDAR**
8 **QUARTER, THE DEPARTMENT SHALL NOTIFY THE COMPTROLLER AS TO EACH FINAL**
9 **TAX CREDIT CERTIFICATE ISSUED DURING THE PREVIOUS QUARTER OF:**

10 **A. THE MAXIMUM CREDIT AMOUNT STATED IN THE**
11 **INITIAL TAX CREDIT CERTIFICATE; AND**

12 **B. THE FINAL CERTIFIED TAX CREDIT AMOUNT.**

13 **2. ON NOTIFICATION THAT A FINAL TAX CREDIT HAS**
14 **BEEN ISSUED, THE COMPTROLLER SHALL TRANSFER AN AMOUNT EQUAL TO THE**
15 **CREDIT AMOUNT STATED IN THE INITIAL TAX CREDIT CERTIFICATE FROM THE**
16 **RESERVE FUND TO THE GENERAL FUND.**

17 **(7) IF AN INITIAL TAX CREDIT CERTIFICATE HAS BEEN RESCINDED BY**
18 **THE DEPARTMENT, THE DEPARTMENT MAY APPROVE ADDITIONAL INITIAL TAX**
19 **CREDIT CERTIFICATES FOR OTHER BUSINESS ENTITIES THAT MAY NOT EXCEED THE**
20 **AMOUNT OF TAX CREDITS APPROVED IN THE INITIAL TAX CREDIT CERTIFICATES**
21 **THAT WERE RESCINDED.**

22 **(8) IN EACH CALENDAR YEAR, THE DEPARTMENT MAY NOT APPROVE**
23 **INITIAL TAX CREDIT CERTIFICATES THAT:**

24 **(I) EXCEED 60% OF THE TOTAL AMOUNT APPROPRIATED TO**
25 **THE RESERVE FUND FOR THAT FISCAL YEAR IN THE STATE BUDGET AS APPROVED**
26 **BY THE GENERAL ASSEMBLY FOR CONTRIBUTIONS TO STUDENT ASSISTANCE**
27 **ORGANIZATIONS THAT PROVIDE FINANCIAL ASSISTANCE FOR QUALIFIED**
28 **EDUCATION EXPENSES TO STUDENTS AT ELIGIBLE SCHOOLS THAT ARE NONPUBLIC;**
29 **OR**

30 **(II) EXCEED 40% OF THE TOTAL AMOUNT APPROPRIATED TO**
31 **THE RESERVE FUND FOR THAT FISCAL YEAR IN THE STATE BUDGET AS APPROVED**
32 **BY THE GENERAL ASSEMBLY FOR CONTRIBUTIONS TO STUDENT ASSISTANCE**
33 **ORGANIZATIONS THAT PROVIDE FINANCIAL ASSISTANCE FOR QUALIFIED**
34 **EDUCATION EXPENSES TO STUDENTS AT ELIGIBLE SCHOOLS THAT ARE PUBLIC.**

1 **(H) ANY UNUSED AMOUNT OF THE CREDIT MAY NOT BE CARRIED OVER TO**
2 **ANY OTHER TAXABLE YEAR.**

3 **(I) (1) IN ACCORDANCE WITH § 2.5-109 OF THE ECONOMIC**
4 **DEVELOPMENT ARTICLE, THE DEPARTMENT SHALL REPORT ON THE TAX CREDITS**
5 **APPROVED UNDER THIS SECTION.**

6 **(2) THE REPORT REQUIRED UNDER PARAGRAPH (1) OF THIS**
7 **SUBSECTION SHALL INCLUDE FOR EACH BUSINESS ENTITY APPROVED TO RECEIVE**
8 **A FINAL TAX CREDIT CERTIFICATE IN THE PRIOR CALENDAR YEAR:**

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2016, and shall be applicable to all taxable years beginning after December 31, 2015.
