A BILL ENTITLED

1 AN ACT concerning

2 **Charles County Sheriff – Salaries and Collective Bargaining**

3 FOR the purpose of requiring that the salary schedule for deputy sheriffs of Charles County
4 correspond to the Department of State Police salary schedule; requiring that the
5 salary schedule for the deputy sheriffs of Charles County be revised to reflect any
6 revision made to the Department of State Police salary schedule; requiring the
7 County Commissioners of Charles County to appropriate certain funds to provide
8 certain salaries of the deputy sheriffs except under certain circumstances; providing
9 that the County Commissioners are not required to grant certain step increases to
10 the deputy sheriffs; providing that certain step increases are subject to
11 appropriations by the Board; authorizing certain sworn law enforcement officers and
12 correctional officers in Charles County to collectively bargain with the County
13 Commissioners of Charles County, in addition to the Sheriff, with respect to certain
14 matters; prohibiting the resolution or adjustment of a certain dispute from being
15 inconsistent with the terms of a certain collective bargaining agreement; prohibiting
16 the County Commissioners from recognizing an exclusive representative except
17 under certain circumstances; providing for the decertification of a certain exclusive
18 representative under certain circumstances; altering the maximum number of
19 individuals that the Sheriff and the exclusive representative may designate to
20 represent the Sheriff or the exclusive representative in collective bargaining;
21 authorizing the County Commissioners to designate a certain number of individuals
22 to represent the County Commissioners in collective bargaining under certain
23 circumstances; altering the date by which negotiations for the collective bargaining
24 agreement shall begin; altering the time period during which an exclusive
25 bargaining agreement may be valid; requiring an agreement involving the County
26 Commissioners as a party, or a modification to that agreement, to be signed and
27 ratified by the County Commissioners in order to be effective or valid; requiring that
28 the terms of a collective bargaining agreement prevail in a certain conflict except
29 under certain circumstances; authorizing any party to collective bargaining to seek
30 mediation under certain circumstances; requiring the party seeking mediation to
31 provide certain notice to certain persons; authorizing any party to a certain collective

1 bargaining agreement to declare a bargaining impasse under certain circumstances;
 2 establishing procedures and timelines for the mediation and arbitration of collective
 3 bargaining disputes involving the exclusive representative of certain sworn law
 4 enforcement officers or correctional officers in the Charles County Sheriff's Office;
 5 providing that certain recommendations of the arbitrator are not binding;
 6 authorizing the Sheriff or the County Commissioners to adopt or reject certain
 7 recommendations under certain circumstances; requiring the parties to accept or
 8 reject the recommendations within a certain period of time; establishing a certain
 9 method of distributing the costs of the mediation and arbitration; authorizing the
 10 parties to reach a voluntary settlement on unresolved issues at any time; providing
 11 that the terms and conditions of a certain collective bargaining agreement shall
 12 remain in effect under certain circumstances until a certain time; making a
 13 conforming change; and generally relating to the salaries and collective bargaining
 14 rights of sworn law enforcement officers and correctional officers of the Charles
 15 County Sheriff's Office.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 27 That the Laws of Maryland read as follows:

28 **Article – Courts and Judicial Proceedings**

29 2–309.

30 (a) The sheriff of a county and his deputies shall receive the annual salaries
 31 provided by this section for performing the duties required of them by the Constitution and
 32 the laws of this State. They shall be reimbursed for expenses as provided by law.

33 (a–1) The government of each county shall furnish an office for the sheriff and pay
 34 the necessary expenses for telephones, stationery and for other purposes, and unless
 35 otherwise provided by law, shall provide for the necessary traveling expenses of the sheriff
 36 for conveying prisoners to any penal institution in the State and other necessary traveling
 37 expenses.

38 (j) (3) (I) The Sheriff, in accordance with rules and regulations developed
 39 by the Board of County Commissioners and the Sheriff, shall appoint the number of deputy

1 sheriffs that the Board of County Commissioners of Charles County and the Sheriff
2 consider necessary.

3 **(II) THE SALARY SCHEDULE FOR THE DEPUTY SHERIFFS, BASED**
4 **ON RANK AND LENGTH OF SERVICE, SHALL CORRESPOND TO THE DEPARTMENT OF**
5 **STATE POLICE SALARY SCHEDULE, INCLUDING LONGEVITY STEPS.**

6 **(III) THE SALARY SCHEDULE FOR THE DEPUTY SHERIFFS SHALL**
7 **BE REVISED TO REFLECT ANY REVISIONS MADE TO THE DEPARTMENT OF STATE**
8 **POLICE SALARY SCHEDULE.**

9 **(IV) 1. EXCEPT AS PROVIDED IN SUBPARAGRAPH (V) OF THIS**
10 **PARAGRAPH, THE COUNTY COMMISSIONERS OF CHARLES COUNTY SHALL**
11 **APPROPRIATE THE FUNDS NECESSARY TO PROVIDE THE SALARIES FOR DEPUTY**
12 **SHERIFFS SPECIFIED IN THE SALARY SCHEDULE UNDER SUBPARAGRAPH (II) OF**
13 **THIS PARAGRAPH UNLESS THE COUNTY COMMISSIONERS DECLARE A FISCAL**
14 **EMERGENCY UNDER SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH.**

15 **2. AFTER A DISCUSSION AMONG THE COUNTY**
16 **COMMISSIONERS OF CHARLES COUNTY, THE SHERIFF, AND THE EXCLUSIVE**
17 **REPRESENTATIVES OF THE BARGAINING UNITS OF SWORN LAW ENFORCEMENT**
18 **OFFICERS AND CORRECTIONAL OFFICERS OF THE CHARLES COUNTY SHERIFF'S**
19 **OFFICE, THE COUNTY COMMISSIONERS OF CHARLES COUNTY MAY DECLARE A**
20 **FISCAL EMERGENCY BY A MAJORITY VOTE OF THE COUNTY COMMISSIONERS**
21 **FOLLOWING A PUBLIC HEARING.**

22 **(V) 1. IF THE DEPARTMENT OF STATE POLICE GRANTS**
23 **STEP INCREASES TO ITS EMPLOYEES, THE COUNTY COMMISSIONERS OF CHARLES**
24 **COUNTY ARE NOT REQUIRED UNDER SUBPARAGRAPH (IV) OF THIS PARAGRAPH TO**
25 **GRANT STEP INCREASES TO THE DEPUTY SHERIFFS.**

26 **2. STEP INCREASES FOR THE DEPUTY SHERIFFS ARE**
27 **SUBJECT TO APPROPRIATIONS BY THE COUNTY COMMISSIONERS OF CHARLES**
28 **COUNTY.**

29 **(5) (i) This paragraph applies to all full-time, merit system sworn law**
30 **enforcement officers and correctional officers in the Charles County Sheriff's Office at a**
31 **rank of sergeant or below.**

32 **(ii) This paragraph does not apply to the following employees in the**
33 **Charles County Sheriff's Office:**

34 **1. Sworn law enforcement officers or correctional officers in**
35 **the Charles County Sheriff's Office at a rank of lieutenant or above;**

- 1 2. Employees in appointed positions;
- 2 3. Civilian merit system employees;
- 3 4. Full-time reduced hours employees;
- 4 5. Part-time employees;
- 5 6. Contractual employees;
- 6 7. Temporary employees;
- 7 8. Emergency employees; or
- 8 9. Employees whose employment is administered under the
9 county policies and procedures manual.

10 (iii) 1. A sworn law enforcement officer or correctional officer
11 subject to this paragraph has the right to:

12 A. Take part in or refrain from taking part in forming,
13 joining, supporting, or participating in any employee organization or its lawful activities;

14 B. Be represented by an exclusive representative, if any, in
15 collective bargaining; and

16 C. Engage in other concerted activities for the purpose of
17 collective bargaining.

18 2. Sworn law enforcement officers and correctional officers
19 subject to this paragraph may seek recognition in order to organize and bargain collectively
20 in good faith with the Sheriff or the Sheriff's designee concerning the following matters:

21 A. Compensation, excluding salary, wages, and those
22 benefits determined, offered, administered, controlled, or managed by the County
23 Commissioners of Charles County;

24 B. Leave, holidays, and vacations; and

25 C. Hours, working conditions, and job security.

26 3. **A. SWORN LAW ENFORCEMENT OFFICERS**
27 **SUBJECT TO THIS PARAGRAPH MAY SEEK RECOGNITION IN ORDER TO ORGANIZE**
28 **AND BARGAIN COLLECTIVELY IN GOOD FAITH WITH THE COUNTY COMMISSIONERS**
29 **OF CHARLES COUNTY AND THE SHERIFF, OR THE SHERIFF'S DESIGNEE,**
30 **CONCERNING MERIT STEP INCREASES AND THOSE BENEFITS DETERMINED,**

1 OFFERED, ADMINISTERED, CONTROLLED, OR MANAGED BY THE COUNTY
2 COMMISSIONERS OF CHARLES COUNTY.

3 **B. CORRECTIONAL OFFICERS SUBJECT TO THIS**
4 **PARAGRAPH MAY SEEK RECOGNITION IN ORDER TO ORGANIZE AND BARGAIN**
5 **COLLECTIVELY IN GOOD FAITH WITH THE COUNTY COMMISSIONERS OF CHARLES**
6 **COUNTY AND THE SHERIFF, OR THE SHERIFF'S DESIGNEE, CONCERNING SALARY,**
7 **WAGES, AND THOSE BENEFITS DETERMINED, OFFERED, ADMINISTERED,**
8 **CONTROLLED, OR MANAGED BY THE COUNTY COMMISSIONERS OF CHARLES**
9 **COUNTY.**

10 **4. A.** A sworn law enforcement officer or correctional
11 officer who is a member of a bargaining unit with an exclusive representative may discuss
12 any matter with the employer without the intervention of the exclusive representative.

13 **B. IF A DISCUSSION UNDER SUBSUBSUBPARAGRAPH A**
14 **OF THIS SUBSUBPARAGRAPH LEADS TO A RESOLUTION OR ADJUSTMENT OF A**
15 **DISPUTE, THE RESOLUTION OR ADJUSTMENT MAY NOT BE INCONSISTENT WITH THE**
16 **TERMS OF A COLLECTIVE BARGAINING AGREEMENT THEN IN EFFECT.**

17 **[4.] 5.** A sworn law enforcement officer or correctional officer
18 who is not a member of a bargaining unit with an exclusive representative may be required
19 to pay a proportional service fee for costs associated with the administration and
20 enforcement of any agreement that benefits the affected employees. An exclusive
21 representative shall be selected in accordance with the procedures set forth in
22 subparagraph (v) of this paragraph.

23 **[5.] 6.** This paragraph does not require that sworn law
24 enforcement officers and correctional officers be represented by the same exclusive
25 representative.

26 (iv) The Sheriff and the Office of the Sheriff for Charles County,
27 through their appropriate officers and employees, may:

28 1. Determine the:

29 A. Mission;

30 B. Budget;

31 C. Organization;

32 D. Numbers, types, and grades of employees assigned;

33 E. Work projects, tours of duty, and methods, means, and
34 personnel by which its operations are conducted;

1 F. Technology needs;

2 G. Internal security practices; and

3 H. Relocation of its facilities;

4 2. Maintain and improve the efficiency and effectiveness of
5 governmental operations;

6 3. Determine the services to be rendered, operations to be
7 performed, and technology to be used;

8 4. Determine the overall methods, processes, means, and
9 classes of work or personnel by which governmental operations are to be conducted;

10 5. Hire, direct, supervise, and assign employees;

11 6. A. Promote, demote, discipline, discharge, retain, and
12 lay off employees; and

13 B. Terminate employment because of lack of funds, lack of
14 work, a determination by the employer that continued work would be inefficient or
15 nonproductive, or for other legitimate reasons;

16 7. Set the qualifications of employees for appointment and
17 promotions;

18 8. Set standards of conduct;

19 9. Adopt office rules, regulations, and procedures;

20 10. Provide a system of merit employment according to a
21 standard of business efficiency; and

22 11. Take actions, not otherwise specified in this paragraph, to
23 carry out the mission of the Office of the Sheriff of Charles County.

24 (v) 1. Except as provided in subsubparagraph 2 of this
25 subparagraph, an exclusive representative may not be recognized by **THE COUNTY**
26 **COMMISSIONERS OF CHARLES COUNTY OR** the Sheriff unless that representative is
27 selected and certified by the Department of Labor, Licensing, and Regulation.

28 2. Any petition to be recognized that is submitted on behalf
29 of the sworn law enforcement officers shall be accompanied by a showing of interest
30 supported by at least 51% of the sworn law enforcement officers indicating their desire to
31 be exclusively represented by the petitioner for the purpose of collective bargaining.

1 3. Any petition to be recognized that is submitted on behalf
2 of the correctional officers shall be accompanied by a showing of interest supported by at
3 least 51% of the correctional officers indicating their desire to be exclusively represented
4 by the petitioner for the purpose of collective bargaining.

5 4. A. EXCEPT AS PROVIDED IN
6 SUBSUBSUBPARAGRAPH B OF THIS SUBSUBPARAGRAPH, AN EXCLUSIVE
7 REPRESENTATIVE SHALL BE DEEMED DECERTIFIED IF A PETITION IS SUBMITTED TO
8 THE COUNTY COMMISSIONERS OF CHARLES COUNTY AND THE SHERIFF THAT IS
9 SIGNED BY 51% OF THE SWORN LAW ENFORCEMENT OFFICERS OR CORRECTIONAL
10 OFFICERS INDICATING THEIR DESIRE TO DECERTIFY THE EXCLUSIVE
11 REPRESENTATIVE.

12 B. IF THE EXCLUSIVE REPRESENTATIVE WISHES TO
13 CHALLENGE THE VALIDITY OF A PETITION SUBMITTED UNDER
14 SUBSUBSUBPARAGRAPH A OF THIS SUBSUBPARAGRAPH, WITHIN 20 DAYS AFTER
15 SUBMISSION OF THE PETITION, THE EXCLUSIVE REPRESENTATIVE MAY REQUEST A
16 SECRET BALLOT ELECTION.

17 C. THE SECRET BALLOT ELECTION SHALL BE
18 CONDUCTED BY AN IMPARTIAL UMPIRE SELECTED JOINTLY BY THE PARTICIPATING
19 PARTIES FROM A LIST OF UMPIRES PROVIDED BY THE AMERICAN ARBITRATION
20 ASSOCIATION.

21 D. THE COSTS ASSOCIATED WITH THE APPOINTMENT OF
22 THE IMPARTIAL UMPIRE SHALL BE SHARED EQUALLY BY THE EXCLUSIVE
23 REPRESENTATIVE AND CHARLES COUNTY.

24 E. IF AT LEAST 51% OF THE EMPLOYEES IN THE
25 BARGAINING UNIT VOTE IN FAVOR OF DECERTIFICATION DURING THE SECRET
26 BALLOT ELECTION, THE EXCLUSIVE REPRESENTATIVE SHALL BE DECERTIFIED.

27 (vi) 1. A. The Sheriff may designate at least one, but not more
28 than [three] FOUR, individuals to represent the Sheriff in collective bargaining.

29 B. IF THE COUNTY COMMISSIONERS OF CHARLES
30 COUNTY ARE A PARTY TO COLLECTIVE BARGAINING, THE COUNTY COMMISSIONERS
31 MAY DESIGNATE AT LEAST ONE, BUT NOT MORE THAN FOUR, INDIVIDUALS TO
32 REPRESENT THE COUNTY COMMISSIONERS IN COLLECTIVE BARGAINING.

33 C. The exclusive representative shall designate at least one,
34 but not more than [three] FOUR, individuals to represent the exclusive representative in
35 collective bargaining.

1 2. The parties shall meet at reasonable times and engage in
2 collective bargaining in good faith.

3 3. Negotiations or matters relating to negotiations shall be
4 considered closed sessions under § 3–305 of the General Provisions Article.

5 4. The parties shall make every reasonable effort to conclude
6 negotiations in a timely manner for inclusion by the Sheriff and the Office of the Sheriff of
7 Charles County in its budget request to the County Commissioners of Charles County.

8 5. Negotiations for an agreement shall begin on or before
9 each [July] **SEPTEMBER** 1 of the year before the expiration of any existing agreement.

10 (vii) To the extent that any matters negotiated between the Sheriff,
11 **THE COUNTY COMMISSIONERS OF CHARLES COUNTY**, and the collective bargaining
12 unit require legislative approval or the appropriation of funds, the matters shall be
13 recommended to the General Assembly for the approval of legislation or to the County
14 Commissioners for the appropriation of funds.

15 (viii) An agreement is not valid if it extends for less than 1 year or for
16 more than **[2] 4** years.

17 (ix) 1. An agreement shall contain all matters of agreement
18 reached in the collective bargaining process.

19 2. An agreement may contain a grievance procedure for
20 binding arbitration of the interpretation of contract terms and clauses.

21 3. **A.** An agreement reached in accordance with this
22 paragraph shall be in writing and signed by the designated representatives of the Sheriff
23 and the exclusive representative involved in the collective bargaining negotiations.

24 **B. IF THE COUNTY COMMISSIONERS OF CHARLES**
25 **COUNTY ARE A PARTY TO THE AGREEMENT, THE AGREEMENT SHALL BE SIGNED BY**
26 **THE COUNTY COMMISSIONERS IN ADDITION TO THE SIGNATORIES REQUIRED**
27 **UNDER SUBSUBSUBPARAGRAPH A OF THIS SUBSUBPARAGRAPH.**

28 4. An agreement is not effective until it is ratified by **[the]:**

29 **A. THE Sheriff;**

30 **B. IF THE COUNTY COMMISSIONERS OF CHARLES**
31 **COUNTY ARE A PARTY TO THE COLLECTIVE BARGAINING, THE COUNTY**
32 **COMMISSIONERS; and**

1 C. [a] A majority of the votes cast by the employees in the
2 bargaining unit.

3 5. A modification to an existing agreement is not valid unless
4 it is in writing and ratified by [the]:

5 A. THE Sheriff;

6 B. IF THE COUNTY COMMISSIONERS OF CHARLES
7 COUNTY ARE A PARTY TO THE COLLECTIVE BARGAINING, THE COUNTY
8 COMMISSIONERS; and

9 C. [a] A majority of the votes cast by the employees in the
10 bargaining unit.

11 (X) IF THERE IS A CONFLICT BETWEEN AN EXISTING
12 COLLECTIVE BARGAINING AGREEMENT AND A RULE OR REGULATION ADOPTED BY
13 CHARLES COUNTY, INCLUDING MERIT SYSTEM OR OTHER PERSONNEL
14 REGULATIONS, THE TERMS OF THE AGREEMENT SHALL PREVAIL UNLESS
15 OTHERWISE PROHIBITED BY LAW.

16 (XI) 1. IF THE EXCLUSIVE REPRESENTATIVE, THE SHERIFF,
17 AND, IF A PARTY TO COLLECTIVE BARGAINING, THE COUNTY COMMISSIONERS ARE
18 UNABLE TO REACH AN AGREEMENT ON OR BEFORE JANUARY 15, ANY PARTY MAY
19 SEEK MEDIATION THROUGH THE FEDERAL MEDIATION AND CONCILIATION
20 SERVICE.

21 2. A PARTY SEEKING MEDIATION UNDER
22 SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH SHALL PROVIDE WRITTEN NOTICE
23 TO THE OTHER PARTIES AND THE FEDERAL MEDIATION AND CONCILIATION
24 SERVICE AT LEAST 15 DAYS BEFORE THE ANTICIPATED FIRST MEDIATION MEETING.

25 3. THE PARTIES SHALL SHARE THE COSTS OF THE
26 SERVICES OF THE MEDIATOR AS FOLLOWS:

27 A. THE EXCLUSIVE REPRESENTATIVE SHALL PAY HALF
28 OF THE COSTS;

29 B. IF THE COUNTY COMMISSIONERS AND THE SHERIFF
30 ARE BOTH PARTIES TO THE NEGOTIATIONS GIVING RISE TO THE MEDIATION, THE
31 COUNTY COMMISSIONERS AND THE SHERIFF SHALL EACH PAY ONE-QUARTER OF
32 THE COSTS; AND

1 **C. IF THE COUNTY COMMISSIONERS OF CHARLES**
2 **COUNTY ARE NOT A PARTY TO THE NEGOTIATIONS GIVING RISE TO THE MEDIATION,**
3 **THE SHERIFF SHALL PAY HALF OF THE COSTS.**

4 **4. COSTS INCURRED BY A PARTY TO PREPARE, APPEAR,**
5 **OR SECURE REPRESENTATION, EXPERT WITNESSES, OR EVIDENCE OF ANY KIND**
6 **SHALL BE BORNE EXCLUSIVELY BY THAT PARTY.**

7 **5. THE PARTIES SHALL ENGAGE IN MEDIATION FOR AT**
8 **LEAST 30 DAYS UNLESS THE PARTIES MUTUALLY AGREE IN WRITING TO THE**
9 **TERMINATION OR EXTENSION OF THE MEDIATION OR REACH AN AGREEMENT.**

10 **6. THE CONTENTS OF A MEDIATION PROCEEDING**
11 **UNDER THIS SUBPARAGRAPH MAY NOT BE DISCLOSED BY THE PARTIES OR THE**
12 **MEDIATOR.**

13 **(XII) 1. IF THE EXCLUSIVE REPRESENTATIVE, THE SHERIFF,**
14 **AND, IF A PARTY TO COLLECTIVE BARGAINING, THE COUNTY COMMISSIONERS OF**
15 **CHARLES COUNTY HAVE NOT REACHED AN AGREEMENT ON OR BEFORE MARCH 1,**
16 **OR ANY LATER DATE DETERMINED BY MUTUAL AGREEMENT OF THE PARTIES:**

17 **A. ANY PARTY MAY DECLARE A BARGAINING IMPASSE;**

18 **B. THE PARTY DECLARING A BARGAINING IMPASSE**
19 **UNDER ITEM A OF THIS SUBSUBPARAGRAPH SHALL CHOOSE A LIST OF**
20 **ARBITRATORS PROVIDED TO THE PARTIES BY THE FEDERAL MEDIATION AND**
21 **CONCILIATION SERVICE OR UNDER THE LABOR ARBITRATION RULES OF THE**
22 **AMERICAN ARBITRATION ASSOCIATION; AND**

23 **C. WITHIN 3 DAYS AFTER THE PARTIES' RECEIPT OF THE**
24 **LIST CHOSEN UNDER ITEM B OF THIS SUBSUBPARAGRAPH, THE PARTIES SHALL**
25 **SELECT AN ARBITRATOR BY ALTERNATIVE STRIKING OF NAMES FROM THE LIST.**

26 **2. ON OR BEFORE MARCH 15, OR ANY LATER DATE**
27 **DETERMINED BY MUTUAL AGREEMENT OF THE PARTIES, THE PARTIES SHALL**
28 **SUBMIT TO THE ARBITRATOR:**

29 **A. A JOINT MEMORANDUM LISTING ALL ITEMS TO WHICH**
30 **THE PARTIES PREVIOUSLY AGREED; AND**

31 **B. A SEPARATE PROPOSED MEMORANDUM OF EACH**
32 **PARTY'S FINAL OFFER PRESENTED IN NEGOTIATIONS ON ALL ITEMS TO WHICH THE**
33 **PARTIES PREVIOUSLY DID NOT AGREE.**

1 **3. A. ON OR BEFORE MARCH 30, OR ANY LATER DATE**
2 **DETERMINED BY MUTUAL AGREEMENT OF THE PARTIES, THE ARBITRATOR SHALL**
3 **HOLD A CLOSED HEARING ON THE PARTIES' PROPOSALS AT A TIME, DATE, AND**
4 **PLACE WITHIN CHARLES COUNTY SELECTED BY THE ARBITRATOR.**

11 **B. ADMINISTER OATHS AND TAKE TESTIMONY AND**
12 **OTHER EVIDENCE; AND**

13 **C. ISSUE SUBPOENAS.**

14 **5. ONCE THE PARTIES HAVE SUBMITTED THEIR**
15 **POSITIONS INTO THE RECORD, EACH PARTY SHALL HAVE AN OPPORTUNITY TO**
16 **REVIEW ITS FINAL POSITION BEFORE THE RECORD IS CLOSED AND THE MATTER IS**
17 **SUBMITTED TO THE ARBITRATOR FOR A DETERMINATION.**

18 **6. ON OR BEFORE APRIL 15, OR ANY LATER DATE**

24 **B. STATING THE REASONS THAT THE ARBITRATOR**
25 **FOUND THE FINAL OFFER TO BE MORE REASONABLE.**

26 **7. IN DETERMINING WHICH FINAL OFFER IS MORE**
27 **REASONABLE UNDER SUBSUBPARAGRAPH 6 OF THIS SUBPARAGRAPH, THE**
28 **ARBITRATOR MAY CONSIDER ONLY:**

29 **A. PAST COLLECTIVE BARGAINING AGREEMENTS**
30 **BETWEEN THE PARTIES, INCLUDING THE BARGAINING HISTORY THAT LED TO THE**
31 **COLLECTIVE BARGAINING AGREEMENT AND THE PRECOLLECTIVE BARGAINING**

1 HISTORY OF EMPLOYEE WAGES, HOURS, BENEFITS, AND OTHER WORKING
2 CONDITIONS;

3 B. IN AN ARBITRATION TO WHICH THE EXCLUSIVE
4 REPRESENTATIVE OF SWORN LAW ENFORCEMENT OFFICERS IS A PARTY, A
5 COMPARISON OF WAGES, HOURS, BENEFITS, AND OTHER CONDITIONS OF
6 EMPLOYMENT OF LAW ENFORCEMENT OFFICERS EMPLOYED IN OTHER
7 JURISDICTIONS IN THE STATE;

8 C. IN AN ARBITRATION TO WHICH THE EXCLUSIVE
9 REPRESENTATIVE OF SWORN LAW ENFORCEMENT OFFICERS IS A PARTY, A
10 COMPARISON OF WAGES, HOURS, BENEFITS, AND OTHER CONDITIONS OF
11 EMPLOYMENT OF LAW ENFORCEMENT OFFICERS FROM THE PRIMARY POLICE OR
12 SHERIFF'S DEPARTMENTS IN ALL COUNTIES IN THE STATE;

13 D. IN AN ARBITRATION TO WHICH THE EXCLUSIVE
14 REPRESENTATIVE OF CORRECTIONAL OFFICERS IS A PARTY, A COMPARISON OF
15 WAGES, HOURS, BENEFITS, AND OTHER CONDITIONS OF EMPLOYMENT OF
16 CORRECTIONAL OFFICERS EMPLOYED IN OTHER JURISDICTIONS IN THE STATE;

17 E. A COMPARISON OF WAGES, HOURS, BENEFITS, AND
18 OTHER CONDITIONS OF EMPLOYMENT OF EMPLOYEES WORKING FOR CHARLES
19 COUNTY;

20 F. THE COSTS OF THE RESPECTIVE PROPOSALS OF THE
21 PARTIES;

22 G. THE CONDITION OF THE GENERAL OPERATING FUND
23 OF CHARLES COUNTY, THE ABILITY OF THE SHERIFF AND CHARLES COUNTY TO
24 FINANCE ANY ECONOMIC ADJUSTMENTS REQUIRED UNDER THE PROPOSED
25 COLLECTIVE BARGAINING AGREEMENT, AND THE POTENTIAL IMPACT OF THE
26 PARTIES' FINAL OFFERS ON THE BOND RATING OF CHARLES COUNTY;

27 H. THE ANNUAL INCREASE OR DECREASE IN CONSUMER
28 PRICES FOR GOODS AND SERVICES AS REFLECTED IN THE MOST RECENT CONSUMER
29 PRICE INDEX FOR THE WASHINGTON-ARLINGTON-ALEXANDRIA,
30 DC-VA-MD-WV METROPOLITAN STATISTICAL AREA PUBLISHED BY THE
31 FEDERAL BUREAU OF LABOR STATISTICS;

32 I. THE ANNUAL INCREASE OR DECREASE IN THE COST
33 OF LIVING IN THE STATISTICAL AREAS DESCRIBED IN ITEM H OF THIS
34 SUBSUBPARAGRAPH AS COMPARED TO THE NATIONAL AVERAGE AND TO OTHER
35 COMPARABLE METROPOLITAN AREAS;

1 **J. THE ANNUAL INCREASE OR DECREASE IN THE COST**
2 **OF LIVING IN CHARLES COUNTY;**

3 **K. RECRUITMENT AND RETENTION DATA;**

4 **L. THE SPECIAL NATURE OF THE WORK PERFORMED BY**
5 **THE EMPLOYEES IN THE BARGAINING UNIT, INCLUDING HAZARDS OF EMPLOYMENT,**
6 **PHYSICAL REQUIREMENTS, EDUCATIONAL QUALIFICATIONS, JOB TRAINING AND**
7 **SKILLS, SHIFT ASSIGNMENTS, AND THE DEMANDS PLACED ON THOSE EMPLOYEES AS**
8 **COMPARED TO OTHER CHARLES COUNTY SHERIFF EMPLOYEES;**

9 **M. THE INTEREST AND WELFARE OF THE PUBLIC AND**
10 **THE EMPLOYEES IN THE BARGAINING UNIT; AND**

11 **N. STIPULATIONS OF THE PARTIES REGARDING ANY OF**
12 **THE ITEMS UNDER THIS SUBSUBPARAGRAPH.**

13 **8. THE ARBITRATOR MAY NOT:**

14 **A. RECEIVE OR CONSIDER THE HISTORY OF COLLECTIVE**
15 **BARGAINING RELATED TO THE IMMEDIATE DISPUTE, INCLUDING ANY OFFERS OF**
16 **SETTLEMENT NOT CONTAINED IN THE FINAL OFFER SUBMITTED TO THE**
17 **ARBITRATOR, UNLESS THE PARTIES MUTUALLY AGREE OTHERWISE;**

18 **B. COMBINE FINAL OFFERS OR ALTER THE FINAL OFFER**
19 **THAT THE ARBITRATOR SELECTS, UNLESS THE PARTIES MUTUALLY AGREE**
20 **OTHERWISE; OR**

21 **C. SELECT AN OFFER IN WHICH THE CONDITIONS OF**
22 **EMPLOYMENT OR THE COMPENSATION, SALARIES, FEES, OR WAGES TO BE PAID ARE**
23 **UNREASONABLE.**

24 **9. A. THE ARBITRATOR SHALL SUBMIT THE REPORT**
25 **ISSUED UNDER SUBSUBPARAGRAPH 6 OF THIS SUBPARAGRAPH TO THE COUNTY**
26 **COMMISSIONERS, THE SHERIFF, AND THE EXCLUSIVE REPRESENTATIVE.**

27 **B. THE RECOMMENDATIONS OF THE ARBITRATOR ARE**
28 **NOT BINDING ON THE COUNTY COMMISSIONERS, THE SHERIFF, OR THE EXCLUSIVE**
29 **REPRESENTATIVE.**

30 **C. EXCEPT AS PROVIDED IN SUBSUBSUBPARAGRAPH D**
31 **OF THIS SUBSUBPARAGRAPH, THE SHERIFF AND, IF A PARTY TO COLLECTIVE**

1 BARGAINING, THE COUNTY COMMISSIONERS MAY ADOPT OR REJECT A
2 RECOMMENDATION OF THE ARBITRATOR.

3 D. IF A RECOMMENDATION OF THE ARBITRATOR
4 REQUIRES AN APPROPRIATION OF FUNDS, ONLY THE COUNTY COMMISSIONERS MAY
5 ADOPT OR REJECT THE RECOMMENDATION.

6 E. THE PARTIES SHALL ACCEPT OR REJECT THE
7 ARBITRATOR'S RECOMMENDATIONS WITHIN 30 DAYS AFTER THE SUBMISSION OF
8 THE REPORT TO THE PARTIES UNDER SUBSUBSUBPARAGRAPH A OF THIS
9 SUBSUBPARAGRAPH.

10 10. THE PARTIES SHALL SHARE THE COSTS OF THE
11 SERVICES OF THE ARBITRATOR AS FOLLOWS:

12 A. THE EXCLUSIVE REPRESENTATIVE SHALL PAY HALF
13 OF THE COSTS;

14 B. IF THE COUNTY COMMISSIONERS AND THE SHERIFF
15 ARE BOTH PARTIES TO THE NEGOTIATIONS GIVING RISE TO THE ARBITRATION, THE
16 COUNTY COMMISSIONERS AND THE SHERIFF SHALL EACH PAY ONE-QUARTER OF
17 THE COSTS; AND

18 C. IF THE COUNTY COMMISSIONERS OF CHARLES
19 COUNTY ARE NOT A PARTY TO THE NEGOTIATIONS GIVING RISE TO THE
20 ARBITRATION, THE SHERIFF SHALL PAY HALF OF THE COSTS.

21 11. COSTS INCURRED BY A PARTY TO PREPARE, APPEAR,
22 OR SECURE REPRESENTATION, EXPERT WITNESSES, OR EVIDENCE OF ANY KIND
23 SHALL BE BORNE EXCLUSIVELY BY THAT PARTY.

24 12. NOTHING IN THIS SUBPARAGRAPH SHALL BE
25 CONSTRUED TO PROHIBIT THE PARTIES FROM REACHING A VOLUNTARY
26 SETTLEMENT ON ANY UNRESOLVED ISSUES AT ANY TIME BEFORE OR AFTER THE
27 ISSUANCE OF THE RECOMMENDATIONS BY THE ARBITRATOR.

28 (XIII) IF A COLLECTIVE BARGAINING AGREEMENT EXPIRES AFTER
29 THE EXCLUSIVE REPRESENTATIVE HAS GIVEN NOTICE OF ITS DESIRE TO ENTER
30 INTO COLLECTIVE BARGAINING FOR A SUCCESSOR COLLECTIVE BARGAINING
31 AGREEMENT, THE TERMS AND CONDITIONS OF THE PRIOR COLLECTIVE BARGAINING
32 AGREEMENT SHALL REMAIN IN EFFECT UNTIL THE EARLIER OF:

33 1. THE PARTIES REACHING A NEW AGREEMENT; OR

1 **2. 180 DAYS FROM THE DATE THE PARTY OR PARTIES**
2 **REJECT THE ARBITRATOR’S RECOMMENDATIONS.**

3 ~~[(x)]~~ **(XIV)** This paragraph does not authorize a sworn law
4 enforcement officer or correctional officer to engage in a strike as defined in § 3–303 of the
5 State Personnel and Pensions Article.

6 ~~[(xi)]~~ **(XV)** Nothing in this paragraph shall be construed as subjecting
7 disciplinary matters or the disciplinary process to negotiation as part of the collective
8 bargaining process.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2016.
