## Public Health - Prenatal Infectious Disease HIV Testing

FOR the purpose of establishing the Prenatal Infectious Disease Testing Advisory Group in the Department of Health and Mental Hygiene; providing for the membership of the Advisory Group; specifying the terms of the initial members of the Advisory Group; providing for the appointment of the chair of the Advisory Group; providing that a majority of the members serving on the Advisory Group is a quorum; requiring the Advisory Group to determine the times and places of its meetings; prohibiting a member of the Advisory Group from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Advisory Group to make certain recommendations to the Department; requiring the Department, in consultation with stakeholders, to adopt certain regulations; requiring a certain health care provider to follow certain requirements for infectious disease prenatal HIV testing; requiring the Advisory Group Department to provide certain recommendations requirements to certain hospitals and certain organizations; repealing certain provisions of law that require certain health care providers to obtain certain consent, conduct certain tests and treatment, provide a certain referral, and provide certain counseling; repealing a certain provision of law relating to the liability of, and disciplinary action against, certain health care providers under certain circumstances; providing that certain health care providers may not be subject to certain disciplinary action for following certain requirements: defining a certain term; altering a certain definition; making a stylistic change; making certain provisions of this Act subject to a certain contingency; and generally relating to prenatal infectious disease HIV testing and the Prenatal Infectious Disease Testing Advisory Group.
