## Higher Education - Maryland First Scholarship - Creation and Funding

3 FOR the purpose of establishing the Maryland First Scholarship; establishing certain 4 eligibility requirements for the scholarship; requiring certain information to be 5 provided in an application for the scholarship; authorizing the use of the 6 scholarship for certain educational expenses; authorizing the scholarship 7 awarded to be in an annual amount up to a certain percentage of certain tuition 8 and fees at certain institutions of higher education; requiring the scholarship 9 recipient to maintain a certain grade point average; providing for the duration 10 of the scholarship; requiring scholarship applicants and recipients to file for 11 certain federal and State financial aid by a certain date; establishing a certain 12 fund; requiring the Maryland Higher Education Commission to administer a certain fund; providing that the fund is a certain special, nonlapsing fund that 13 is not subject to a certain section of the State Finance and Procurement Article; 14 15 requiring the State Treasurer to hold the fund separately and to make certain 16 investments; requiring certain earnings to accrue to a certain fund; requiring 17 the Comptroller to account for the fund; directing the Commission to use certain 18 gifts and grants for the fund in a certain manner; requiring certain funds not 19 awarded to remain in a certain fund; requiring the Commission to prepare a 20 certain annual report regarding the fund; requiring the Governor to make a 21 certain appropriation in the State budget from a certain fund; authorizing funds 22 from the Education Trust Fund to be used for a certain purpose; defining 23 certain terms; and generally relating to the establishment of the Maryland First 24 Scholarship.

- 3 (a) There is an Education Trust Fund which is a special, nonlapsing fund 4 that is not subject to § 7–302 of the State Finance and Procurement Article.
- 5 (b) (1) There shall be credited to the Education Trust Fund all proceeds allocated to the Fund under § 9–1A–27 of this subtitle.
- 7 (2) Money in the Education Trust Fund shall be invested and 8 reinvested by the Treasurer, and interest and earnings shall accrue to the Fund.
- 9 (c) Money in the Education Trust Fund shall be used to:
- 10 (1) provide funding for public elementary and secondary education, 11 through continuation of the funding and formulas established under the programs 12 commonly known as the Bridge to Excellence in Public Schools Act, first enacted by 13 Chapter 288 of the Acts of the General Assembly of 2002, including the funding for 14 regional differences in the cost of education under § 5–202(f) of the Education Article;
- 15 (2) provide funds to construct public school buildings and provide 16 public school capital improvements in accordance with §§ 5–301 through 5–303 of the 17 Education Article;
- 18 (3) provide funds for capital projects at community colleges and public senior higher education institutions; [and]
- 20 (4) provide funds to expand public early childhood education programs 21 in the State; AND
- 22 (5) PROVIDE FUNDS FOR STUDENT FINANCIAL ASSISTANCE TO 23 ATTEND INSTITUTIONS OF HIGHER EDUCATION IN THE STATE.
- 24 (d) Expenditures from the Education Trust Fund shall be made each fiscal 25 year in accordance with the State budget.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2013.
