3 FOR the purpose of altering the Maryland Technology Internship Program to include 4 certain technology-based internships with units of State and local governments; requiring the University of Maryland Baltimore County, in collaboration with the $\mathbf{5}$ 6 Department of Commerce, to alter the information and activities provided through a 7 certain Internet site and provide certain recruitment and training opportunities and support for units of State and local government; repealing a requirement that a 8 9 business have not more than a certain number of employees to qualify for 10 participation in the Program; establishing certain requirements for a unit of State 11 or local government to qualify for participation in the Program; altering the tracked 12 and assessed Program outcomes; authorizing the use of certain awards to reimburse 13certain businesses or units of State or local government for up to a certain percentage 14 of the amount paid to an intern up to a certain amount; requiring at least a certain percentage of the internships supported by the Program each year to be with certain 15businesses; and generally relating to the Maryland Technology Internship Program. 16
