A BILL ENTITLED

1 AN ACT concerning

2 **Public Financing Act – State Senate and House of Delegates Candidates and**
3 **Matching Fund Revisions**

4 FOR the purpose of altering the candidates authorized to receive public contributions from
5 the Fair Campaign Financing Fund to include candidates for State Senator and
6 member of the House of Delegates; requiring the Comptroller to distribute public
7 contributions to a certain campaign finance entity established to receive public
8 contributions for certain eligible candidates; altering the frequency with which the
9 Comptroller is required to submit a certain statement to the State Board of Elections;
10 requiring the State Board to make a certain determination regarding the balance of
11 the Fund on or before a certain date in certain years; requiring the State Board to
12 provide a certain notice to the Department of Budget and Management on or before
13 a certain date under certain circumstances; requiring the Governor to include a
14 certain appropriation in the budget bill in a certain year under certain
15 circumstances; repealing certain provisions of law regarding the raising of seed
16 money by gubernatorial tickets in order to be eligible to receive a public contribution;
17 requiring certain candidates to take certain actions before receiving public
18 contributions from the Fund; authorizing certain campaign finance entities to accept
19 only certain contributions and loans; establishing requirements that must be met to
20 qualify as an eligible candidate; establishing a qualifying period for certain
21 candidates; repealing certain provisions of law governing campaign expenditure
22 limits for gubernatorial tickets that accept public contributions from the Fund;
23 requiring the State Board to authorize distribution of money in the Fund on
24 certification that certain qualifications have been met and not earlier than a certain
25 date in a certain year; requiring the State Board to distribute public contributions
26 from the Fund during the distribution period in a certain manner; establishing
27 certain limits on the total public contribution payable to eligible candidates for
28 certain elections; repealing certain provisions of law requiring that public
29 contributions be distributed in a certain manner; prohibiting the State Board from
30 distributing matching dollars for certain contributions and loans; requiring that a
31 certain eligible candidate receive a certain proportion of a certain public contribution

2 altering the reasons for which public contributions may be spent to include an
3 expenditure accompanied by a certain receipt; altering the time period within which
4 expenses must be incurred in order to be paid using a public contribution; altering
5 the time period within which a certain part of a public contribution is required to be
6 repaid; providing that certain persons are civilly and criminally liable for the
7 repayment of an unspent public contribution; requiring the State Board to authorize
8 the repayment of certain money to the General Fund of the State from the Fund
9 under certain circumstances; altering the provisions required to be included in
10 certain regulations that the State Board is required to adopt; requiring a person who
11 violates a certain provision of law in a certain manner to pay a certain civil penalty;
12 providing that a certain infraction is a civil offense; authorizing the State Board to
13 impose a certain civil penalty for certain violations of law; establishing procedures
14 for the issuance, service, notice, contents, and prosecution of a certain civil citation;
15 providing for the amount and payment of a certain civil penalty under certain
16 circumstances; establishing certain provisions regarding a District Court proceeding
17 relating to certain violations of law; requiring certain penalties to be distributed to
18 the Fund; defining certain terms; providing for the application of certain provisions
19 of this Act; altering certain defined terms and certain definitions; repealing certain
20 defined terms; making conforming changes; and generally relating to the Public
21 Financing Act.

37 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

38 That the Laws of Maryland read as follows:

39 **Article – Election Law**

40 13–235.

1 (a) This section applies to the following officials:

- 2 (1) the Governor;
- 3 (2) the Lieutenant Governor;
- 4 (3) the Attorney General;
- 5 (4) the Comptroller; and
- 6 (5) a member of the General Assembly.

7 (b) Except as provided in subsection (c), (d), or (e) of this section, during a regular
8 session of the General Assembly an official described in subsection (a) of this section, or a
9 person acting on behalf of the official, may not, as to a candidate for federal, State, or local
10 office, or a campaign finance entity of the candidate or any other campaign finance entity
11 organized under this title and operated in coordination with a candidate:

- 12 (1) receive a contribution;
- 13 (2) conduct a fund-raising event;
- 14 (3) solicit a contribution; or
- 15 (4) deposit or use any contribution of money that was not deposited prior
16 to the session.

17 (c) An official described in subsection (a) of this section, or a person acting on
18 behalf of the official, is not subject to this section when engaged in activities solely related
19 to the official's election to an elective federal or local office for which the official is a filed
20 candidate.

21 (d) Under the Public Financing Act, a gubernatorial ticket **OR A CANDIDATE FOR**
22 **STATE SENATOR OR MEMBER OF THE HOUSE OF DELEGATES**, during the year of the
23 election only, may accept eligible private contributions and any disbursement of funds by
24 the State Board that is based on the eligible private contributions.

25 (e) An official described in subsection (a) of this section, or a person acting on
26 behalf of the official, may deposit a contribution during the legislative session if the
27 contribution was made electronically before the start of the session.

28 (f) (1) As to a violation of this section, the campaign finance entity of the
29 official in violation is liable for a civil penalty as provided in § 13-604.1 of this title.

30 (2) A civil penalty imposed under this subsection shall be distributed to the
31 Fair Campaign Financing Fund established under § 15-103 of this article.

2 (a) In this title the following words have the meanings indicated.

3 (b) “Comptroller” means the Comptroller of the State.

4 (c) **“CONTRIBUTION CARD” MEANS A DOCUMENT SIGNED, INCLUDING BY**
5 **ELECTRONIC SIGNATURE, BY A DONOR ATTESTING THAT THE CONTRIBUTION MADE**
6 **TO A CAMPAIGN IS MADE WITH THE PERSONAL FUNDS OF THE DONOR.**

7 [(c) (D) “Eligible [gubernatorial ticket] CANDIDATE” means a gubernatorial
8 ticket, **A CANDIDATE FOR STATE SENATOR, OR A CANDIDATE FOR MEMBER OF THE**
9 **HOUSE OF DELEGATES** that qualifies to receive a public contribution.

10 [(d) (E) “Eligible private contribution” means [that part of a monetary or
11 in-kind contribution or series of contributions from an individual] **A PRIVATE**
12 **CONTRIBUTION FROM A REGISTERED VOTER** that does not exceed \$250 **IN THE**
13 **AGGREGATE FOR THE ELECTION CYCLE AND IS ACCOMPANIED BY A CONTRIBUTION**
14 **CARD.**

15 [(e) (F) “Fund” means the “Fair Campaign Financing Fund”.

16 [(f) (G) “Gubernatorial ticket” means a Governor–Lieutenant Governor unit.

17 (H) **“PRIVATE CONTRIBUTION” MEANS A MONETARY CONTRIBUTION OR**
18 **SERIES OF MONETARY CONTRIBUTIONS FROM AN INDIVIDUAL THAT DOES NOT**
19 **EXCEED \$250 IN THE AGGREGATE FOR THE ELECTION CYCLE IN WHICH THE**
20 **CONTRIBUTION IS MADE.**

21 [(g) (I) “Public contribution” means money distributed from the Fund to [a
22 gubernatorial ticket] **AN ELIGIBLE CANDIDATE** under this title.

23 [(h) “Seed money” means cumulative eligible private contributions equaling 10%
24 or more of the expenditure limit prescribed under § 15–105 of this title for an election.

25 (i) (1) “Treasurer” has the meaning stated in § 1–101 of this article.

26 (2) “Treasurer” includes a subtreasurer.]

28 (a) There is a Fair Campaign Financing Fund.

29 (b) The Comptroller shall administer the Fund in accordance with this section.

1 (c) In accordance with this title, the Comptroller shall:

2 (1) credit to the Fund:

3 (i) all money collected under this title;

4 (ii) voluntary contributions to the Fund made electronically through
5 the State Board's website;

6 (iii) fees, fines, and penalties assessed under this article or the
7 General Provisions Article that are expressly allocated to the Fund by law;

8 (iv) an anonymous contribution paid to the Fund under § 13–239 of
9 this article;

10 (v) an illegal contribution paid to the Fund under § 13–239.1 of this
11 article;

12 (vi) surplus campaign funds paid to the Fund under § 13–247 of this
13 article; and

14 (vii) contributions to the Fund made through the checkoff on the
15 individual income tax return established under § 2–113.1 of the Tax – General Article;

16 (2) subject to the usual investing procedures for State funds, invest the
17 money in the Fund; and

18 (3) make distributions from the Fund promptly on authorization by the
19 State Board.

20 (d) The Comptroller shall distribute public contributions:

21 (1) only on authorization of the State Board; and

22 (2) as to each eligible [gubernatorial ticket] CANDIDATE, to the [same]
23 campaign account of a single campaign finance entity established under Title 13, Subtitle
24 2 of this article **TO RECEIVE PUBLIC CONTRIBUTIONS.**

25 (e) The Comptroller shall submit a statement of the Fund's balance to the State
26 Board [at the State Board's request and on May 15 of each year] **EACH MONTH.**

27 **(F) (1) ON OR BEFORE JUNE 30 OF THE THIRD YEAR IMMEDIATELY**
28 **PRECEDING A YEAR OF A GUBERNATORIAL ELECTION, THE STATE BOARD SHALL**
29 **DETERMINE WHETHER THE BALANCE OF THE FUND IS SUFFICIENT TO PROVIDE FOR**
30 **A FULL CONTRIBUTION FOR:**

- 1 **(I) IN A PRIMARY ELECTION:**
- 2 1. **TWO GUBERNATORIAL TICKETS;**
- 3 2. **47 CANDIDATES FOR STATE SENATOR; AND**
- 4 3. **141 CANDIDATES FOR MEMBER OF THE HOUSE OF**
5 **DELEGATES; AND**
- 6 **(II) IN A GENERAL ELECTION:**
- 7 1. **ONE GUBERNATORIAL TICKET;**
- 8 2. **47 CANDIDATES FOR STATE SENATOR; AND**
- 9 3. **141 CANDIDATES FOR MEMBER OF THE HOUSE OF**
10 **DELEGATES.**

11 **(2) IF THE BALANCE OF THE FUND IS DETERMINED TO BE**
12 **INSUFFICIENT TO PROVIDE THE PUBLIC CONTRIBUTIONS DESCRIBED UNDER**
13 **PARAGRAPH (1) OF THIS SUBSECTION:**

14 **(I) ON OR BEFORE AUGUST 1 OF THE THIRD YEAR**
15 **IMMEDIATELY PRECEDING A YEAR OF A GUBERNATORIAL ELECTION, THE STATE**
16 **BOARD SHALL SEND A NOTICE TO THE DEPARTMENT OF BUDGET AND**
17 **MANAGEMENT OF THE AMOUNT OF MONEY NEEDED TO PROVIDE THE PUBLIC**
18 **CONTRIBUTIONS DESCRIBED UNDER PARAGRAPH (1) OF THIS SUBSECTION; AND**

19 **(II) THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET**
20 **BILL FOR THE APPROPRIATE FISCAL YEAR AN APPROPRIATION IN AN AMOUNT**
21 **EQUAL TO THE AMOUNT SUBMITTED TO THE DEPARTMENT OF BUDGET AND**
22 **MANAGEMENT UNDER ITEM (I) OF THIS PARAGRAPH.**

23 **[(f)] (G)** To pay costs directly related to the administration of this title, the State
24 Board may expend in each fiscal year an amount of money in the Fund that does not exceed
25 the lesser of:

26 (1) 3% of the Fund's balance, as calculated on the last day of the
27 immediately preceding fiscal year; or

28 (2) \$100,000.

1 A gubernatorial ticket is qualified to receive a public contribution for an election on
2 the date specified by regulation adopted under this title if:

3 (1) the gubernatorial ticket has raised seed money;

4 (2) the seed money is refundable only if the gubernatorial ticket withdraws
5 as a gubernatorial ticket; and

6 (3) as certified by the gubernatorial ticket's treasurer on a campaign
7 finance report, the seed money was:

8 (i) raised in accordance with this title; and

9 (ii) received after March 1 of the year immediately preceding the
10 year of that election.]

12 **(A) BEFORE RECEIVING A PRIVATE CONTRIBUTION, A GUBERNATORIAL**
13 **TICKET OR CANDIDATE FOR STATE SENATOR OR MEMBER OF THE HOUSE OF**
14 **DELEGATES SHALL:**

15 **(1) ON OR BEFORE THE DEADLINE TO FILE A CERTIFICATE OF**
16 **CANDIDACY UNDER § 13-303 OF THIS ARTICLE, FILE WITH THE STATE BOARD A**
17 **NOTICE OF INTENT TO PARTICIPATE AS A PUBLICLY FINANCED CANDIDATE FOR**
18 **BOTH THE PRIMARY AND GENERAL ELECTIONS; AND**

19 **(2) ESTABLISH A CAMPAIGN FINANCE ENTITY FOR COMPLYING WITH**
20 **THE REQUIREMENTS OF THIS TITLE.**

21 **(B) (1) A CAMPAIGN FINANCE ENTITY ESTABLISHED UNDER SUBSECTION**
22 **(A)(2) OF THIS SECTION MAY ACCEPT ONLY:**

23 **(I) A PRIVATE CONTRIBUTION;**

24 **(II) AN ELIGIBLE PRIVATE CONTRIBUTION;**

25 **(III) A PUBLIC CONTRIBUTION; AND**

26 **(IV) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A**
27 **CONTRIBUTION OR LOAN FROM THE ELIGIBLE CANDIDATE OR THE SPOUSE OF THE**
28 **ELIGIBLE CANDIDATE.**

29 **(2) AN ELIGIBLE CANDIDATE OR THE SPOUSE OF AN ELIGIBLE**
30 **CANDIDATE MAY NOT MAKE A CONTRIBUTION OF OR LEND A COMBINED TOTAL OF**

1 MORE THAN \$10,000 TO THE CAMPAIGN OF THE ELIGIBLE CANDIDATE.

2 (C) TO QUALIFY AS AN ELIGIBLE CANDIDATE:

3 (1) A GUBERNATORIAL TICKET SHALL COLLECT WITHIN THE
4 QUALIFYING PERIOD AT LEAST:

5 (I) 1,500 ELIGIBLE PRIVATE CONTRIBUTIONS; AND

6 (II) AN AGGREGATE TOTAL OF \$120,000;

7 (2) A CANDIDATE FOR STATE SENATOR SHALL COLLECT WITHIN THE
8 QUALIFYING PERIOD AT LEAST:

9 (I) 250 ELIGIBLE PRIVATE CONTRIBUTIONS; AND

10 (II) AN AGGREGATE TOTAL OF \$15,000; OR

11 (3) A CANDIDATE FOR MEMBER OF THE HOUSE OF DELEGATES SHALL
12 COLLECT WITHIN THE QUALIFYING PERIOD AT LEAST:

13 (I) 150 ELIGIBLE PRIVATE CONTRIBUTIONS; AND

14 (II) AN AGGREGATE TOTAL OF \$7,500.

15 15-105.

16 (A) FOR PRINCIPAL POLITICAL PARTY CANDIDATES, THE QUALIFYING
17 PERIOD IS FROM THE FIRST DAY OF THE ELECTION CYCLE FOR A GUBERNATORIAL
18 ELECTION UNTIL THE FIRST MONDAY IN MAY, BOTH INCLUSIVE, OF THE ELECTION
19 YEAR.

20 (B) FOR ALL OTHER PARTICIPATING CANDIDATES, THE QUALIFYING
21 PERIOD TO QUALIFY FOR THE GENERAL ELECTION ONLY IS FROM THE FIRST DAY OF
22 THE ELECTION CYCLE FOR A GUBERNATORIAL ELECTION UNTIL THE FIRST MONDAY
23 IN AUGUST, BOTH INCLUSIVE, OF THE ELECTION YEAR.

25 (a) After filing a notice of intent to qualify for a public contribution under this
26 title, a gubernatorial ticket or a person acting on behalf of the gubernatorial ticket OR A
27 CANDIDATE FOR STATE SENATOR OR MEMBER OF THE HOUSE OF DELEGATES OR A
28 PERSON ACTING ON BEHALF OF THE CANDIDATE FOR STATE SENATOR OR MEMBER
29 OF THE HOUSE OF DELEGATES may not, for the benefit of any political committee or any

1 person required to register with the State Board under § 13–306 or § 13–307 of this article
2 or for a participating organization organized under § 13–309.2 of this article:

3 (1) solicit contributions, including the authorized use of the names or
4 images of the gubernatorial ticket **OR CANDIDATE FOR STATE SENATOR OR MEMBER**
5 **OF THE HOUSE OF DELEGATES** in the solicitation; or

6 (2) operate in coordination with any entity for fundraising activities.

7 (b) After filing a notice of intent to qualify for a public contribution under this
8 title, the members of a gubernatorial ticket **OR A CANDIDATE FOR STATE SENATOR OR**
9 **MEMBER OF THE HOUSE OF DELEGATES** may not be a member of a slate that does not
10 receive a public contribution.

11 (c) Until a final campaign finance report is filed with the State Board and any
12 remaining funds of the public contribution distributed to [a gubernatorial ticket] **AN**
13 **ELIGIBLE CANDIDATE** are repaid to the Comptroller for redeposit in the Fund in
14 accordance with [§ 15–107] **§ 15–109** of this [subtitle] **TITLE**, any authorized candidate
15 campaign committee organized under Title 13 of this article on behalf of the [members of a
16 gubernatorial ticket] **ELIGIBLE CANDIDATE** may not engage in campaign finance activity.

18 (a) (1) A gubernatorial ticket that accepts a public contribution from the Fund
19 for an election may not spend, in that election, more than the product of 30 cents, adjusted
20 annually beginning January 1, 1997, in accordance with the Consumer Price Index, times
21 the population of the State as determined under subsection (c) of this section.

22 (2) Paragraph (1) of this subsection:

23 (i) applies separately to each primary and general election; and

24 (ii) does not apply to expenditures made on behalf of a gubernatorial
25 ticket by a State or local central committee.

26 (b) The State Board shall certify the expenditure limit for each election in
27 accordance with subsection (a)(1) of this section.

28 (c) The population of the State shall be determined by the State Board as of
29 January 1 of the year of the election in accordance with the more recent of:

30 (1) the most recent decennial census of the United States; or

31 (2) any population estimate prepared for the State by the Maryland
32 Department of Health.

1 (d) The members of the gubernatorial ticket and, if associated with the
2 expenditure, the responsible officers of its campaign finance entity are jointly and severally
3 liable civilly and criminally for an expenditure made in violation of this section.]

5 (a) (1) [(i)] In accordance with subsection (c) of this section **AND**
6 **REGULATIONS ADOPTED BY THE STATE BOARD**, the State Board shall authorize
7 distribution **OF MONEY IN THE FUND** on a continuing basis [of one-half of the money in
8 the Fund to eligible gubernatorial tickets in the primary election] **TO ELIGIBLE**
9 **CANDIDATES ON CERTIFICATION THAT THE QUALIFICATIONS UNDER § 15–104 OF**
10 **THIS TITLE HAVE BEEN MET.**

11 [(ii)] **(2)** Distributions shall begin [not later than February] **NOT**
12 **EARLIER THAN JANUARY 1** of the year of the election.

13 [(2) Promptly after the primary election, the State Board shall authorize
14 distribution of the remaining money in the Fund in accordance with subsection (d) of this
15 section.]

16 (b) If the State Board determines that there is not, or may not be, sufficient money
17 in the Fund to provide a full public contribution to all eligible [gubernatorial tickets in a
18 primary or general election] **CANDIDATES**, the State Board shall allocate the available
19 money so that each eligible [gubernatorial ticket] **CANDIDATE** in that election receives a
20 proportionate share of the full public contribution to which the [gubernatorial ticket]
21 **ELIGIBLE CANDIDATE** otherwise would be entitled.

22 (c) (1) The State Board shall authorize distribution of the money that is
23 designated for distribution [in the primary election] as provided in this subsection.

24 [(2) An eligible gubernatorial ticket that is opposed in the primary election
25 shall receive \$1 in public contributions for each \$1 in eligible private contributions it has
26 received.

27 [(3) An eligible gubernatorial ticket that is unopposed in the primary
28 election shall receive \$1 in public contributions for each \$3 in eligible private contributions
29 it has received.]

30 **(2) THE STATE BOARD SHALL DISTRIBUTE A PUBLIC CONTRIBUTION**
31 **FROM THE FUND TO EACH ELIGIBLE CANDIDATE DURING THE DISTRIBUTION**
32 **PERIOD AS FOLLOWS:**

4 2. **\$5 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
5 **CONTRIBUTION RECEIVED FOR THE SECOND \$50 OF EACH ELIGIBLE PRIVATE**
6 **CONTRIBUTION;**

7 3. **\$2 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
8 **CONTRIBUTION RECEIVED FOR THE THIRD \$50 OF EACH ELIGIBLE PRIVATE**
9 **CONTRIBUTION; AND**

10 4. **\$0 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
11 **CONTRIBUTION RECEIVED FOR THE REMAINING \$100 OF EACH ELIGIBLE PRIVATE**
12 **CONTRIBUTION;**

13 **(II) FOR EACH ELIGIBLE CANDIDATE FOR STATE SENATOR,**
14 **MATCHING DOLLARS EQUAL TO:**

15 1. **\$6 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
16 **CONTRIBUTION RECEIVED FOR THE FIRST \$50 OF EACH ELIGIBLE PRIVATE**
17 **CONTRIBUTION;**

18 2. **\$2 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
19 **CONTRIBUTION RECEIVED FOR THE NEXT \$100 OF EACH ELIGIBLE PRIVATE**
20 **CONTRIBUTION; AND**

21 3. **\$0 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
22 **CONTRIBUTION RECEIVED FOR THE REMAINING \$100 OF EACH ELIGIBLE PRIVATE**
23 **CONTRIBUTION; OR**

24 **(III) FOR EACH ELIGIBLE CANDIDATE FOR MEMBER OF THE**
25 **HOUSE OF DELEGATES, MATCHING DOLLARS EQUAL TO:**

26 1. **\$6 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
27 **CONTRIBUTION RECEIVED FOR THE FIRST \$50 OF EACH ELIGIBLE PRIVATE**
28 **CONTRIBUTION;**

29 2. **\$2 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**
30 **CONTRIBUTION RECEIVED FOR THE NEXT \$100 OF EACH ELIGIBLE PRIVATE**
31 **CONTRIBUTION; AND**

32 3. **\$0 FOR EACH DOLLAR OF AN ELIGIBLE PRIVATE**

1 CONTRIBUTION RECEIVED FOR THE REMAINING \$100 OF EACH ELIGIBLE PRIVATE
2 CONTRIBUTION.
