1 AN ACT concerning

2 Vehicle Laws – Special Registration Plate – United States Armed Forces

- 3 FOR the purpose of requiring the Motor Vehicle Administration to develop and make 4 available for certain vehicles a special registration plate honoring the armed $\mathbf{5}$ forces of the United States; authorizing certain persons to apply for the special 6 registration plate; requiring certain owners of vehicles assigned a special 7 registration plate under this Act to pay certain fees; requiring that certain fees 8 be used only for certain purposes; requiring a registration plate issued under 9 this Act to contain a certain graphic design and certain words; requiring the 10 Administration to adopt regulations to carry out the provisions of this Act; and generally relating to a special registration plate honoring the armed forces of 11 the United States. 12

1 (A) THE ADMINISTRATION SHALL DEVELOP AND MAKE AVAILABLE FOR 2 QUALIFYING VEHICLES A SPECIALLY DESIGNED REGISTRATION PLATE 3 HONORING THE ARMED FORCES OF THE UNITED STATES.

4 (B) THE OWNER OF A VEHICLE, OR A LESSEE OF THE VEHICLE UNDER A 5 LEASE NOT INTENDED AS SECURITY, OR A DIRECTOR, AN OFFICER, AN 6 EMPLOYEE, OR A PARTNER OF A BUSINESS ENTITY THAT OWNS THE VEHICLE 7 CONSIDERED ELIGIBLE BY THE ADMINISTRATION MAY APPLY TO THE 8 ADMINISTRATION FOR AN ORIGINAL OR A SUBSTITUTE REGISTRATION PLATE 9 UNDER THIS SECTION IF THE VEHICLE IS INCLUDED IN ONE OF THE FOLLOWING 10 CLASSES:

- 11 (1) A CLASS A (PASSENGER) VEHICLE;
- 12 (2) A CLASS D (MOTORCYCLE) VEHICLE;

13(3) A CLASS E (TRUCK) VEHICLE WITH A MANUFACTURER'S14RATED CAPACITY OF 1 TON OR LESS;

- 15 (4) A CLASS G (TRAILER) VEHICLE; OR
- 16 (5) A CLASS M (MULTIPURPOSE) VEHICLE.

17 (C) (1) IN ADDITION TO THE ANNUAL REGISTRATION FEE OTHERWISE 18 REQUIRED UNDER THIS TITLE, AN OWNER OF A VEHICLE ASSIGNED A 19 REGISTRATION PLATE UNDER THIS SECTION SHALL PAY:

20 (I) WHEN INITIALLY ISSUED THE REGISTRATION PLATE, A 21 ONE-TIME FEE SET BY THE ADMINISTRATION TO RECOVER THE 22 ADMINISTRATION'S COSTS UNDER THIS SECTION; AND

(II) WHEN INITIALLY ISSUED THE REGISTRATION PLATE,
AND EACH TIME THE REGISTRATION PLATE IS RENEWED, AN ADDITIONAL FEE
SET BY THE ADMINISTRATION OF AT LEAST \$20 TO BENEFIT THE MARYLAND
CHAPTER OF DISABLED AMERICAN VETERANS.

(2) THE ADDITIONAL FEE COLLECTED UNDER THIS SECTION IS
NOT REQUIRED FOR SPECIAL REGISTRATION OF A VEHICLE THAT IS EXEMPT
UNDER § 13–903 OF THIS TITLE.

30(3) NO PORTION OF THE FEE COLLECTED UNDER THIS SECTION31MAY BE CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE32ACCOUNT FOR DISTRIBUTION UNDER § 8–403 OR § 8–404 OF THIS ARTICLE.

1 (D) A REGISTRATION PLATE ISSUED UNDER THIS SECTION SHALL 2 INCLUDE A GRAPHIC DESIGN OF A BALD EAGLE AND THE WORDS "SUPPORT 3 MARYLAND VETERANS".

4 (E) THE ADMINISTRATION SHALL ADOPT REGULATIONS TO CARRY OUT 5 THE PROVISIONS OF THIS SECTION.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2012.
