1 AN ACT concerning

2 **Criminal Procedure – Victim Compensation – Alterations**
3 **(Victim Compensation Reform Act of 2024)**

4 FOR the purpose of altering the composition of the Criminal Injuries Compensation Board;
5 altering certain duties, powers, and procedures for the Board to make awards to
6 victims of crime; altering the powers and duties of certain employees; altering the
7 amount and types of awards the Board is authorized to make to certain victims of
8 crime; authorizing reconsideration and judicial review of decisions of the Board;
9 altering certain criminal penalties; authorizing the Governor to include certain
10 funding in the annual budget bill for the Criminal Injuries Compensation Fund; and
11 generally relating to the Criminal Injuries Compensation Board and the Criminal
12 Injuries Compensation Fund.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Criminal Procedure

11–801.

(a) In this subtitle the following words have the meanings indicated.

(b) “Board” means the Criminal Injuries Compensation Board.

(c) “Claimant” means the person filing a claim under this subtitle.

(d) (1) “Crime” means:

(i) except as provided in paragraph (2) of this subsection, a criminal offense under state, federal, or common law that is committed in:

1. this State; or

2. another state against a resident of this State; or

(ii) an act of international terrorism as defined in Title 18, § 2331 of the United States Code that is committed outside of the United States against a resident of this State.

(2) “Crime” does not include an act involving the operation of a vessel or motor vehicle unless the act is:

(i) a violation of § 20–102, § 20–104, **§ 21–706, § 21–901.3, § 21–902, [or] § 21–904, OR § 21–1124.3** of the Transportation Article;

(ii) a violation of § 8–738 of the Natural Resources Article;

(iii) a violation of the Criminal Law Article;

(iv) operating a motor vehicle or vessel that results in an intentional injury; or

1 (v) a violation of federal law or the law of another state that is
2 substantially equivalent to a violation under this paragraph, as required under 34 U.S.C.
3 § 20102(b)(5) and (6).

4 (e) “Dependent” means:

5 (1) a surviving spouse, **DOMESTIC PARTNER**, or child of a person; or

6 (2) a person who is dependent on another person for principal support.

7 (f) “Executive Director” means the Executive Director of the Governor’s Office of
8 Crime Prevention, Youth, and Victim Services.

9 **(G) “QUALIFIED THIRD PARTY” MEANS:**

10 **(1) A LICENSED PHYSICIAN, DENTIST, OR PSYCHOLOGIST**
11 **AUTHORIZED TO PRACTICE UNDER THE HEALTH OCCUPATIONS ARTICLE;**

12 **(2) A SOCIAL WORKER OR CASEWORKER OF ANY PUBLIC OR PRIVATE**
13 **HEALTH OR SOCIAL SERVICES AGENCY OR PROVIDER; OR**

14 **(3) AN ADVOCATE OR VICTIM SERVICE PROVIDER FROM A DOMESTIC**
15 **VIOLENCE OR SEXUAL ASSAULT PREVENTION OR ASSISTANCE PROGRAM.**

16 **[(g)] (H)** “Victim” means a person:

17 (1) who suffers physical **OR PSYCHOLOGICAL** injury or death as a result
18 of a crime or delinquent act; **OR**

19 (2) [who suffers psychological injury as a direct result of:

20 (i) a fourth degree sexual offense or a delinquent act that would be
21 a fourth degree sexual offense if committed by an adult;

22 (ii) a felony or a delinquent act that would be a felony if committed
23 by an adult; or

24 (iii) physical injury or death directly resulting from a crime or
25 delinquent act; or

26 **(3)]** who suffers physical injury or death as a direct result of:

27 (i) trying to prevent a crime or delinquent act or an attempted crime
28 or delinquent act from occurring in the person’s presence;

1 (ii) trying to apprehend an offender who had committed a crime or
2 delinquent act in the person's presence or had committed a felony or a delinquent act that
3 would be a felony if committed by an adult; or

4 (iii) helping a law enforcement officer in the performance of the
5 officer's duties or helping a member of a fire department **OR AN AGENCY THAT PROVIDES**
6 **EMERGENCY MEDICAL SERVICES** who is being obstructed from performing the member's
7 duties.

8 11-802.

9 (a) The General Assembly finds:

10 (1) that many [innocent] persons suffer personal physical or psychological
11 injury or die because of [crimes or delinquent acts or in their efforts to prevent them or
12 apprehend persons committing or attempting to commit them] **CRIME VICTIMIZATION;**

13 (2) that [these persons or their dependents may as a result suffer
14 disability, incur financial hardships, or become reliant on public assistance] **THERE IS A**
15 **NEED FOR GOVERNMENT ASSISTANCE FOR CRIME VICTIMS AND THEIR LOVED ONES;**
16 and

17 (3) that [there is a need for government financial assistance for these
18 victims] **NEEDED ASSISTANCE INCLUDES FINANCIAL ASSISTANCE TO ADDRESS THE**
19 **MANY SIGNIFICANT EMOTIONAL, PRACTICAL, AND FINANCIAL HURDLES THAT**
20 **RESULT FROM CRIME VICTIMIZATION, INCLUDING LOST WORK, UNEXPECTED**
21 **FUNERAL EXPENSES, AND HEALTH NEEDS.**

22 (b) The policy of the State is that help, care, and support be provided by the State,
23 as a matter of moral responsibility **AND PUBLIC SAFETY**, for these victims.

24 11-804.

25 (a) There is a Criminal Injuries Compensation Board in the Governor's Office of
26 Crime Prevention, Youth, and Victim Services.

27 (b) (1) The Board consists of [five] **SEVEN** members.

28 (2) **THE MEMBERSHIP OF THE BOARD SHALL REFLECT THE RACIAL,**
29 **ETHNIC, GEOGRAPHIC, AND GENDER DIVERSITY OF THE STATE.**

30 (3) Of the [five] **SEVEN** members of the Board:

31 (i) one shall be a family member of a homicide victim;

1 (ii) [no more than four may belong to the same political party] AT
2 LEAST ONE SHALL BE A SURVIVOR OF VIOLENCE WHO IS A MEMBER OF A COMMUNITY
3 THAT EXPERIENCES DISPROPORTIONATELY HIGH RATES OF VIOLENCE AND
4 INCARCERATION; and

5 (iii) [one shall have been admitted to practice law in the State for at
6 least 5 years immediately preceding the appointment] AT LEAST ONE SHALL BE A
7 REPRESENTATIVE OF AN ORGANIZATION THAT PROVIDES ASSISTANCE TO VICTIMS
8 APPLYING FOR VICTIM COMPENSATION.

9 [(3)] (4) The Executive Director shall appoint the members of the Board,
10 with the approval of the Governor and the advice and consent of the Senate.

11 (c) (1) The term of a member is 5 years.

12 (2) A member who is appointed to fill a vacancy occurring other than by
13 expiration of a term serves for the rest of the unexpired term.

14 (3) A MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE
15 TERMS.

16 11-805.

17 (a) Subject to the authority of the Executive Director, the Board has the following
18 powers and duties:

19 (1) to establish and maintain an office and to appoint and prescribe the
20 duties of a claims examiner, a secretary, clerks, and any other employees and agents as
21 may be necessary;

22 (2) to adopt regulations to carry out the provisions and purposes of this
23 subtitle, including procedures for the review and evaluation of claims and regulations for
24 the approval of attorneys' fees for representation before the Board or before the court on
25 judicial review;

26 (3) to request from the State's Attorney, the Department of State Police,
27 [or] county or municipal police departments, OR A QUALIFIED THIRD PARTY any
28 investigation and information that will help the Board to determine[:

29 (i)] whether a crime or a delinquent act was committed or attempted;
30 [and

31 (ii) whether and to what extent the victim or claimant was
32 responsible for the victim's or claimant's own injury;]

1 (4) to ~~DELEGATE TO EMPLOYEES OF THE BOARD THE ABILITY TO~~ hear
 2 and determine each claim for an award filed with the Board under this subtitle, ~~TO HEAR~~
 3 ~~APPEALS BY APPLICANTS OF INITIAL DETERMINATIONS MADE BY EMPLOYEES OF~~
 4 ~~THE BOARD~~, and to reinvestigate or reopen a case as the Board determines to be necessary;

5 (5) to direct medical examination of victims;

6 (6) to hold hearings, administer oaths, examine any person under oath, and
 7 issue subpoenas requiring the attendance and testimony of witnesses or requiring the
 8 production of documents or other evidence; AND

9 (7) to take or cause to be taken affidavits or depositions within or outside
 10 the State]; and

11 (8) to submit each year to the Governor, to the Executive Director, and,
 12 subject to § 2-1257 of the State Government Article, to the General Assembly a written
 13 report of the activities of the Board].

14 (b) Except as otherwise provided by law, an employee of the Board is subject to
 15 the State Personnel and Pensions Article.

16 (c) [(1)] The Board [may delegate to a member or employee of the Board its
 17 powers under this section to hold hearings, administer oaths, examine a person under oath,
 18 and issue subpoenas.

19 (2) A subpoena issued under this section is subject to the Maryland Rules]

20 **SHALL:**

21 (1) **MAY DELEGATE TO EMPLOYEES OF THE BOARD AUTHORITY TO**
 22 **HEAR CLAIMS AND MAKE INITIAL DETERMINATIONS REGARDING EACH CLAIM FOR**
 23 **AN AWARD FILED WITH THE BOARD UNDER THIS SUBTITLE, AND ANY OTHER**
 24 **POWERS NECESSARY FOR THE OFFICE WITHIN THE BOARD TO MAKE INITIAL**
 25 **DETERMINATIONS; AND**

26 (2) **SHALL** SUBMIT EACH YEAR TO THE GOVERNOR, TO THE
 27 **EXECUTIVE DIRECTOR, AND, SUBJECT TO § 2-1257 OF THE STATE GOVERNMENT**
 28 **ARTICLE, TO THE GENERAL ASSEMBLY A WRITTEN REPORT OF THE ACTIVITIES OF**
 29 **THE BOARD, INCLUDING:**

30 (I) THE NUMBER OF APPLICATIONS FILED WITH THE BOARD;

31 (II) THE NUMBER OF APPLICATIONS APPROVED;

32 (III) THE NUMBER OF APPLICATIONS DENIED;

1 (IV) AGGREGATED DATA REGARDING THE BASIS FOR EACH
2 DENIAL;

3 (V) ANONYMIZED DATA INDICATING THE RACE, GENDER, AGE,
4 AND COUNTY OF RESIDENCE OF VICTIMS;

5 (VI) ANONYMIZED DATA INDICATING THE CRIME INVOLVED IN
6 EACH APPLICATION; AND

7 (VII) THE AVERAGE TIME IN BETWEEN THE BOARD RECEIVING AN
8 APPLICATION, THE DETERMINATION OF ELIGIBILITY, AND THE FIRST
9 DISBURSEMENT TO THE VICTIM.

10 (D) (1) A CLAIM BY A PERSON OTHER THAN THE VICTIM MAY NOT
11 INCLUDE NARRATIVE DESCRIBING THE VICTIM OR A PHOTOGRAPH OF THE VICTIM.

12 (2) THE BOARD MAY NOT DISCLOSE THE IDENTITY OF OR
13 INFORMATION THAT CLEARLY IDENTIFIES A VICTIM OF SEXUAL ASSAULT, CHILD
14 ABUSE, STALKING, OR ELDER ABUSE.

15 (3) IF THE CONFIDENTIALITY OF A RECORD OR REPORT THAT THE
16 BOARD OBTAINS IS PROTECTED BY LAW OR REGULATION, THE RECORD OR REPORT
17 SHALL REMAIN CONFIDENTIAL, SUBJECT TO THE LAW OR REGULATION.

18 11-807.

19 (b) When a report of a [violent] crime is filed with a law enforcement unit, the
20 law enforcement unit shall give to a victim of that [violent] crime written information that
21 the Board supplies about compensation for victims.

22 11-808.

23 (a) (1) Except as provided in paragraph (2) of this subsection, the following
24 persons are eligible for awards in the manner provided under this subtitle:

25 (i) a victim;

26 (ii) a dependent of a victim who died as a direct result of:

27 1. a crime or delinquent act;

28 2. trying to prevent a crime or delinquent act or an attempted
29 crime or delinquent act from occurring in the victim's presence or trying to apprehend a
30 person who had committed a crime or delinquent act in the victim's presence [or had

1 committed a felony or a delinquent act that would be considered a felony if committed by
2 an adult]; or

3 3. helping a law enforcement officer perform the officer's
4 duties or helping a member of a fire department **OR AN AGENCY THAT PROVIDES**
5 **EMERGENCY MEDICAL SERVICES** who is obstructed from performing the member's
6 duties;

7 (iii) any person who paid or assumed responsibility for the funeral
8 expenses of a victim who died as a direct result of:

9 1. a crime or delinquent act;

10 2. trying to prevent a crime or delinquent act or an attempted
11 crime or delinquent act from occurring in the victim's presence or trying to apprehend a
12 person who had committed a crime or delinquent act in the victim's presence [or had
13 committed a felony]; or

14 3. helping a law enforcement officer perform the officer's
15 duties or helping a member of a fire department **OR AN AGENCY THAT PROVIDES**
16 **EMERGENCY MEDICAL SERVICES** who is obstructed from performing the member's
17 duties; and

18 (iv) 1. a parent, child, **DOMESTIC PARTNER, DEPENDENT**
19 **MINOR, ADULT UNDER LEGAL GUARDIANSHIP**, or spouse of a victim who resides with
20 the victim; or

21 2. a parent, child, **DOMESTIC PARTNER, DEPENDENT**
22 **MINOR, ADULT UNDER LEGAL GUARDIANSHIP**, or spouse of an individual who is
23 incarcerated for abuse as defined in § 4-501 of the Family Law Article and who, prior to
24 incarceration:

25 A. resided with the parent, child, **DOMESTIC PARTNER,**
26 **DEPENDENT MINOR, ADULT UNDER THEIR LEGAL GUARDIANSHIP**, or spouse; and

27 B. provided financial support to the parent, child, **DOMESTIC**
28 **PARTNER, DEPENDENT MINOR, ADULT UNDER THE INDIVIDUAL'S LEGAL**
29 **GUARDIANSHIP**, or spouse.

30 (2) A person who commits the crime or delinquent act that is the basis of a
31 claim, or an accomplice of the person, is not eligible to receive an award with respect to the
32 claim.

33 11-809.

1 (a) (1) Except as provided in paragraphs (2) [and], (3), AND (4) of this
2 subsection, a claimant shall file a claim within [3] 4 years after the later of:

3 (i) the discovery of the occurrence of the crime or delinquent act or
4 the death of the victim; or

5 (ii) the earlier of:

6 1. the date the claimant discovered an attempt to obtain a
7 reversal of a conviction, a sentence, or an adjudication for the crime or delinquent act; or

8 2. the date the claimant, exercising ordinary diligence,
9 should have discovered an attempt to obtain a reversal of a conviction, a sentence, or an
10 adjudication for the crime or delinquent act.

11 (2) In a case of child abuse, a claimant may file a claim[:

12 (i) up to the date the child who was the subject of the abuse reaches
13 the age of 25 years; or

14 (ii) if the Board determines that there was good cause for failure to
15 file a claim before the date the child who was the subject of the abuse reached the age of 25
16 years,] at any time.

17 (3) In a case [of sexual assault, a] **WHERE THE FILING OF A CLAIM WAS**
18 **DELAYED AS THE RESULT OF A DELAY IN THE TESTING OF DNA OR A DELAY IN DNA**
19 **PROFILE MATCHING FROM A SEXUAL ASSAULT FORENSIC EXAMINATION KIT OR**
20 **BIOLOGICAL MATERIAL RELATED TO A SEXUAL OFFENSE, A CLAIMANT SHALL FILE A**
21 **CLAIM WITHIN 4 YEARS AFTER NOTIFICATION OF THE RESULTS OF THE TESTING OR**
22 **DNA PROFILE MATCHING.**

23 (4) A claimant may file a claim at any time if the Board determines that
24 there was good cause for failure to file a claim within the time limits provided under
25 paragraphs (1) and [(2)] (3) of this subsection.

26 11-810.

27 (a) [(1)] The Board may make an award only if the Board finds that:

28 [(i)] (1) a crime or delinquent act was committed; AND

29 [(ii)] (2) the crime or delinquent act directly resulted in:

30 [1.] (I) physical injury to or death of the victim; or

1 [2.] (II) psychological injury to the victim that necessitated
2 mental health counseling[;

3 (iii) police, other law enforcement, or judicial records show that the
4 crime or delinquent act or the discovery of child abuse was reported to the proper
5 authorities within 48 hours after the occurrence of the crime or delinquent act or the
6 discovery of the child abuse; and

7 (iv) the victim has cooperated fully with all law enforcement units.

8 (2) For good cause, the Board may waive the requirements of paragraph
9 (1)(iii) and (iv) of this subsection].

10 (b) **THE BOARD SHALL ACCEPT AS EVIDENCE:**

11 (1) **A REPORT PRODUCED BY A LAW ENFORCEMENT AGENCY;**

12 (2) **MEDICAL RECORDS DOCUMENTING AN INJURY CONSISTENT WITH**
13 **THE ALLEGED CRIME;**

14 (3) **A SWORN STATEMENT FROM A QUALIFIED THIRD PARTY;**

15 (4) **A PEACE ORDER ISSUED UNDER TITLE 3, SUBTITLE 15 OF THE**
16 **COURTS ARTICLE;**

17 (5) **A PROTECTIVE ORDER ISSUED UNDER TITLE 4, SUBTITLE 5 OF**
18 **THE FAMILY LAW ARTICLE; AND**

19 (6) **ANY OTHER EVIDENCE THE BOARD CONSIDERS PROBATIVE.**

20 (C) Unless total dependency is established, family members, **HOUSEHOLD**
21 **MEMBERS, AND MINORS LIVING WITH A LEGAL GUARDIAN** are considered to be partly
22 dependent on a parent **OR A LEGAL GUARDIAN** with whom they reside without regard to
23 actual earnings.

24 [(c)] (D) The Board may make an award only if the claimant, as a result of the
25 injury on which the claim is based, has:

26 (1) incurred at least \$100 in unreimbursed and unreimbursable expenses
27 or indebtedness reasonably incurred or claimed for:

28 (i) medical care, **INCLUDING THE COST OF MEDICAL SUPPLIES;**

29 (ii) expenses for eyeglasses and other corrective lenses;

1 (iii) mental health counseling;

2 (iv) funeral expenses;

3 (v) repairing, replacing, or cleaning property;

4 (vi) disability or dependent claim, **OR ANY ASSISTIVE**
5 **TECHNOLOGY RELATED TO A DISABILITY OR DEPENDENT CLAIM; [or]**

6 **(VII) THE COSTS OF ONE-TIME RELOCATION, INCLUDING ANY**
7 **SECURITY DEPOSIT;**

8 **(VIII) CHILD CARE EXPENSES INCURRED AS A RESULT OF SEEKING**
9 **MEDICAL OR PSYCHOLOGICAL CARE;**

10 **(IX) TRANSPORTATION COSTS INCURRED BY TRAVEL TO SEEK**
11 **MEDICAL OR PSYCHOLOGICAL CARE; OR**

12 **[(vii)] (X) other necessary services; or**

13 (2) lost at least \$100 in earnings or support.

14 **[(d)] (E) [(1) (i)** Except as provided under subparagraph (ii) of this
15 paragraph, in considering a claim and in determining the amount of an award, the Board
16 shall determine whether the victim's conduct contributed to the infliction of the victim's
17 injury, and, if so, reduce the amount of the award or reject the claim.

18 (ii) The Board may disregard the responsibility of the victim for the
19 victim's own injury if that responsibility is attributable to efforts by the victim:

20 1. to prevent a crime or delinquent act or an attempted crime
21 or delinquent act from occurring in the victim's presence; or

22 2. to apprehend an offender who had committed a crime or
23 delinquent act in the victim's presence or had committed a felony or delinquent act that
24 would be a felony if committed by an adult.

25 **[(2)]** A claimant filing for injuries incurred as the occupant of a motor vehicle
26 or a dependent of an occupant of a motor vehicle operated in violation of § 21-902 of the
27 Transportation Article may not receive an award unless the claimant proves that the
28 occupant did not know or could not have known of the condition of the operator of the
29 vehicle.

30 **[(3)]** A claimant may not receive an award if:

1 (i) the victim initiated, consented to, provoked, or unreasonably
2 failed to avoid a physical confrontation with the offender; or

3 (ii) the victim was participating in a crime or delinquent act when
4 the injury was inflicted.]

5 [(e)] (F) (1) A victim or dependent may not be denied compensation [solely]
6 because the victim:

7 (i) is a relative of the offender; or

8 (ii) was living with the offender as a family member or household
9 member at the time of the injury or death.

10 (2) If the Board can reasonably determine that the offender will not receive
11 any economic benefit or undue enrichment from the compensation, the Board may award
12 compensation to a victim or dependent who is a relative, family member, or household
13 member of the offender.

14 11-811.

15 (a) (1) (i) Except as otherwise provided in this subsection, an award under
16 this subtitle shall be made in accordance with the schedule of benefits, as it existed on
17 January 1, 2001, and degree of disability as specified in Title 9, Subtitle 6 of the Labor and
18 Employment Article and any other applicable provisions of the Labor and Employment
19 Article, except for Title 9, Subtitle 8 of the Labor and Employment Article.

20 (ii) For determining the amount of an award under this subtitle, the
21 term “average weekly wages” does not include tips, gratuities, and wages that are
22 undeclared on the claimant’s State or federal income tax returns for the applicable years.

23 (iii) If a claimant does not have “average weekly wages” to qualify
24 under the formula in Title 9, Subtitle 6 of the Labor and Employment Article, the award
25 shall be in an amount equal to the average of the maximum and minimum awards listed in
26 the applicable portion of that subtitle.

27 (2) An award for loss of earnings or support made under this subtitle may
28 be up to two-thirds of the victim’s gross average wage, but may not be less than the amount
29 provided in paragraph (1) of this subsection.

30 (3) The parent or guardian of a victim who is a child and who resides with
31 the victim may be eligible for an award of up to 30 days of lost earnings as a result of caring
32 for the victim.

33 (4) An award for funeral expenses may not exceed [\$7,500] **\$10,000**.

1 (5) Subject to the limitation under subsection (b)(3) of this section and §
2 11–812 of this subtitle, a person who is eligible for an award as the result of the death of a
3 victim or psychological injury may be eligible, under the regulations that the Board adopts,
4 to receive psychiatric, psychological, or mental health counseling.

5 (6) Subject to the limitation under subsection (b)(6) of this section and §
6 11–812 of this subtitle, a parent, child, **DOMESTIC PARTNER, DEPENDENT**, or spouse of
7 a victim who resides with the victim and who is eligible for an award as the result of the
8 injury of a victim is eligible to receive psychiatric, psychological, or mental health
9 counseling.

10 (i) any award given under this subtitle; and

11 (ii) the costs of carrying out this subtitle.

12 (c) This section does not prohibit the Fund from receiving money from any other
13 source.

15 effect July 1, 2025.

16 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section
17 3 of this Act, this Act shall take effect July 1, 2024.
