Article – Estates and Trusts Section 2-108(x)(7)Annotated Code of Maryland (2017 Replacement Volume and 2021 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Estates and Trusts** 2 - 108. Except in Montgomery, Frederick, Carroll, Talbot, Cecil, Kent, Queen (x) (1)Anne's, [Baltimore,] Garrett, and Harford counties and Baltimore City, and except as **OTHERWISE** provided in [paragraphs (3) and (4) of] this subsection, a county shall pay a pension, in the same manner as salaries are paid during active service, to each judge of the Orphans' Court who: (i) Has terminated active service; (ii) Has reached 60 years of age; and (iii) Has completed at least two terms of office. THIS PARAGRAPH APPLIES ONLY IN BALTIMORE COUNTY. (7) **(I)** AN ORPHAN'S ORPHANS' COURT JUDGE IS ELIGIBLE FOR A **(II)** PENSION UNDER THIS SUBSECTION ONLY IF THE JUDGE WAS IN OFFICE ON OR AFTER **JANUARY 1, 2022.** THE PENSION SHALL BE THE GREATER OF: **(III)** 1. \$1,200 ANNUALLY; OR 2. AN ANNUAL AMOUNT CALCULATED AT THE RATE OF 4% OF THE LAST ANNUAL AMOUNT OF COMPENSATION MULTIPLIED BY THE NUMBER OF YEARS OF SERVICE BEGINNING ON OR AFTER JANUARY 1, 2022, NOT EXCEEDING 24 YEARS.
