6 7 8	(vi) In Dorchester County, a person hunting turkey on public land that is designated for hunting by the Department on any Sunday during the spring turkey hunting season; and
9 10	(vii) A person hunting deer under a Deer Management Permit on any Sunday throughout the year, including all deer hunting seasons.
11	(12) (I) THIS PARAGRAPH APPLIES ONLY IN DORCHESTER COUNTY.
12 13 14 15 16	(II) SUBJECT TO § §§ 10–411 AND 10–415 OF THIS SUBTITLE, THE DEPARTMENT MAY ALLOW A PERSON TO HUNT DEER ON PRIVATE PROPERTY ON A SUNDAY DURING THE BOW HUNTING SEASON FROM THE FIRST SUNDAY IN OCTOBER THROUGH THE SECOND SUNDAY IN JANUARY THE FOLLOWING YEAR, INCLUSIVE, ON:
