13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

17 18 19	(a) (1) In this section, "agricultural building" means a structure designed and constructed to house farm implements, hay, grain, poultry, livestock, or other horticultural products.
20	(2) "Agricultural building" does not include a place of human residence.
21	(b) This section applies only to:



- ANNE ARUNDEL COUNTY, Calvert County, Carroll County, Cecil 1 (1) 2 County, Charles County, Dorchester County, Frederick County, Garrett County, Harford County, Howard County, Prince George's County, St. Mary's County, Somerset County, and 3 Talbot County; or 4 5 a county where the local legislative body has approved the application (2)6 of this section to the county. 7 The Standards do not apply to the construction, alteration, or modification of (c) 8 an agricultural building for which agritourism is an intended subordinate use. 9 Except as provided in subsection (e) of this section, an existing agricultural (d) 10 building used for agritourism is not considered a change of occupancy that requires a building permit if the subordinate use of agritourism: 11 12 (1) is in accordance with limitations set forth in regulations adopted by the 13 Department; 14 (2)occupies only levels of the building on which a ground level exit is 15 located; and 16 (3)does not require more than 50 people to occupy an individual building 17 at any one time. 18 (e) In ANNE ARUNDEL COUNTY, Carroll County, Cecil County, Garrett County, and Howard County, an existing agricultural building used for agritourism is not 19 20 considered a change of occupancy that requires a building permit if: 21the subordinate use of agritourism does not require more than 200 22people to occupy an individual building at any one time; and 23the total width of means of egress meets or exceeds the International Building Code standard that applies to egress components other than stairways in a 2425 building without a sprinkler system. 26 An agricultural building used for agritourism: (f) 27 (1) shall be structurally sound and in good repair; but 28(2)need not comply with: 29 requirements for bathrooms, sprinkler systems, and elevators set 30 forth in the Standards; or
- 31 (ii) any other requirements of the Standards or other building codes 32 as set forth in regulations adopted by the Department.

- 1 (g) The Department shall adopt regulations to implement this section.
