1 (h) After a grant has been provided under this section, the State Racing 2 Commission shall:

3 (1) in consultation with the Department of General Services, monitor the 4 implementation of the approved capital construction plan; and

5 (2) make provisions for recapture of grant moneys if the capital 6 construction plan is not implemented within the time frame approved by the State Racing 7 Commission.

8 (i) Any unencumbered funds remaining in the Racetrack Facility Renewal 9 Account after a video lottery facility has been in operation for 16 years shall be paid to the 10 Education Trust Fund established under § 9–1A–30 of this subtitle.

11 (j) The State Racing Commission shall adopt regulations to implement the 12 provisions of this subsection, including regulations to address minimum criteria for the 13 types of improvements to be made by the holder of a license.

14 (k) The provisions of this section may not be construed to apply to the racecourse 15 in Allegany County.

1, 2019.
