CHAPTER _____

1 AN ACT concerning

2 **Frederick County – Gaming Events – Sunday Hours of Operation**

3 FOR the purpose of specifying that, in Frederick County, a gaming permit authorizes a
4 gaming event to be conducted on a Sunday during the hours of sale for the alcoholic
5 beverages sold at the establishment where the gaming event is conducted; and
6 generally relating to gaming in Frederick County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Criminal Law**

20 13–1301.

1 In this subtitle, “gaming event” includes:

- 2 (1) a bazaar;
- 3 (2) a carnival;
- 4 (3) a raffle;
- 5 (4) a tip jar; and
- 6 (5) a punchboard.

7 13–1302.

8 This subtitle applies only in Frederick County.

9 13–1304.

10 (a) Before an organization listed in subsection (b) of this section may conduct a
11 gaming event, the organization shall obtain a permit from the county agency that the
12 county commissioners designate.

13 (b) An organization may conduct a gaming event for its own benefit if the
14 organization is:

- 15 (1) a bona fide:
 - 16 (i) religious organization;
 - 17 (ii) fraternal organization;
 - 18 (iii) civic organization;
 - 19 (iv) war veterans’ organization;
 - 20 (v) hospital;
 - 21 (vi) amateur athletic organization;
 - 22 (vii) patriotic organization;
 - 23 (viii) educational organization; or
 - 24 (ix) charitable organization;
- 25 (2) a Frederick County volunteer:

- 1 (i) fire company;
- 2 (ii) rescue company; or
- 3 (iii) ambulance company; or
- 4 (3) an auxiliary for a Frederick County volunteer:

- 5 (i) fire company;
- 6 (ii) rescue company; or
- 7 (iii) ambulance company.

8 (c) (1) Before the county agency may issue a gaming permit, the county agency
9 shall determine whether the organization applying for the gaming permit meets the
10 requirements of this section.

11 (2) An application and the action that the county agency takes on the
12 application are public records.

- 13 (d) (1) (i) A gaming permit is valid for 1 year after the date that it is issued.
- 14 (ii) A gaming permit may not be transferred.

15 (2) The county commissioners may charge a permit fee.

16 (e) (1) Only members of an organization that holds a gaming permit may
17 conduct the gaming event.

18 (2) Except as allowed under § 13–1305 of this subtitle, an individual may
19 not benefit financially from a gaming event.

20 (3) A gaming permit [~~may not authorize~~] **AUTHORIZES** a gaming event to
21 be conducted on a Sunday [~~before 1 p.m.~~] **DURING THE HOURS OF SALE FOR THE**
22 **ALCOHOLIC BEVERAGES SOLD AT THE ESTABLISHMENT WHERE THE GAMING EVENT**
23 **IS CONDUCTED.**

24 (f) (1) The holder of a gaming permit may award:

- 25 (i) prizes to individuals at a gaming event; and
- 26 (ii) only one major prize at each gaming event.

27 (2) During each calendar year, the holder of a gaming event, including a
28 raffle for which the prize drawings are held on a single day, may not hold or receive the

1 proceeds from more than four gaming events in which the major prize has a value of more
2 than \$5,000.

3 (3) During each calendar year, the holder of a gaming event may hold one
4 raffle in which prize drawings are held on more than a single day if the major prize has a
5 value of \$5,000 or less.

6 (4) The county commissioners may regulate the number of permits to
7 conduct a raffle that an organization may receive in 1 calendar year.

8 (g) The county commissioners may adopt regulations to carry out this section and
9 §§ 13–1305 and 13–1307 of this subtitle.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2017.
