17 (A) IN THIS SECTION, "MILITARY FAMILY ADVOCACY PROGRAM" MEANS 18 THE PROGRAM ESTABLISHED BY THE UNITED STATES DEPARTMENT OF DEFENSE 19 TO ADDRESS CHILD ABUSE AND NEGLECT AND DOMESTIC ABUSE IN MILITARY 20 FAMILIES.

21 (B) A LOCAL DEPARTMENT THAT HAS A UNITED STATES MILITARY 22 INSTALLATION LOCATED WITHIN ITS JURISDICTION SHALL ENTER INTO A 23 MEMORANDUM OF UNDERSTANDING WITH THE MILITARY FAMILY ADVOCACY

#### 1 **PROGRAM AT THE LOCAL MILITARY INSTALLATION.**

2 (C) A MEMORANDUM OF UNDERSTANDING UNDER THIS SECTION SHALL 3 ESTABLISH PROCEDURES AND PROTOCOLS FOR:

4 (1) IDENTIFYING AN INDIVIDUAL ALLEGED TO HAVE COMMITTED 5 ABUSE OR NEGLECT AS MILITARY PERSONNEL;

6 (2) REPORTING BY A LOCAL DEPARTMENT TO A MILITARY FAMILY 7 ADVOCACY PROGRAM WHEN AN INVESTIGATION IMPLICATING MILITARY 8 PERSONNEL HAS BEEN INITIATED; AND

9 (3) MAINTAINING CONFIDENTIALITY REQUIREMENTS UNDER STATE 10 AND FEDERAL LAW.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2021.
