1 AN ACT concerning

2 **Correctional Services – Diminution Credits – Educational Accomplishment**

3 FOR the purpose of authorizing, with certain exceptions, a certain inmate to receive a
4 certain deduction from the inmate’s term of confinement for earning a certain
5 diploma, degree, certification, or certificate of completion; requiring the
6 Commissioner of Correction to adopt certain regulations; and generally relating
7 to the terms of confinement of inmates.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Correctional Services**

16 **3–706.1.**

1 **(A) ~~IN~~ EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, IN**
 2 **ADDITION TO ANY OTHER DEDUCTIONS ALLOWED UNDER THIS SUBTITLE, AN**
 3 **INMATE MAY BE ALLOWED A DEDUCTION OF 60 DAYS FROM THE INMATE'S TERM**
 4 **OF CONFINEMENT FOR EACH OF THE FOLLOWING EARNED BY THE INMATE:**

5 **(1) A GENERAL EQUIVALENCY DIPLOMA OR A HIGH SCHOOL**
 6 **DIPLOMA;**

7 **(2) A 2-YEAR OR 4-YEAR COLLEGE DEGREE;**

8 **(3) A 2-YEAR OR 4-YEAR CERTIFICATION IN APPLIED SCIENCES;**

9 **(4) A TECHNICAL EDUCATION DIPLOMA AS PROVIDED AND**
 10 **DEFINED BY THE COMMISSIONER; OR**

11 **(5) A CERTIFICATE OF COMPLETION FOR A CIVICS EDUCATION**
 12 **PROGRAM THAT REQUIRES PASSING A FINAL EXAMINATION.**

13 **(B) THE COMMISSIONER SHALL ADOPT REGULATIONS GOVERNING THE**
 14 **DETERMINATION OF DEDUCTIONS AUTHORIZED UNDER THIS SECTION.**

15 **(C) THIS SECTION DOES NOT APPLY TO AN INMATE WHO IS SERVING A**
 16 **SENTENCE FOR A VIOLATION OF § 2-201, § 2-204, § 2-205, OR § 2-206 OF THE**
 17 **CRIMINAL LAW ARTICLE.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 19 October 1, 2012.
