17	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18	That the Laws of Maryland read as follows:

21	(A) THE ADMINISTRATION SHALL ISSUE A SPECIAL MARYLAND HEROES
22	COMMEMORATIVE REGISTRATION PLATE.

- 1 FEES MAY NOT BE RETAINED BY OR TRANSFERRED TO ANY AGENCY OF THE STATE

- 3 (V) NOTWITHSTANDING SUBPARAGRAPH (IV) OF THIS
- 4 PARAGRAPH, THE SURPLUS MONEY AND MONEY COLLECTED FOR ADDITIONAL
- 5 RENEWAL FEES SHALL BE DISBURSED BY THE ADMINISTRATION TO THE MARYLAND
- 6 COMMISSION ON AFRICAN AMERICAN HISTORY AND CULTURE.
- 7 (3) NO PORTION OF THE ADDITIONAL INITIAL REGISTRATION OR
- 8 RENEWAL FEES MAY BE CREDITED TO THE GASOLINE AND MOTOR VEHICLE
- 9 REVENUE ACCOUNT FOR DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS
- 10 ARTICLE.
- 11 (D) (1) THE ADMINISTRATION SHALL ADOPT REGULATIONS NOT
- 12 INCONSISTENT WITH THE MARYLAND VEHICLE LAW TO GOVERN THE ISSUANCE OF
- 13 SPECIAL REGISTRATION PLATES UNDER THIS SECTION, INCLUDING REGULATIONS
- 14 DETAILING THE PLAN OF DISTRIBUTION OF THE FUNDS.
- 15 (2) THE ADMINISTRATION SHALL CONSULT WITH THE MARYLAND
- 16 COMMISSION ON AFRICAN AMERICAN HISTORY AND CULTURE TO ESTABLISH A
- 17 SCHEDULE UNDER WHICH THE ADMINISTRATION WILL TRANSFER TO THE
- 18 COMMISSION REVENUE COLLECTED ON BEHALF OF THE COMMISSION UNDER THIS

- 20 (E) THE ADDITIONAL FEES TO THE ANNUAL REGISTRATION FEE REQUIRED
- 21 BY THIS SECTION ARE NOT REQUIRED FOR SPECIAL REGISTRATION OF A VEHICLE
- 22 THAT IS EXEMPT UNDER § 13–903 OF THIS TITLE.
- 23 (F) (1) A COMMEMORATIVE REGISTRATION PLATE ISSUED UNDER THIS
- 24 SECTION SHALL DISPLAY:
- 25 (I) A SPECIAL REGISTRATION NUMBER ASSIGNED BY THE
- 26 ADMINISTRATION THAT MAY CONSIST OF ANY COMBINATION OF:
- 27 1. LETTERS; AND
- 28 2. Numerals; and
- 29 (II) A DESIGN APPROVED BY THE ADMINISTRATION THAT:
- 30 1. INCLUDES THE IMAGES OF HARRIET TUBMAN AND
- 31 FREDERICK DOUGLASS; AND

- 2. ADEQUATELY REFLECTS THE MARYLAND HEROES THEME THAT THE PLATE COMMEMORATES.
- 3 (2) THE ADMINISTRATION SHALL CONSULT WITH THE MARYLAND COMMISSION ON AFRICAN AMERICAN HISTORY AND CULTURE WITH RESPECT TO THE DESIGN OF THE MARYLAND HEROES COMMEMORATIVE REGISTRATION PLATE.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2023.
