- FOR the purpose of altering the definition of the term "pharmacist" in provisions of law 4 regarding the Prescription Drug Monitoring Program to include pharmacists licensed in other states to dispense monitored prescription drugs; altering the grounds for which a certain health occupations board and certain disciplinary panels are authorized to take disciplinary action against certain licensed dentists or applicants for a license to practice dentistry, certain licensed physician assistants, and certain licensed physicians for failing to comply with the requirements of the Program; and generally relating to the Prescription Drug Monitoring Program.
