1 AN ACT concerning

2 **Frederick County – Ethics and Campaign Activity – County Board and**
3 **Commission Members and Board of License Commissioners**

4 FOR the purpose of prohibiting a member of the Board of License Commissioners of
5 Frederick County ~~from having an authorized candidate campaign committee and~~
6 ~~campaign finance entity while serving as a member of the Board; requiring a certain~~
7 ~~individual appointed to the Board to close an open authorized candidate campaign~~
8 ~~committee and campaign finance entity by a certain day; or a person acting on behalf~~
9 ~~of the member, a campaign finance entity of the member, or any other campaign~~
10 ~~finance entity operated in coordination with the member from soliciting, receiving,~~
11 ~~depositing, or using a contribution while the member is serving on the Board;~~
12 ~~prohibiting a campaign finance entity of the member or any other campaign finance~~
13 ~~entity operated in coordination with the member from making an expenditure while~~
14 ~~the member is serving on the Board, except for a certain purpose; requiring a~~

31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
32 That the Laws of Maryland read as follows:

33 **Article – Alcoholic Beverages**

34 20–201.

35 There is a Board of License Commissioners for Frederick County.

36 20–202.

37 (a) The Governor shall appoint three members to the Board.

1 (b) Each member of the Board shall be:

2 (1) a registered voter of the county during the member's term of office; and

3 (2) an individual of good moral character and integrity who reasonably
4 reflects the citizenry of the county.

5 (c) (1) In this subsection, "direct or indirect interest" means an interest that
6 is proprietary or obtained by a loan, mortgage, or lien or in any other manner.

7 (2) A member of the Board may not:

8 (i) have a direct or indirect interest in or on a premises where
9 alcoholic beverages are manufactured or sold;

10 (ii) have a direct or indirect interest in a business wholly or partly
11 devoted to the manufacture or sale of alcoholic beverages;

12 (iii) own stock in:

13 1. a corporation that has a direct or indirect interest in a
14 premises where alcoholic beverages are manufactured or sold; or

15 2. a business wholly or partly devoted to the manufacture or
16 sale of alcoholic beverages;

17 (iv) hold any other public office or employment; or

18 (v) solicit or receive, directly or indirectly, a commission,
19 remuneration, or gift from:

20 1. a person engaged in the manufacture or sale of alcoholic
21 beverages; or

22 2. a license holder.

23 (3) A person who violates this subsection is guilty of a misdemeanor and is
24 subject to a fine not exceeding \$1,000.

25 (d) (1) The term of a member is 5 years.

26 (2) The terms of the members are staggered as required by the terms
27 provided for members of the Board on July 1, 2016.

28 (e) A member who is appointed after a term has begun serves only for the rest of
29 the term and until a successor is appointed and qualifies.

1 (f) (1) The Governor may remove a member for incompetence, misconduct,
2 neglect of a duty required by law, or unprofessional or dishonorable conduct.

3 (2) The Governor shall give a member who is charged a copy of the charges
4 against the member and, with at least 10 days' notice, an opportunity to be heard publicly
5 in person or by counsel.

6 (3) If a member is removed, the Governor shall file with the Office of the
7 Secretary of State a statement of charges against the member and the Governor's findings
8 on the charges.

9 (g) (1) IN THIS SUBSECTION, "CAMPAIGN FINANCE ENTITY" HAS THE
10 MEANING STATED IN § 1-101 OF THE ELECTION LAW ARTICLE.

18 (2) A MEMBER, A PERSON ACTING ON BEHALF OF THE MEMBER, A
19 CAMPAIGN FINANCE ENTITY OF THE MEMBER, OR ANY OTHER CAMPAIGN FINANCE
20 ENTITY OPERATED IN COORDINATION WITH THE MEMBER MAY NOT SOLICIT,
21 RECEIVE, DEPOSIT, OR USE A CONTRIBUTION WHILE THE MEMBER IS SERVING ON
22 THE BOARD.

23 (3) A CAMPAIGN FINANCE ENTITY OF THE MEMBER OR ANY OTHER
24 CAMPAIGN FINANCE ENTITY OPERATED IN COORDINATION WITH THE MEMBER MAY
25 NOT MAKE AN EXPENDITURE, EXCEPT TO PAY A LATE FILING FEE OR CIVIL PENALTY
26 IMPOSED UNDER TITLE 13 OF THE ELECTION LAW ARTICLE, WHILE THE MEMBER
27 IS SERVING ON THE BOARD.

28 (4) A CAMPAIGN FINANCE ENTITY OF THE MEMBER OR ANY OTHER
29 CAMPAIGN FINANCE ENTITY OPERATED IN COORDINATION WITH THE MEMBER
30 SHALL PAY ANY OUTSTANDING OBLIGATIONS BEFORE THE MEMBER BEGINS
31 SERVING ON THE BOARD.

32 ~~(4)~~ (5) No later than 48 hours after opening a campaign account through
33 a campaign finance entity, [as defined in § 1-101 of the Election Law Article,] a member
34 who has established an authorized candidate campaign committee shall vacate the

1 member's position on the Board in accordance with § 5-866 of the General Provisions
2 Article.

3 **Article – General Provisions**

4 5-865.

5 This part applies only to an appointed member of the Frederick County Board of
6 Zoning Appeals, the Frederick County Ethics Commission, the Frederick County Planning
7 Commission, or the Board of License Commissioners for Frederick County.

9 (A) IN THIS PART, "CAMPAIGN FINANCE ENTITY" HAS THE MEANING STATED
10 IN § 1-101 OF THE ELECTION LAW ARTICLE.

11 ~~(B) AN APPOINTED MEMBER OF A BOARD OR COMMISSION UNDER § 5-865~~
12 ~~OF THIS SUBTITLE MAY NOT HAVE AN AUTHORIZED CANDIDATE CAMPAIGN~~

25 (C) A CAMPAIGN FINANCE ENTITY OF THE MEMBER OR ANY OTHER
26 CAMPAIGN FINANCE ENTITY OPERATED IN COORDINATION WITH THE MEMBER MAY
27 NOT MAKE AN EXPENDITURE, EXCEPT TO PAY A LATE FILING FEE OR CIVIL PENALTY
28 IMPOSED UNDER TITLE 13 OF THE ELECTION LAW ARTICLE, WHILE THE MEMBER
29 IS SERVING ON THE BOARD OR COMMISSION.

30 (D) A CAMPAIGN FINANCE ENTITY OF THE MEMBER OR ANY OTHER
31 CAMPAIGN FINANCE ENTITY OPERATED IN COORDINATION WITH THE MEMBER
32 SHALL PAY ANY OUTSTANDING OBLIGATIONS BEFORE THE MEMBER BEGINS
33 SERVING ON THE BOARD OR COMMISSION.

1 ~~(D)~~ (E) Not later than 48 hours after opening a campaign account through a
2 campaign finance entity, [as defined in § 1-101 of the Election Law Article,] an appointed
3 member of [the Board of Zoning Appeals, Ethics Commission, Planning Commission, or the
4 Board of License Commissioners] **A BOARD OR COMMISSION UNDER § 5-865 OF THIS**
5 **SUBTITLE** who has established an authorized candidate campaign committee shall vacate
6 the position on the board or commission.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2019.
