A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Montgomery County –**
3 **Old Blair High School Auditorium**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005
5 to extend the date by which the Board of Directors of the Old Blair Auditorium
6 Project, Inc. must present evidence that a matching fund will be provided.

7 BY repealing and reenacting, with amendments,
8 Chapter 445 of the Acts of the General Assembly of 2005, as amended by
9 Chapter 65 of the Acts of the General Assembly of 2007, Chapter 219 of
10 the Acts of the General Assembly of 2008, and Chapter 707 of the Acts of
11 the General Assembly of 2009
12 Section 1(3) Item ZA01(AR) and Item ZA02(AV)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Chapter 445 of the Acts of 2005, as amended by Chapter 65 of the Acts of 2007,**
16 **Chapter 219 of the Acts of 2008, and Chapter 707 of the Acts of 2009**

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That:

20 (AR) Old Blair High School Auditorium. Provide a grant equal to
21 the lesser of (i) \$300,000 or (ii) the amount of the matching
22 fund provided, to the Board of Directors of the Old Blair
23 Auditorium Project, Inc. for the repair, renovation,
24 construction, reconstruction, and capital equipping of the Old
25 Blair High School Auditorium located in Silver Spring.
