2 **Children – Therapeutic Child Care Grant Program – ~~Funding~~ Establishment**

3 FOR the purpose of establishing the Therapeutic Child Care Grant Program to provide
4 ~~specialized child care and early childhood education by funding to educators, early~~
5 ~~intervention providers, mental health providers, and health care providers to certain~~
6 grants to certain providers that provide specialized child care and early education to
7 children under a certain age who have delays in development, physical disabilities,
8 or delays in social, emotional, or behavioral functioning; *requiring certain providers*
9 *who received certain grants to report certain information to the State Department of*
10 *Education on or before certain dates; requiring the Department to compile certain*
11 *information and provide reports to certain committees on or before certain dates;* and
12 generally relating to the Therapeutic Child Care Grant Program.

14 **(C) (1) THE PURPOSE OF THE PROGRAM IS TO PROVIDE GRANTS TO**
15 **PROVIDERS THAT SPECIALIZE IN PROVIDING CHILD CARE AND EARLY CHILDHOOD**
16 **EDUCATION TO CHILDREN UNDER THE AGE OF 6 YEARS WHO HAVE DEVELOPMENTAL**
17 **DELAYS, PHYSICAL DISABILITIES, OR DELAYS IN SOCIAL, EMOTIONAL, OR**
18 **BEHAVIORAL FUNCTIONING.**

19 **(2) THE DEPARTMENT SHALL ADMINISTER THE PROGRAM.**

20 **(3) ON OR BEFORE AUGUST 15 EACH YEAR, THE DEPARTMENT SHALL**
21 **AWARD GRANTS UNDER THIS SECTION.**

22 **(D) (1) FOR EACH OF FISCAL YEARS 2023 THROUGH 2025, THE**
23 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**
24 **\$3,700,000 TO THE PROGRAM.**

25 **(2) IN AWARDING GRANTS UNDER THE PROGRAM, THE DEPARTMENT**
26 **SHALL DISTRIBUTE:**

27 **(I) \$1,283,000 TO EXISTING PROVIDERS IN THE SAME AMOUNT**
28 **AS WAS PROVIDED IN FISCAL YEAR 2022;**

1 (II) \$1,917,000 TO EXISTING PROVIDERS IN THE SAME
 2 PROPORTION AS WAS PROVIDED IN FISCAL YEAR 2022 TO PROVIDE ADDITIONAL
 3 SERVICES; AND

4 (III) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS
 5 SUBSECTION, \$500,000 TO NEW PROVIDERS OR EXISTING PROVIDERS TO ENROLL
 6 ADDITIONAL CHILDREN.

7 (3) IF FUNDS ARE REMAINING AFTER THE DISTRIBUTION REQUIRED
 8 UNDER PARAGRAPH (2)(III) OF THIS SUBSECTION, THEN THE REMAINDER SHALL BE
 9 DISTRIBUTED AS PROVIDED UNDER PARAGRAPH (2)(II) OF THIS SUBSECTION.

10 (E) (1) ON OR BEFORE DECEMBER 1, 2022, AND DECEMBER 1, 2023, THE
 11 PROVIDERS WHO RECEIVED A GRANT UNDER THIS SECTION SHALL REPORT TO THE
 12 DEPARTMENT THE COST OF PROVIDING SERVICES TO A CHILD WITH
 13 DEVELOPMENTAL DELAYS, PHYSICAL DISABILITIES, OR DELAYS IN SOCIAL,
 14 EMOTIONAL, OR BEHAVIORAL FUNCTIONING AND THE SOURCES OF FUNDING
 15 RECEIVED BY THE PROVIDER.

16 (2) ON OR BEFORE DECEMBER 30, 2022, AND DECEMBER 30, 2023,
 17 THE DEPARTMENT SHALL COMPILE THE INFORMATION PROVIDED UNDER
 18 PARAGRAPH (1) OF THIS SUBSECTION AND SHALL REPORT THE COMPILED
 19 INFORMATION TO THE SENATE BUDGET AND TAXATION COMMITTEE AND THE
 20 HOUSE WAYS AND MEANS COMMITTEE, IN ACCORDANCE WITH § 2-1257 OF THE
 21 STATE GOVERNMENT ARTICLE.

22 (F) THE DEPARTMENT MAY ADOPT REGULATIONS NECESSARY TO CARRY
 23 OUT THIS SECTION.
