3 FOR the purpose of authorizing the Attorney General to institute an action in a circuit court for injunctive relief to prohibit a person from engaging in or continuing to 4 $\mathbf{5}$ engage in certain violations of election law; law, except in certain circumstances; 6 authorizing the State Prosecutor to seek injunctive relief in certain circumstances in 7 which the Attorney General is prohibited from seeking injunctive relief under this 8 Act; providing that injunctive relief may be granted under this Act only to prevent 9 certain violations of election law from affecting a pending election; requiring a 10 showing of certain evidence before injunctive relief may be granted under this Act; requiring a circuit court to hear and determine an action filed under this Act as soon 11 12as practicable; providing that the grant of a remedy under this Act does not preclude any other remedy available under State or federal law; providing that a circuit court 13 shall have jurisdiction over any proceeding instituted under this Act; requiring a 14 15circuit court to exercise its jurisdiction without regard to whether a person asserting a right under this Act has exhausted any other remedy available under law; and 1617generally relating to election law violations related to voting.
