AN ACT concerning
Task Force on Forest Conservation in Maryland Technical Study on Changes in Forest Cover and Tree Canopy in Maryland
FOR the purpose of requiring the Harry R. Hughes Center for Agro-Ecology, in consultation with the Department of Natural Resources, the Department of the Environment, the Department of Planning, the Department of Agriculture, and the Chesapeake Bay Program, to conduct a technical study to review changes in forest cover and tree canopy in the State; providing for the scope of the technical study requiring the Harry R. Hughes Center for Agro-Ecology to submit a report of it findings to the Governor and the General Assembly on or before a certain date providing for the termination of this Act; and generally relating to a technical study to review changes in forest cover and tree canopy in Maryland. establishing the Task Force on Forest Conservation in Maryland; providing for the composition, chair, and
staffing of the Task Force; authorizing the Task Force to establish subcommittees
