A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Social Work Examiners – Board Membership and Certified Social**
3 **Worker Licenses**

4 FOR the purpose of altering the membership of the State Board of Social Work Examiners;
5 repealing obsolete references to certified social worker licenses; and generally
6 relating to the State Board of Social Work Examiners.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Health Occupations**

20 19–101.

21 (a) In this title the following words have the meanings indicated.

22 (b) “Board” means the State Board of Social Work Examiners.

23 19–202.

1 (a) (1) The Board consists of 12 members.

2 (2) Of the 12 Board members:

3 (i) 10 shall be licensed social workers of whom:

4 1. Subject to paragraph (3) of this subsection, 1 is a licensed
5 bachelor social worker;

6 2. Subject to paragraph (3) of this subsection, 1 is a licensed
7 master social worker at the time of appointment;

8 3. Subject to paragraph (3) of this subsection, at least 1 is [a]:

9 A. A licensed certified social worker; OR

10 B. A LICENSED MASTER SOCIAL WORKER WHO IS
11 APPROVED FOR INDEPENDENT PRACTICE;

12 4. Subject to paragraph (3) of this subsection, at least 4 are
13 licensed certified social workers—clinical;

14 5. 1 is a licensed social worker employed by the Department
15 of Human Services; and

16 6. Subject to paragraph (3) of this subsection, 1 is a licensed
17 social worker who is:

18 A. Primarily engaged in social worker education at a social
19 work program accredited by the Council on Social Work Education; and

20 B. Nominated from a list of names submitted by the deans
21 and directors of the Maryland Social Work Education Programs; and

22 (ii) 2 shall be consumer members.

23 (3) If a [licensed bachelor social worker, a licensed master social worker, a
24 licensed certified social worker, a licensed certified social worker—clinical, or a licensed
25 social worker] **LICENSEE OF THE SPECIFIED LICENSE CATEGORY** is not appointed to the
26 Board under paragraph (2)(i) of this subsection within 3 months of a vacancy, a licensee of
27 any license category shall be appointed immediately if that licensee is qualified to be a
28 member of the Board under subsections (b) and (d) of this section.

29 (4) The Governor shall appoint all members of the Board with the advice
30 of the Secretary and the advice and consent of the Senate.

1 (5) The Governor shall appoint all social work members of the Board from
2 a list of nominees containing names submitted by:

3 (i) Professional social work associations in the State;

4 (ii) Any person who provides a statement of nomination signed by at
5 least 15 social workers licensed in the State;

6 (iii) The secretaries of public agencies of the State where social
7 workers are employed; or

8 (iv) The corporate executive officers or executive directors of private
9 organizations where social workers are employed.

10 19–302.1.

11 To obtain a [certified social worker license or a] certified social worker–clinical
12 license, an out–of–state applicant shall:

13 (1) Meet the requirements of § 19–302(a) of this subtitle;

14 (2) Be licensed or registered to practice social work in another state under
15 a category of licensure that is equivalent to a [certified social worker license or a] certified
16 social worker–clinical license;

17 (3) Have passed an examination in that state as a condition of licensure;
18 and

19 (4) Have performed at least 1,000 hours of compensated social work
20 practice per year for 5 years out of the 10 years preceding application to the Board.

22 (d) Subject to subsection (e) of this section, the Board shall reissue a license to an
23 individual who:

24 (6) (i) Passes the respective examination required for initial licensure;
25 or

26 (ii) 1. Holds an active license to practice social work in another
27 state under a category of licensure that is equivalent to a licensed bachelor social worker,
28 licensed master social worker, [certified social worker,] or certified social worker–clinical;
29 and

30 2. Has passed an examination in that state as a condition of
31 licensure.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
2 1, 2024.
