Maryland Pediatric Cancer Fund - Establishment and Income Tax Checkoff

- 3 FOR the purpose of establishing the Maryland Pediatric Cancer Fund; establishing the 4 Maryland Pediatric Cancer Advisory Committee to review and evaluate requests for 5 funding from the Fund; requiring the Secretary of Health to consider the evaluations 6 of the Advisory Committee before determining how to provide grants to eligible 7 persons from the Fund; requiring the Secretary to adopt regulations to implement a 8 pediatric cancer grant program; requiring the Comptroller to include a checkoff on individual income tax return forms for voluntary contributions to the Fund and to 9 include certain information in each individual income tax return package; and 10 generally relating to the Maryland Pediatric Cancer Fund. 11

- 8 (B) "ADVISORY COMMITTEE" MEANS THE MARYLAND PEDIATRIC CANCER 9 ADVISORY COMMITTEE.

- 24 SUBMIT A REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2–1257 OF
- 25 THE STATE GOVERNMENT ARTICLE, ON THE ADMINISTRATION OF THE FUND.
- 26 (2) THE REPORT REQUIRED UNDER THIS SUBSECTION SHALL
- 27 INCLUDE:
- 28 (I) THE GROSS AMOUNT OF DONATIONS TO THE FUND
- 29 THROUGH THE INCOME TAX CHECKOFF SYSTEM AND OTHERWISE;
- 30 (II) THE COST OF ADMINISTRATION BY THE COMPTROLLER OF
- 31 THE INCOME TAX CHECKOFF SYSTEM;

THE COMPTROLLER SHALL INCLUDE ON THE INDIVIDUAL 10 **(1)** INCOME TAX RETURN FORM A CHECKOFF DESIGNATED AS THE "MARYLAND 11 12 PEDIATRIC CANCER FUND CONTRIBUTION". 13 **(2)** THE CHECKOFF SHALL STATE THAT: 14 THE INDIVIDUAL, OR EACH SPOUSE IN THE CASE OF A JOINT **(I)** RETURN, MAY CONTRIBUTE TO THE MARYLAND PEDIATRIC CANCER FUND THE 15 AMOUNT DESIGNATED BY THE INDIVIDUAL; AND 16 17 (II)THE INDIVIDUAL SHALL DEDUCT THE AMOUNT OF THE 18 CONTRIBUTION FROM ANY REFUND TO WHICH THE INDIVIDUAL IS ENTITLED; OR 19 2. IF THE INDIVIDUAL IS NOT ENTITLED TO A REFUND, 20 THE INDIVIDUAL SHALL ADD THE AMOUNT OF THE CONTRIBUTION TO THE INCOME 21TAX TO BE PAID WITH THE RETURN. 22 THE COMPTROLLER SHALL INCLUDE, WITH THE INDIVIDUAL INCOME TAX RETURN PACKAGE, A DESCRIPTION OF THE PURPOSES FOR WHICH THE 23MARYLAND PEDIATRIC CANCER FUND WAS ESTABLISHED AND THE PURPOSES FOR 24WHICH THE FUND MAY BE USED. 25
- 26 (B) THE COMPTROLLER SHALL:
- 27 **(1)** COLLECT THE CHECKOFF CONTRIBUTIONS AND ACCOUNT TO THE 28STATE TREASURER FOR THE MONEY COLLECTED;
- 29 **(2)** FROM THE CONTRIBUTIONS COLLECTED, DISTRIBUTE THE 30 **AMOUNT** NECESSARY TO ADMINISTER THE CHECKOFF SYSTEM TO AN

1 ADMINISTRATIVE COST ACCOUNT; AND

- 2 (3) AFTER THE DISTRIBUTION UNDER ITEM (2) OF THIS SUBSECTION,
- 3 DISTRIBUTE THE REMAINDER OF THE MONEY COLLECTED UNDER THIS SUBSECTION
- 4 TO THE MARYLAND PEDIATRIC CANCER FUND ESTABLISHED UNDER § 20–121 OF
