## Article - Public Safety

- 3 (a) In this subtitle the following words have the meanings indicated.
- 4 (h) "Standards" means the Maryland Building Performance Standards.
- 5 12-508.
- 6 (a) (1) In this section, "agricultural building" means a structure designed and constructed to house farm implements, hay, grain, poultry, livestock, or other horticultural products.
- 9 (2) "Agricultural building" does not include a place of human residence.
- 10 (b) This section applies only to:
- 11 (1) Allegany County, Anne Arundel County, Baltimore County, Calvert
- 12 County, Carroll County, Cecil County, Charles County, Dorchester County, Frederick
- 13 County, Garrett County, Harford County, Howard County, Kent County, MONTGOMERY
- 14 COUNTY, Prince George's County, St. Mary's County, Somerset County, and Talbot
- 15 County; or
- 16 (2) a county where the local legislative body has approved the application of this section to the county.
- 18 (c) The Standards do not apply to the construction, alteration, or modification of an agricultural building for which agritourism is an intended subordinate use.
- 20 (d) Except as provided in subsection (e) <u>AND (F)</u> of this section, an existing 21 agricultural building used for agritourism is not considered a change of occupancy that 22 requires a building permit if the subordinate use of agritourism:
- 23 (1) is in accordance with limitations set forth in regulations adopted by the 24 Department;
- 25 (2) occupies only levels of the building on which a ground level exit is 26 located; and
- 27 (3) does not require more than 50 people to occupy an individual building 28 at any one time.
- 29 (e) In Allegany County, Anne Arundel County, Baltimore County, Carroll 30 County, Cecil County, Garrett County, Howard County, Kent County, Prince George's County, and St. Mary's County, an existing agricultural building used for agritourism is

32 not considered a change of occupancy that requires a building permit if:

6 7 8	(f) (1) IN MONTGOMERY COUNTY, AN EXISTING AGRICULTURAL BUILDING USED FOR AGRITOURISM IS NOT CONSIDERED A CHANGE OF OCCUPANCY THAT REQUIRES A BUILDING PERMIT AS PROVIDED IN THIS SUBSECTION.
9 10 11 12	(2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, IF THE SUBORDINATE USE OF AGRITOURISM DOES NOT REQUIRE MORE THAN 50 PEOPLE TO OCCUPY AN INDIVIDUAL BUILDING AT ANY ONE TIME, THEN THAT USE MUST BE:
