FOR the purpose of authorizing certain volunteer fire departments and certain organizations that promote the arts and preserve the culture in Prince George's County to hold events in which the public may play poker card games; limiting the number of poker events that may be held; requiring that a permit be obtained from the Prince George's County Department of Environmental Resources before a poker event may be held; specifying certain requirements that an applicant must meet to qualify for a permit; specifying the contents of an application for a permit; authorizing the Department to request from the Criminal Justice Information System Central Repository of the Department of Public Safety and Correctional Services a State and national criminal history records check for individuals who are to participate in the management or operation of a poker event; specifying certain items that are to be part of the application; requiring the Central Repository to forward criminal history record information to certain persons; specifying how criminal history record information may be used; allowing certain individuals to work as volunteers at a poker event; specifying grounds for the denial of an application for a permit or the suspension or denial of a permit; requiring that a certain worker have government-issued photographic identification; allowing certain individuals to prepare quarterly and annual financial reports; requiring a permit holder to maintain a certain bank account for a certain purpose; requiring that certain documents be maintained for a certain number of years; requiring a permit holder to file certain reports with the Department; providing a certain fee to be charged for failure to meet a certain filing deadline; requiring the president of the permit holder to be responsible for filing certain reports under certain circumstances; specifying the purposes for which proceeds from a poker event may be used; prohibiting proceeds to be used for certain purposes; requiring a permit holder to maintain details of use of proceeds disbursements for at least a
