5 Development Incentive Fund to be distributed for certain purposes; and generally

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

 2 Cecil County, Garrett County, or St. Mary's County shall distribute the hotel rental tax
 3 revenue as follows:

4 (1) a reasonable sum for hotel rental tax administrative costs to the general
 5 fund of the county;

6 (2) after the distribution in item (1) of this subsection, the revenue
 7 attributable to a hotel located in a municipality to the municipality; and

8 (3) the remaining balance to the general fund of the county.
