# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

#### Article – Election Law

16 (d) (4) (I) If the local board receives more than one legally sufficient 17 ABSENTEE ballot, in separate envelopes, from the same individual, the local board shall:

[(i)] 1. count only the [ballot with the latest properly signed oath]
 FIRST LEGALLY SUFFICIENT ABSENTEE BALLOT RECEIVED; and

20 [(ii)] 2. reject any other ABSENTEE ballot.

21(II)EXCEPT AS PROVIDED IN SUBPARAGRAPH (III) OF THIS22PARAGRAPH, IF THE LOCAL BOARD RECEIVES A LEGALLY SUFFICIENT ABSENTEE
