## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Criminal Law – Counterfeiting – Venue**

3 FOR the purpose of including the county in which an alleged counterfeit deed or other  
4 instrument is filed or recorded in a certain manner as a venue to prosecute a  
5 certain counterfeiting crime or other crime based on an act that establishes a  
6 certain counterfeiting crime; and generally relating to counterfeit deeds or other  
7 instruments.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 8–601.

17 (a) A person, with intent to defraud another, may not counterfeit, cause to be  
18 counterfeited, or willingly aid or assist in counterfeiting any:

- 1 (1) bond;
- 2 (2) check;
- 3 (3) deed;
- 4 (4) draft;
- 5 (5) endorsement or assignment of a bond, draft, check, or promissory  
6 note;
- 7 (6) entry in an account book or ledger;
- 8 (7) letter of credit;
- 9 (8) negotiable instrument;
- 10 (9) power of attorney;
- 11 (10) promissory note;
- 12 (11) release or discharge for money or property;
- 13 (12) title to a motor vehicle;
- 14 (13) waiver or release of mechanics' lien; or
- 15 (14) will or codicil.

16 (b) A person may not knowingly, willfully, and with fraudulent intent  
17 possess a counterfeit of any of the items listed in subsection (a) of this section.

18 (c) (1) A person who violates subsection (a) of this section is guilty of a  
19 felony and on conviction is subject to imprisonment not exceeding 10 years or a fine  
20 not exceeding \$1,000 or both.

21 (2) A person who violates subsection (b) of this section is guilty of a  
22 misdemeanor and on conviction is subject to imprisonment not exceeding 3 years or a  
23 fine not exceeding \$1,000 or both.

24 (d) Notwithstanding any other provision of law, the prosecution of an alleged  
25 violation of this section or for an alleged violation of a crime based on an act that  
26 establishes a violation of this section may be commenced in any county in which:

- 27 (1) an element of the crime occurred;

1                   (2)     **THE DEED OR OTHER ALLEGED COUNTERFEIT INSTRUMENT IS**  
2 **RECORDED IN THE COUNTY LAND RECORDS, FILED WITH THE CLERK OF THE**  
3 **CIRCUIT COURT, OR FILED WITH THE REGISTER OF WILLS;**

4                   (3)     the victim resides; or

5                   [(3)] (4)     if the victim is not an individual, the victim conducts  
6 business.

7                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
8 October 1, 2011.
