## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Allegany County – Alcoholic Beverages – ~~Transfer and Auction of Licenses~~**  
3 **Class B–D Beer, Wine, and Liquor License**

4 FOR the purpose of ~~providing for the transfer of certain expired alcoholic beverages licenses~~  
5 ~~by the Board of License Commissioners for Allegany County to the County~~  
6 ~~Commissioners of Allegany County; requiring the Board to issue a certain number~~  
7 ~~of new Class D licenses each year to the County Commissioners for certain purposes;~~  
8 ~~authorizing the Board to determine which types of new Class D licenses are issued~~  
9 ~~to the County Commissioners; providing that certain licenses are not subject to~~  
10 ~~certain limitations; requiring the County Commissioners to conduct a public auction~~  
11 ~~each year of certain alcoholic beverages licenses in a certain manner; providing for~~  
12 ~~the disposition of the proceeds of certain auctions; providing that certain licenses~~  
13 ~~transferred or issued to the County Commissioners are to be held solely for the~~  
14 ~~purposes of public auction and not to be exercised by the County Commissioners; and~~  
15 ~~generally relating to alcoholic beverages~~ establishing a Class B–D beer, wine, and  
16 liquor license in Allegany County; authorizing the Board of License Commissioners  
17 for Allegany County to issue a Class B–D license for use by a certain restaurant;  
18 authorizing a license holder to sell beer, wine, and liquor for on–premises  
19 consumption; requiring a license holder to submit a certain report on request from  
20 the Board; authorizing the Board to take certain enforcement actions under certain  
21 circumstances; requiring a license holder to demonstrate certain compliance as a  
22 prerequisite for license renewal; authorizing a license holder to sell beer, wine, and  
23 liquor during certain hours and days; establishing the annual license fee; limiting  
24 the number of Class B–D licenses that may be issued in a single year; and generally  
25 relating to alcoholic beverages licenses in Allegany County.

~~(2) THE AUCTION SHALL BE A PUBLIC AUCTION CONDUCTED BY SILENT BID ON A DATE AND ON TERMS THAT THE COUNTY COMMISSIONERS DETERMINE.~~

~~(3) (i) THE ANNUAL LICENSE FEE SHALL BE PAID TO THE BOARD OUT OF THE PROCEEDS OF THE PUBLIC AUCTION.~~

3 (B) THE BOARD MAY ISSUE THE LICENSE FOR USE BY A RESTAURANT THAT:

4 (1) IS LOCATED IN A PERMANENT BUILDING WITH AMPLE SPACE AND  
5 ACCOMMODATIONS;

6 (2) COMMONLY OFFERS HOT AND COLD MEALS THAT ARE PREPARED,  
7 SOLD, AND SERVED TO THE PUBLIC DURING REGULAR BUSINESS HOURS;

8 (3) MAINTAINS A MENU THAT ADVERTISES A VARIETY OF FOOD THAT  
9 THE ESTABLISHMENT SERVES;

10 (4) SERVES FOOD AT ALL TIMES WHENEVER ALCOHOLIC BEVERAGES  
11 ARE BEING SERVED OR CONSUMED; AND

12 (5) HAS, ON AN ANNUAL BASIS, GROSS SALES OF FOOD AND  
13 NONALCOHOLIC BEVERAGES THAT EXCEED ITS GROSS SALES OF ALCOHOLIC  
14 BEVERAGES.

15 (C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,  
16 AND LIQUOR FOR ON-PREMISES CONSUMPTION.

17 (D) (1) (I) ONCE EVERY LICENSING CYCLE, THE LICENSE HOLDER  
18 SHALL COMPLY WITH A REQUEST FROM THE BOARD TO SUBMIT A FOOD ALCOHOL  
19 RATIO REPORT COVERING 2 PRECEDING QUARTERS THAT THE BOARD SELECTS TO  
20 DEMONSTRATE COMPLIANCE WITH THE ANNUAL GROSS SALES REQUIREMENT  
21 UNDER SUBSECTION (B)(5) OF THIS SECTION.

22 (II) TO ENFORCE THIS PARAGRAPH, THE BOARD MAY:

23 1. REQUEST A LICENSE HOLDER TO PROVIDE  
24 SUPPORTING DATA OR ADDITIONAL INFORMATION;

25 2. IMPOSE A FINE ON A LICENSE HOLDER; OR

3 **OPERATION, AND SALES AMOUNTS AND PERCENTAGES FOR FOOD, NONALCOHOLIC**  
4 **BEVERAGES, AND ALCOHOLIC BEVERAGES FOR THE TIME PERIOD REQUESTED.**

5           **(E) AS A PREREQUISITE FOR THE RENEWAL OF THE LICENSE, THE LICENSE**  
6 **HOLDER SHALL DEMONSTRATE COMPLIANCE WITH THE ANNUAL GROSS SALES**  
7 **REQUIREMENT UNDER SUBSECTION (B)(5) OF THIS SECTION.**

8           **(F) THE LICENSE HOLDER MAY SELL BEER, WINE, AND LIQUOR DURING THE**  
9 **HOURS AND DAYS SET OUT FOR A CLASS B–D BEER, WINE, AND LIQUOR LICENSE**  
10 **UNDER § 9–2004 OF THIS TITLE.**

11           **(G) THE ANNUAL LICENSE FEE IS \$700.**

13           **NOT MORE THAN TWO CLASS B–D LICENSES MAY BE ISSUED IN A SINGLE**  
14 **YEAR.**

16           (a) (1) **Except as provided in § 9–2005 of this subtitle for December 31 and**  
17 **January 1, a holder of a Class A beer, wine, and liquor license may sell beer, wine, and**  
18 **liquor for off–premises consumption:**

19                           (i) **on Monday through Saturday from 7 a.m. to 2 a.m. the following**  
20 **day; and**

21                           (ii) **on Sunday from 11 a.m. to 2 a.m. the following day if the holder:**

22                                       1. **pays an additional fee of \$250; or**

23                                       2. **is issued a 2–day Sunday sales permit in accordance with**  
24 **paragraph (2) of this subsection.**

25                           (2) (i) **The Board may issue a 2–day Sunday sales permit to a holder of**

31 **from 11 a.m. to 2 a.m. the following day.**

1                   (iv) The permit fee is \$50 for each time the permit is used.

2           (b) (1) Except as provided in § 9–2005 of this subtitle for December 31 and  
3 January 1, a holder of a Class B beer, wine, and liquor license may sell beer, wine, and  
4 liquor:

5                   (i) on Monday through Saturday, for on–premises and off–premises  
6 consumption, from 7 a.m. to 2 a.m. the following day;

7                   (ii) on Sunday, for on–premises and off–premises consumption, from  
8 11 a.m. to 2 a.m. the following day if the holder:

9                           1. pays an additional fee of \$250;

10                           2. is issued the license for use in a restaurant in a permanent  
11 building with ample space and accommodations where meals are usually prepared, sold, or  
12 served to the public when the restaurant is regularly open for business; or

13                           3. is issued a 2–day Sunday sales permit in accordance with  
14 paragraph (2) of this subsection.

15           (2) (i) The Board may issue a 2–day Sunday sales permit to a holder of  
16 a Class B beer, wine, and liquor license, including a Class B beer, wine, and liquor license  
17 issued for use in a restaurant or banquet room in a hotel or motel.

18                   (ii) An applicant for a 2–day Sunday sales permit need not have  
19 kitchen facilities on the licensed premises.

20                   (iii) A 2–day Sunday sales permit authorizes the holder to sell beer,  
21 wine, and liquor for on–premises and off–premises consumption on not more than two  
22 Sundays in a year from 11 a.m. Sunday to 2 a.m. the following day.

23                   (iv) The permit fee is \$50 for each time the permit is used.

24           **(C) (1) EXCEPT AS PROVIDED IN § 9–2005 OF THIS SUBTITLE FOR**  
25 **DECEMBER 31 AND JANUARY 1, A HOLDER OF A CLASS B–D BEER, WINE, AND**  
26 **LIQUOR LICENSE MAY SELL BEER, WINE, AND LIQUOR:**

27                   **(I) ON MONDAY THROUGH SATURDAY, FOR ON–PREMISES**  
28 **CONSUMPTION, FROM 7 A.M. TO 2 A.M. THE FOLLOWING DAY; AND**

29                   **(II) ON SUNDAY:**

30                           **1. FROM 11 A.M. TO 2 A.M. THE FOLLOWING DAY IF THE**  
31 **HOLDER PAYS AN ADDITIONAL FEE OF \$250; OR**

17 11 a.m. to 2 a.m. the following day if the holder:

19                                    2. is issued a 2-day Sunday sales permit in accordance with  
20 paragraph (2) of this subsection.

21                                    (2) (i) The Board may issue a 2-day Sunday sales permit to a holder of  
22 a Class C beer, wine, and liquor license.

23                                    (ii) An applicant for a 2-day Sunday sales permit need not have  
24 kitchen facilities on the licensed premises.

25                                    (iii) A 2-day Sunday sales permit authorizes the holder to sell beer,  
26 wine, and liquor for on-premises and off-premises consumption on not more than two  
27 Sundays in a year from 11 a.m. Sunday to 2 a.m. the following day.

28                                    (iv) The permit fee is \$50 for each time the permit is used.

29                                    [(d)] (E) (1) Except as provided in § 9-2005 of this subtitle for December 31  
30 and January 1, a holder of a Class D beer, wine, and liquor license may sell beer, wine, and  
31 liquor:

1                   (i)     on Monday through Saturday, for on-premises and off-premises  
 2 consumption, from 7 a.m. to 2 a.m. the following day;

3                   (ii)    on Sunday, from 11 a.m. to 2 a.m. the following day if the holder  
 4 pays an additional fee of \$250; or

5                   (iii)  in accordance with a 2-day Sunday sales permit issued under  
 6 paragraph (2) of this subsection.

7               (2)   (i)     The Board may issue a 2-day Sunday sales permit to a holder of  
 8 a Class D beer, wine, and liquor license.

9                   (ii)    An applicant for a 2-day Sunday sales permit need not have  
 10 kitchen facilities on the licensed premises.

11                  (iii)  A 2-day Sunday sales permit authorizes the holder to sell beer,  
 12 wine, and liquor for on-premises and off-premises consumption on not more than two  
 13 Sundays in a year from 11 a.m. Sunday to 2 a.m. the following day.

14                  (iv)   The permit fee is \$50 for each time the permit is used.

15               SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
 16 1, 2021.
