1 AN ACT concerning

2 **Motor Vehicle Administration – Identification Cards and Drivers’ Licenses**

3 FOR the purpose of altering the period of validity of identification cards issued for
4 certain applicants by the Motor Vehicle Administration; repealing a
5 requirement that certain information be stated on a driver’s license application
6 form; authorizing the Administration to waive a vision examination for certain
7 license applicants under certain circumstances; and generally relating to
8 drivers’ licenses and identification cards.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

2 12–301.

3 (i) (1) Subject to paragraph (3) of this subsection, an identification card
4 issued to an applicant [at least 16 years old] **UNDER THE AGE OF 65** expires at the
5 end of a period of not more than 5 years determined in regulations adopted by the
6 Administration.

7 (2) Subject to paragraph (3) of this subsection, an identification card
8 issued to an applicant [under the age of 16 years expires every 5 years] **AT LEAST 65**
9 **YEARS OLD EXPIRES AT THE END OF A PERIOD OF NOT MORE THAN 8 YEARS**
10 **DETERMINED IN REGULATIONS ADOPTED BY THE ADMINISTRATION.**

11 (3) (i) If an applicant has temporary lawful status, the
12 Administration may not issue an identification card to the applicant for a period that
13 extends beyond the expiration date of the applicant's authorized stay in the United
14 States or, if there is no expiration date, for a period longer than 1 year.

15 (ii) Nothing contained in this paragraph may be construed to
16 allow the issuance of an identification card for a period longer than the period
17 described in paragraphs (1) and (2) of this subsection.

18 (iii) The Administration shall indicate on the face and in the
19 machine-readable zone of a temporary identification card issued under this paragraph
20 that the card is a temporary identification card.

21 (4) An identification card may be renewed on application and payment
22 of the fee required by this section.

23 16–106.

24 (a) Each application for a driver's license shall be made on the form that the
25 Administration requires.

26 (b) The application shall state:

27 (1) The full name, Maryland residence address, [employer,] race, sex,
28 height, weight, general physical condition, and date of birth of the applicant;

29 (2) Whether the applicant previously has been refused a license to
30 drive and, if so:

31 (i) By what state or country; and

32 (ii) The date of and reason for the refusal;

1 (3) Whether the applicant previously has been licensed to drive and, if
2 so:

3 (i) When and by what state or country; and

4 (ii) Whether the license ever has been suspended, revoked, or
5 canceled and, if so, the date of and reason for the suspension, revocation, or
6 cancellation;

7 (4) Subject to the provisions of subsection (c) of this section, the
8 applicant's Social Security number; and

9 (5) Any other pertinent information that the Administration requires.

11 (h) The Administration may not waive a vision examination required under
12 this section **UNLESS THE APPLICANT:**

13 **(1) IS APPLYING FOR A CORRECTED DRIVER'S LICENSE UNDER §**
14 **16-114.1 OF THIS SUBTITLE; AND**

15 **(2) HAS PASSED A VISION EXAMINATION ACCEPTABLE TO THE**
16 **ADMINISTRATION WITHIN THE LAST 12 MONTHS.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2010.
