18 19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:



- 3 (B) (1) EACH LOCAL BOARD SHALL VERIFY THE SIGNATURE OF THE 4 VOTER ON THE RETURN ENVELOPE OR BALLOT/RETURN ENVELOPE BY COMPARING 5 THE SIGNATURE WITH THE VOTER'S REGISTRATION RECORD IN ACCORDANCE WITH
- 6 REGULATIONS ADOPTED BY THE STATE BOARD.

- 4 (a) Following an election, each local board shall meet at its designated counting 5 center to canvass the absentee ballots cast in that election in accordance with the 6 regulations and guidelines established by the State Board.
- 7 (b) (1) A local board may not open any envelope of an absentee ballot prior to 8 8 a.m. on the Wednesday following election day.
- 9 (2) A local board may not delay the commencement of the canvass to await 10 the receipt of late-arriving, timely absentee ballots.
- 11 (c) (1) An absentee ballot shall be deemed timely received if it is received in accordance with the regulations and guidelines established by the State Board.
- 13 (2) An absentee ballot that is received after the deadline specified by the regulations and guidelines may not be counted.
- 15 (d) (1) The State Board shall adopt regulations that reflect the policy that the clarity of the intent of the voter is the overriding consideration in determining the validity of an absentee ballot or the vote cast in a particular contest.
- 18 (2) A local board may not reject an absentee ballot except by unanimous vote and in accordance with regulations of the State Board.
- 20 (3) The local board shall reject an absentee ballot if:
- 21 (i) the voter failed to sign the oath on the [ballot envelope] RETURN 22 ENVELOPE OR BALLOT/RETURN ENVELOPE AND FAILED TO CORRECT THE OMISSION 23 AS PROVIDED IN § 9–310.2 OF THIS ARTICLE;
- 24 (ii) the local board received more than one ballot from the same 25 individual for the same election in the same ballot envelope; or
- 26 (iii) the local board determines that an absentee ballot is 27 intentionally marked with an identifying mark that is clearly evident and placed on the 28 ballot for the purpose of identifying the ballot.
- 29 (4) If the local board receives more than one legally sufficient ballot, in separate envelopes, from the same individual, the local board shall:
- 31 (i) count only the ballot with the latest properly signed oath; and

- 2 (5) If the intent of the voter is not clearly demonstrated, the local board 3 shall reject only the vote for that office or question.
 - (6) If an absentee voter casts a vote for an individual who has ceased to be a candidate, the vote for that candidate may not be counted, but that vote does not invalidate the remainder of the ballot.
- 7 (e) At the end of each day of canvassing, a local board shall prepare and release 8 a report of the unofficial results of the absentee ballot vote tabulation.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
