5 (D) ON OR BEFORE DECEMBER 31 EACH YEAR, EACH PUBLIC INSTITUTION 6 OF HIGHER EDUCATION SHALL REPORT TO THE COMMISSION AND, IN ACCORDANCE 7 WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY 8 ON THE FOLLOWING METRICS RELATED TO THE IMMEDIATELY PRECEDING 9 ACADEMIC YEAR:

10 (1) THE TOTAL NUMBER OF STUDENTS AWARDED ACADEMIC CREDIT 11 FOR PRIOR LEARNING;

14(3) THE NUMBER OF ACADEMIC CREDITS AWARDED TO15MATRICULATING STUDENTS FOR PRIOR LEARNING AND, OF THOSE CREDITS:
