- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 15 That the Laws of Maryland read as follows:
- 16 Article State Personnel and Pensions
- 17 26–403.
- 18 (a) Except as provided in [subsection (f)] SUBSECTIONS (F) AND (G) of this
- 19 section, a retiree who is receiving a service retirement allowance may accept employment

- 3 (b) A reemployed retiree who is receiving a service retirement allowance may not 4 receive creditable service or eligibility service during the period of reemployment.
- 5 (c) The retiree's compensation during the period of reemployment may not be subject to the employer pickup provisions of § 21–303 of this article or any reduction or deduction as a member contribution for pension or retirement purposes.
- 8 (d) The State Retirement Agency shall institute appropriate reporting procedures 9 with the affected payroll systems to ensure compliance with this section.
- 10 (e) (1) Immediately on the employment of any retiree, a participating 11 employer shall notify the State Retirement Agency of the type of employment and the 12 anticipated earnings of the retiree.
- 13 (2) At least once each year, in a format specified by the State Retirement 14 Agency, each participating employer shall provide the State Retirement Agency with a list 15 of all employees included on any payroll of the employer, the Social Security numbers of 16 the employees, and their earnings for that year.
- 17 (f) An individual who is receiving a service retirement allowance under this title 18 may not be employed within 45 days of the date the individual retired, on a permanent, 19 temporary, or contractual basis, by:
- 20 (1) the State or other participating employer; or
- 21 (2) a withdrawn participating governmental unit, if the retiree was an 22 employee of the withdrawn participating governmental unit while the withdrawn 23 governmental unit was a participating employer.
- 24 (G) (1) This section applies to a retiree who is elected as a Sheriff less than 5 years 1 year after the retiree's date of retirement.
- 26 (2) THE BOARD OF TRUSTEES SHALL, AFTER GIVING NOTICE, 27 TEMPORARILY SUSPEND THE RETIREE'S ALLOWANCE AS OF THE DATE THE RETIREE 28 BEGINS SERVING AS A SHERIFF.
- 29 **(3)** ON RECEIVING SATISFACTORY DOCUMENTATION THAT THE **(I)** INDIVIDUAL IS NO LONGER SERVING AS A SHERIFF, THE BOARD OF TRUSTEES 30 31 SHALL REINSTATE THE RETIREE'S **ALLOWANCE** WITH **ACCUMULATED** 32COST-OF-LIVING ADJUSTMENTS FROM THE DATE THE ALLOWANCE WAS 33 TEMPORARILY SUSPENDED.
