HOUSE JOINT RESOLUTION

1 A House Joint Resolution concerning

2 **Equal Benefits for Treatment for Agent Orange Exposure of Vietnam**
3 **Veterans Who Served Outside Vietnam**

4 FOR the purpose of urging the United States Congress to extend medical benefits for
5 the treatment for Agent Orange exposure of Vietnam veterans who served
6 outside Vietnam that are equal to the medical benefits provided to Vietnam
7 veterans who served within the country's borders.

8 WHEREAS, Thousands of veterans of the Vietnam War suffer from the effects
9 of exposure to Agent Orange, a powerful and toxic defoliant used to clear areas of
10 dense vegetation used as enemy hideouts; and

11 WHEREAS, Agent Orange exposure causes a variety of devastating health
12 effects, including increased rates of cancer, immune system disorders, and genetic
13 maladies that lead to birth defects in the children of individuals exposed to Agent
14 Orange; and

15 WHEREAS, Although the use of Agent Orange is most commonly associated
16 with the country of Vietnam, it also was used extensively in surrounding areas such as
17 Thailand; and

18 WHEREAS, Many veterans affected by exposure to Agent Orange proudly and
19 bravely served their country in these surrounding areas without ever actually serving
20 in Vietnam; and

21 WHEREAS, These veterans are struggling to obtain the same medical benefits
22 to deal with their exposure to Agent Orange as those veterans who served on the
23 ground in Vietnam; now, therefore, be it



1 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the
2 Congress of the United States is urged to work with the Department of Veterans
3 Affairs to ensure that Vietnam veterans who served in areas surrounding Vietnam are
4 able to receive the same medical benefits for the treatment of Agent Orange exposure
5 as those veterans who served within the country's borders; and be it further
