A BILL ENTITLED

1 AN ACT concerning

Real Property – Expedited Wrongful Detainer Proceedings – Property for Sale or Lease

4 FOR the purpose of requiring certain expedited proceedings in a wrongful detainer action $\mathbf{5}$ if the property that is the subject of the action is, at the time of the complaint, 6 advertised or listed for sale or lease by the complainant; requiring that notice of a 7 hearing on a certain complaint or a certain appeal be served in person or, under 8 certain circumstances, posted conspicuously on the property; requiring a certain 9 court to issue a warrant within a certain number of hours if the court rules in favor of the complainant in a certain expedited wrongful detainer action; and generally 10 11 relating to a wrongful detainer action for possession of real property.
