CHAPTER _____

1 AN ACT concerning

2 **Community Colleges – Out-of-State Fee – Waiver for Border State Residents**

3 FOR the purpose of authorizing the boards of trustees of community colleges with service
4 areas that border other states to set an out-of-state fee for certain students who
5 reside in out-of-state counties that border Maryland; requiring that this fee be more
6 than the out-of-county fee paid by certain Maryland students; allowing this fee to
7 be less than the usual out-of-state fee paid by certain out-of-state students;
8 prohibiting students attending community colleges by paying this fee from being
9 counted for the purposes of certain State aid to community colleges; making a
10 conforming change; and generally relating to a fee for out-of-state community
11 college students residing in counties bordering their school's service area.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Education**

4 16–310.

5 (a) (1) Subject to paragraphs (2), (3), (4), (5), [and] (6), AND (7) of this
6 subsection and subsection (f) of this section, any student who attends a community college
7 in this State and is not a resident of this State shall pay, in addition to the student tuition
8 and fees payable by a county resident, an out-of-state fee, at least equal to:

9 (i) 60% of the county share per full-time equivalent student as
10 determined under § 16–305 of this subtitle; and

11 (ii) The marginal cost component of the State share per full-time
12 equivalent student as determined under § 16–305(c)(5) of this subtitle.

13 **(2) (I) EACH BOARD OF TRUSTEES OF A COMMUNITY COLLEGE**
14 **WITH A SERVICE AREA THAT BORDERS ANOTHER STATE MAY SET AN OUT-OF-STATE**
15 **FEE IN ACCORDANCE WITH SUBPARAGRAPH (II) OF THIS PARAGRAPH FOR ANY**
16 **STUDENT WHO RESIDES IN AN OUT-OF-STATE COUNTY THAT BORDERS THE**
17 **COMMUNITY COLLEGE’S SERVICE AREA.**

18 **(II) THE FEE DESCRIBED IN SUBPARAGRAPH (I) OF THIS**
19 **PARAGRAPH:**

20 **1. SHALL BE MORE THAN THE OUT-OF-COUNTY FEE AS**
21 **DETERMINED IN SUBSECTION (B)(1) OF THIS SECTION; AND**

22 **2. MAY BE LESS THAN THE OUT-OF-STATE FEE AS**
23 **DETERMINED IN PARAGRAPH (1) OF THIS SUBSECTION.**

24 **(III) ANY STUDENT ATTENDING A COMMUNITY COLLEGE IN THIS**
25 **STATE WHO PAYS A FEE AS PROVIDED IN THIS PARAGRAPH MAY NOT BE INCLUDED**
26 **AS AN IN-STATE RESIDENT FOR COMPUTATION OF STATE AID TO COMMUNITY**
27 **COLLEGES IN ACCORDANCE WITH § 16–305 OF THIS SUBTITLE.**

28 **[(2)] (3) (i)** A resident of the state of West Virginia who attends
29 Garrett College under a negotiated reciprocity agreement between the states of Maryland
30 and West Virginia is an in-county resident for tuition purposes.

31 **(ii)** For each full-time equivalent student participating in the
32 reciprocity agreement, the State shall pay to Garrett College an amount equal to the net
33 State support per full-time equivalent student as provided in § 16–305 of this subtitle. For

1 any fiscal year, if State appropriations for reimbursement of any reciprocity agreements
2 under this paragraph do not provide sufficient funds to fully reimburse the college, the
3 Governor shall include in the budget bill for the next fiscal year a deficiency appropriation
4 to provide the additional funds to fully reimburse the college.

5 (iii) The Commission may make payments to effectuate the
6 provisions of this paragraph from funds specifically appropriated for this purpose as
7 provided in the State budget or any supplemental budget request.

8 (iv) The payments authorized by this paragraph are in addition to
9 the State operating fund to community colleges authorized in § 16–305(c) of this subtitle.

10 **[(3)] (4)** (i) Any student attending a community college in this State
11 who is not a resident of this State and is enrolled in an education program leading to
12 licensure in nursing shall be included as an in–county resident for tuition purposes and
13 shall be included as an in–State resident for computation of the State aid to community
14 colleges in accordance with § 16–305 of this subtitle.

15 (ii) The student shall furnish a surety bond or promissory note to the
16 State with security satisfactory to the Maryland Higher Education Commission, that on
17 completion of the nursing education program, the student will work for at least 2 years in
18 a hospital or related institution as defined in § 19–301 of the Health – General Article in
19 this State.

20 (iii) The Secretary of Health and Mental Hygiene may determine if
21 there is a shortage of nurses.

22 (iv) Subject to subparagraphs (v) and (vi) of this paragraph, if the
23 Secretary determines that there is no shortage of nurses, the Nonresident Student Tuition
24 Reduction and State Aid Program established under this paragraph may not be applied to
25 any courses required for the nursing program.

26 (v) Subparagraph (iv) of this paragraph applies only to students who
27 enroll in a nursing education program subsequent to the determination made under
28 subparagraph (iv) of this paragraph.

29 (vi) Subparagraph (v) of this paragraph may not affect any student
30 who is participating in the Nonresident Tuition Reduction and State Aid Program prior to
31 the determination under subparagraph (iii) of this paragraph.

32 **[(4)] (5)** (i) Each board of community college trustees may waive the
33 out–of–state fee as determined in paragraph (1) of this subsection for a student who is
34 employed by a business located in the county that supports the community college.

35 (ii) Any student attending a community college in this State who
36 receives a tuition waiver as provided by this paragraph shall not be included as an in–State

1 resident for computation of State aid to community colleges in accordance with § 16–305 of
2 this subtitle.

3 ~~[(5)]~~ **(6)** (i) Each board of community college trustees shall waive the
4 out-of-state fee as determined in paragraph (1) of this subsection for a student who resides
5 in this State but does not meet the in-State residency requirement for tuition purposes and
6 is a public school teacher employed by a county board if:

7 1. A. The course or program is required by the State or
8 the county board to maintain the teacher's present position with the county board; or

9 B. The course or program maintains or improves skills
10 required by the county board in the teacher's current position;

11 2. The teacher resides in this State and is employed as a
12 full-time public school teacher; and

13 3. The teacher has been employed as a public school teacher
14 in the State for less than a year.

15 (ii) A public school teacher is responsible for the difference between
16 in-State and out-of-state tuition if:

17 1. The teacher resigns or is terminated from employment
18 with the county board; and

19 2. The teacher remains enrolled in the course or program at
20 a community college during the teacher's first year as a Maryland resident.

21 (iii) Any public school teacher attending a community college in this
22 State who satisfies the requirements established in this paragraph shall be included as an
23 in-State resident for computation of the State aid to community colleges in accordance with
24 § 16–305 of this subtitle.

25 ~~[(6)]~~ **(7)** (i) In this paragraph, "BRAC" means the Base Realignment
26 and Closure process as announced by the United States Department of Defense.

27 (ii) Each board of community college trustees may waive the
28 out-of-state fee as determined in paragraph (1) of this subsection for a student who resides
29 in the State but does not meet the in-State residency requirement for tuition purposes and
30 has moved to the State as an employee or a family member of an employee as part of BRAC.

31 (iii) Any BRAC employee or family member of a BRAC employee
32 attending a community college in the State who satisfies the requirements established in
33 this paragraph shall be included as an in-State resident for computation of the State aid
34 to community colleges in accordance with § 16–305 of this subtitle.

1 (b) (1) Subject to the provisions of paragraphs (2), (3), and (4) of this subsection
2 and subsection (g) of this section, any student who attends a community college not
3 supported by the county in which the student resides shall pay, in addition to the student
4 tuition and fees payable by a resident of a county that supports the community college, an
5 out-of-county or out-of-region fee at least equal to 60% of the county share per full-time
6 equivalent student as determined under § 16-305 of this subtitle.

8 (g) (4) A student who is not a resident of the State shall be considered a
9 resident for purposes of assessing tuition and fees to the extent that such student would be
10 eligible for in-county status under the provisions of § [16-310(a)(3)] **16-310(A)(4)** or (f) of
11 this title.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2017.
