- 1 This section applies to a claim by the estate of [an individual] A DECEDENT (a) 2 or a beneficiary of [the individual resulting from the death of the individual in a vehicle 3 accident] THE DECEDENT, WHO DIED AS A RESULT OF AN ALLEGED TORT. 4 A claimant may obtain the documentation described in § 10-1102 of this subtitle if the claimant provides in writing to the insurer: 5 6 The date of the [vehicle accident] ALLEGED TORT; (1)7 The name and last known address of the alleged tortfeasor; (2) 8 A copy of the [vehicle accident report] ANY VEHICLE ACCIDENT (3) 9 REPORT OR POLICE REPORT CONCERNING THE ALLEGED TORT, if available: 10 The insurer's claim number, if available; **(4)** 11 A copy of the decedent's death certificate issued in the State or another (5)12 jurisdiction; 13 A copy of the letters of administration issued to appoint the personal 14 representative of the decedent's estate in the State or a substantially similar document issued by another jurisdiction; 15 16 (7)The name of each beneficiary of the decedent, if known; and 17 The relationship to the decedent of each known beneficiary of the (8)18 decedent. 19 10-1105.20 An insurer shall provide in writing the documentation described under § 2110–1102 of this subtitle within 30 days after the date of a request in accordance with § 22 10-1103 or \ 10-1104 of this subtitle, regardless of whether the insurer contests the 23applicability of coverage to a claim.

criminally liable for the disclosure of documentation required under this subtitle.

27 (1) An admission that a claim is subject to the applicable agreement 28 between the insurer and the alleged tortfeasor; or

An insurer, and the employees and agents of an insurer, may not be civilly or

29 (2) A waiver of any term or condition of the applicable agreement between 30 the insurer and the alleged tortfeasor or any right of the insurer, including any potential 31 defense concerning coverage or liability.

- 1 (d) Documentation disclosed under this subtitle is not admissible as evidence at 2 trial by reason of its disclosure under this subtitle.
 - SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any claim filed with an insurer, as defined in Section 1 of this Act, before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2017.
