CHAPTER _____

1 AN ACT concerning

2 **Election Law – Campaign Finance – Draft Committees and Exploratory**
3 **Committees**

4 FOR the purpose of applying certain campaign finance requirements for a political
5 committee to draft committees and exploratory committees; establishing
6 requirements and prohibitions for draft committees and exploratory committees
7 relating to the establishment of the committees, receipt of funds, and permissible
8 disbursements; requiring an authorized candidate campaign committee that results
9 from the draft committee or exploratory committee to make any equipment
10 purchases from the draft committee or exploratory committee at the fair market
11 value of the equipment; requiring a draft committee or an exploratory committee to
12 dispense of remaining funds in a certain manner in a certain time frame;
13 establishing that a draft committee or an exploratory committee is not subject to any
14 contribution limit; and generally relating to draft committees and exploratory
15 committees.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Election Law**

12 1–101.

13 (a) In this article the following words have the meanings indicated unless a
14 different meaning is clearly intended from the context.

15 (k) (1) “Campaign material” means any material that:

16 (i) contains text, graphics, or other images;

17 (ii) relates to a candidate, a [prospective] **POTENTIAL** candidate, or
18 the approval or rejection of a question or prospective question; and

19 (iii) is published, distributed, or disseminated.

20 (2) “Campaign material” includes:

21 (i) a qualifying paid digital communication;

22 (ii) any other material transmitted by or appearing on the Internet
23 or other electronic medium;

24 (iii) an oral commercial campaign advertisement; and

25 (iv) an automated or prerecorded oral communication.

26 (l) (1) “Candidate” means an individual who files a certificate of candidacy for
27 a public or party office.

28 (2) “Candidate” includes:

29 (i) an incumbent justice of the Supreme Court of Maryland or
30 Appellate Court of Maryland at an election for continuance in office; and

1 (ii) an individual, prior to that individual filing a certificate of
2 candidacy, if a campaign finance entity has been established on behalf of that individual.

3 (gg) "Political committee" means a combination of two or more individuals that has
4 as its major purpose promoting the success or defeat of a candidate, political party,
5 question, or prospective question submitted to a vote at any election.

7 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
8 INDICATED.

9 (2) (I) "DONATION" MEANS THE GIFT OR TRANSFER, OR PROMISE
10 OF GIFT OR TRANSFER, OF MONEY OR OTHER THING OF VALUE TO A PERSON THAT
11 MAKES DISBURSEMENTS FOR A DRAFT COMMITTEE OR AN EXPLORATORY
12 COMMITTEE.

13 (II) "DONATION" DOES NOT INCLUDE ANY AMOUNT OF MONEY
14 OR ANY OTHER THING OF VALUE:

15 1. RECEIVED BY A PERSON IN THE ORDINARY COURSE OF
16 ANY TRADE OR BUSINESS CONDUCTED BY THE PERSON, WHETHER FOR PROFIT OR
17 NOT FOR PROFIT, OR IN THE FORM OF INVESTMENTS IN THE PERSON'S BUSINESS;
18 OR

19 2. A. THAT THE DONOR AND THE PERSON RECEIVING
20 THE MONEY OR THING OF VALUE EXPRESSLY AGREE IN WRITING MAY NOT BE USED
21 FOR A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE; AND

22 B. IN THE CASE OF A MONETARY DONATION, IS
23 DEPOSITED IN A SEPARATE BANK ACCOUNT THAT IS NEVER USED FOR A DRAFT
24 COMMITTEE OR AN EXPLORATORY COMMITTEE.

25 (3) "DRAFT COMMITTEE" MEANS AN ENTITY THAT IS ORGANIZED TO
26 ENCOURAGE A POTENTIAL CANDIDATE TO RUN FOR OFFICE BUT IS NOT AUTHORIZED
27 BY THE POTENTIAL CANDIDATE.

28 (4) "EXPLORATORY COMMITTEE" MEANS AN ENTITY ESTABLISHED
29 BY A POTENTIAL CANDIDATE FOR A PUBLIC OFFICE TO DETERMINE THE POTENTIAL
30 CANDIDATE'S VIABILITY FOR THAT PUBLIC OFFICE.

31 (B) EXCEPT AS OTHERWISE PROVIDED IN §§ 13-220.1 AND 13-220.2 OF THIS
32 TITLE AND SUBTITLE 2, PART V OF THIS TITLE, ALL PROVISIONS OF THIS TITLE

1 THAT APPLY TO A POLITICAL COMMITTEE ALSO APPLY TO A DRAFT COMMITTEE OR
2 AN EXPLORATORY COMMITTEE.

3 (C) A PERSON MAY ESTABLISH A DRAFT COMMITTEE FOR A PUBLIC OFFICE
4 FOR AN INDIVIDUAL ONLY IF:

5 (1) THE DRAFT COMMITTEE IS NOT ESTABLISHED IN COORDINATION
6 OR COOPERATION WITH THE INDIVIDUAL IT INTENDS TO ENCOURAGE TO SEEK
7 PUBLIC OFFICE; AND

8 (2) THE INDIVIDUAL THE DRAFT COMMITTEE INTENDS TO
9 ENCOURAGE TO SEEK PUBLIC OFFICE IS NOT A CANDIDATE FOR THAT PUBLIC
10 OFFICE.

11 (D) AN INDIVIDUAL WHO IS A CANDIDATE MAY ESTABLISH A DRAFT
12 COMMITTEE OR AN EXPLORATORY COMMITTEE FOR ANOTHER PUBLIC OFFICE.

13 (E) SUBJECT TO SUBSECTION (F) OF THIS SECTION, A DRAFT COMMITTEE
14 OR AN EXPLORATORY COMMITTEE FOR AN INDIVIDUAL MAY RECEIVE FUNDS AND
15 MAKE DISBURSEMENTS TO DETERMINE THE INDIVIDUAL'S VIABILITY FOR A PUBLIC
16 OFFICE.

17 (F) A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE MAY MAKE A
18 DISBURSEMENT ONLY FOR THE FOLLOWING:

19 (1) CONDUCTING SURVEYS OR POLLS REGARDING VIABILITY OF THE
20 POTENTIAL CANDIDATE FOR A PUBLIC OFFICE;

21 (2) DIRECT MAILINGS AND OTHER COMMUNICATIONS TO POTENTIAL
22 VOTERS;

23 (3) EMPLOYING STAFF;

24 (4) ESTABLISHING A WEBSITE;

25 (5) QUALIFYING PAID DIGITAL COMMUNICATIONS;

26 (6) RENTING OR LEASING OFFICE SPACE; AND

27 (7) PURCHASING ELECTRONIC EQUIPMENT, INCLUDING COMPUTERS
28 AND TELEPHONES.

29 (G) A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE MAY NOT PAY
30 ANY EXPENSE IN ADVANCE FOR GOODS OR SERVICES TO BE USED BY THE POLITICAL

1 COMMITTEE OF THE POTENTIAL CANDIDATE ONCE THE POTENTIAL CANDIDATE
2 REGISTERS AN AUTHORIZED CANDIDATE CAMPAIGN COMMITTEE.

3 (H) IF AN AUTHORIZED CANDIDATE CAMPAIGN COMMITTEE RESULTS FROM
4 THE DRAFT COMMITTEE OR EXPLORATORY COMMITTEE, ANY PURCHASES MADE BY
5 THE AUTHORIZED CANDIDATE CAMPAIGN COMMITTEE OF EQUIPMENT FROM THE
6 DRAFT COMMITTEE OR EXPLORATORY COMMITTEE SHALL BE MADE AT THE FAIR
7 MARKET VALUE OF THE EQUIPMENT.

8 (I) (1) A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE SHALL
9 RETURN ANY REMAINING FUNDS RECEIVED UNDER SUBSECTION (E) OF THIS
10 SECTION IN ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION WITHIN 120
11 DAYS AFTER:

12 (I) A POTENTIAL CANDIDATE OR AN INDIVIDUAL A DRAFT
13 COMMITTEE ENCOURAGED TO SEEK PUBLIC OFFICE:

14 1. TIMELY FILES A CERTIFICATE OF CANDIDACY FOR A
15 PUBLIC OFFICE UNDER TITLE 5, SUBTITLE 3 OF THIS ARTICLE; OR

16 2. PUBLICLY ANNOUNCES THAT THE INDIVIDUAL HAS
17 DECLINED TO FILE A CERTIFICATE OF CANDIDACY FOR PUBLIC OFFICE; OR

18 (II) THE DEADLINE FOR FILING A CERTIFICATE OF CANDIDACY
19 UNDER TITLE 5, SUBTITLE 3 OF THIS ARTICLE HAS PASSED.

20 (2) A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE SHALL
21 RETURN FUNDS UNDER PARAGRAPH (1) OF THIS SUBSECTION:

22 (I) PRO RATA TO THE CONTRIBUTORS; OR

23 (II) BY PAYING THE REMAINING FUNDS TO:

24 1. IF THE POTENTIAL CANDIDATE OR INDIVIDUAL THE
25 DRAFT COMMITTEE ENCOURAGED TO SEEK PUBLIC OFFICE IS A MEMBER OF A
26 POLITICAL PARTY:

27 A. THE STATE CENTRAL COMMITTEE OF THE POLITICAL
28 PARTY; OR

29 B. A LOCAL CENTRAL COMMITTEE OF THE POLITICAL
30 PARTY;

1 **2. IF THE POTENTIAL CANDIDATE OR INDIVIDUAL THE**
 2 **DRAFT COMMITTEE ENCOURAGED TO SEEK PUBLIC OFFICE ESTABLISHES AN**
 3 **AUTHORIZED CANDIDATE CAMPAIGN COMMITTEE, SUBJECT TO § 13-226 OF THIS**
 4 **TITLE, THE AUTHORIZED CANDIDATE CAMPAIGN COMMITTEE;**

5 **3. A NONPROFIT ORGANIZATION EXEMPT FROM**
 6 **TAXATION UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE; OR**

7 **4. THE FAIR CAMPAIGN FINANCING FUND**
 8 **ESTABLISHED UNDER § 15-103 OF THIS ARTICLE.**

9 **(J) A DONATION TO A DRAFT COMMITTEE OR AN EXPLORATORY COMMITTEE**
 10 **IS NOT SUBJECT TO ANY LIMITS.**

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 12 January 1, 2025.
