SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That: There is a Waterway Incident Notification System (WINS) Workgroup. (a) (b) The Workgroup consists of the following members: (1)one member of the Senate of Maryland, appointed by the President of the Senate: (2) one member of the House of Delegates, appointed by the Speaker of the House: (3)the Secretary of Emergency Management, or the Secretary's designee; **(4)** the Chair of the Maryland 9–1–1 Board, or the Chair's designee;

23 24	(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.
25 26	(g) A member of the Workgroup serves at the pleasure of the person who appointed the member.
27	(h) At the Workgroup's first meeting, the Workgroup shall vote to adopt a code of

conduct providing for the acceptable conduct of Workgroup members.

The Workgroup shall study and make recommendations regarding:

1 2 3 4	(1) the feasibility of establishing a Waterway Incident Notification System to notify members of the public, including recreational boaters and commercial waterment of active waterway emergencies involving a person at risk of death or serious bodily harm emergency marine events, or marine hazards; and
5 6 7 8 9	(2) potential partnerships among the State, the U.S. Coast Guard, the U.S. Navy, and nearby states to improve notifications to members of the public, including recreational boaters and commercial watermen, of waterway emergencies involving a person at risk of death or serious bodily harm, emergency marine events, or marine hazards.
10 11 12	(h) (j) (1) On or before December 31, 2024, the Workgroup shall submit an interim report of its findings and recommendations to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly.
13 14 15	(2) On or before September 30, 2025, the Workgroup shall submit a final report of its findings and recommendations to the Governor and, in accordance with § 2–1257 of the State Government Article, the General Assembly.
16 17 18 19	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2024. It shall remain effective for a period of 2 years and 1 month and, at the end of June 30, 2026, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
