A BILL ENTITLED

1 AN ACT concerning

2 **Workers' Compensation – Volunteer Canteen and Rehabilitation Personnel**

3 FOR the purpose of altering the definition of “on duty” in workers’ compensation law
4 to include the performance of certain support or rehabilitation services for
5 certain emergency responders under certain circumstances; altering the
6 definition of “volunteer company” to include a volunteer canteen, rehabilitation,
7 or personnel support unit; and generally relating to workers’ compensation for
8 volunteer canteen and rehabilitation personnel.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Labor and Employment**

17 9–234.

18 (a) (1) In this section the following words have the meanings indicated.

19 (2) (i) “On duty” means:

20 1. fighting a fire;

21 2. performing a duty of a member of an advanced life
22 support unit or an ambulance, first aid, or rescue squad in a volunteer company;

1 3. except as provided in subparagraph (ii) of this
2 paragraph, performing a duty that the volunteer company assigns to the member;

3 4. performing a duty that a written bylaw or rule of
4 government adopted for the volunteer company assigns to the member;

5 5. **PERFORMING SUPPORT OR REHABILITATION**
6 **SERVICES, INCLUDING SUPPLYING NECESSARY FOOD OR FLUIDS OR PROVIDING**
7 **RELIEF FROM CLIMATIC CONDITIONS, FOR EMERGENCY RESPONDERS DURING**
8 **AN EMERGENCY INCIDENT OR A TRAINING EXERCISE;**

9 6. going to or from performing a duty included under
10 item 1, 2, 3, [or] 4, **OR 5** of this subparagraph;

11 [6.] 7. accompanying an accident or fire victim while
12 being transported to a hospital in a helicopter;

13 [7.] 8. returning to the home station of the individual
14 after accompanying a victim under item [6] 7 of this subparagraph;

15 [8.] 9. performing a duty assigned to a member of a
16 fire company appointed as a deputy sheriff under § 7–302 or § 7–303 of the Public
17 Safety Article; or

18 [9.] 10. performing a duty assigned to an individual
19 appointed to serve as a member of the fire police in Washington County under § 7–304
20 of the Public Safety Article.

21 (ii) “On duty” does not include attendance of a member of a
22 volunteer company at a social function unless a written bylaw or rule of government
23 adopted for the volunteer company requires the attendance or participation of the
24 member.

25 (3) “Volunteer company” means:

26 (i) a volunteer advanced life support unit;

27 (ii) a volunteer ambulance company or squad;

28 (iii) a volunteer fire company or department;

29 (iv) a volunteer rescue company, department, or squad; [and]

30 (v) a volunteer fire police unit; **AND**

1 **(VI) A VOLUNTEER CANTEEN, REHABILITATION, OR**
2 **PERSONNEL SUPPORT UNIT.**

3 (b) An individual who is a covered employee under subsection (h)(2), (k), (n),
4 (o)(2), (p)(1)(ii), (r)(3), (v), or (x)(1) of this section continues to be a covered employee
5 while:

6 (1) accompanying an accident or fire victim who is being transported
7 to a hospital in a helicopter; and

8 (2) returning to the home station of the individual after accompanying
9 a victim under item (1) of this subsection.

10 (c) (1) Unless an election is made under paragraph (2) of this subsection,
11 a member of a volunteer company in Allegany County is not a covered employee.

12 (2) The Board of County Commissioners for Allegany County may
13 provide by resolution for members of a volunteer company in the county to be covered
14 employees while on duty.

15 (d) A member of a volunteer company in Anne Arundel County is a covered
16 employee while on duty.

17 (e) A member of a volunteer company in Baltimore County is a covered
18 employee while on duty.

19 (f) A member of a volunteer company in Calvert County is a covered
20 employee while on duty.

21 (g) A member of a volunteer company in Caroline County is a covered
22 employee while on duty.

23 (h) (1) Unless an election is made in accordance with this subsection, a
24 member of a volunteer company in Carroll County is not a covered employee.

25 (2) A volunteer fire company in Carroll County may elect to make its
26 members covered employees.

27 (3) A volunteer fire company that elects to make its members covered
28 employees shall pay the premium for the coverage.

29 (i) (1) A member of a volunteer company in Cecil County who meets the
30 guidelines set under paragraph (2) of this subsection is a covered employee while on
31 duty.

1 (2) The Board of County Commissioners of Cecil County may set
2 guidelines to determine the eligibility of members of a volunteer company in the
3 county for coverage under this subsection.

4 (3) The guidelines under paragraph (2) of this subsection may not
5 limit the number of covered employees in a volunteer company.

6 (j) (1) Unless an election is made in accordance with this subsection, a
7 member of a volunteer company in Charles County is not a covered employee.

8 (2) The Board of County Commissioners of Charles County may
9 provide by resolution for members of a volunteer company in the county to be covered
10 employees while on duty.

11 (k) A member of a volunteer company in Dorchester County is a covered
12 employee.

13 (l) A member of a volunteer company in Frederick County is a covered
14 employee while on duty.

15 (m) (1) Unless an election is made under paragraph (2) of this subsection,
16 a member of a volunteer company in Garrett County is not a covered employee.

17 (2) The Board of County Commissioners for Garrett County may
18 provide by resolution for members of a volunteer company in the county to be covered
19 employees while on duty.

20 (n) A member of a volunteer company in Harford County is a covered
21 employee.

22 (o) An individual is a covered employee:

23 (1) while on duty as an actively participating member of a volunteer
24 company in Howard County; or

25 (2) if not covered under item (1) of this subsection, while a member of
26 a volunteer company in Howard County participating in the activities of the volunteer
27 company.

28 (p) (1) An individual is a covered employee:

29 (i) while on duty as an actively participating member of a
30 volunteer company in Kent County; or

31 (ii) if not covered under item (i) of this paragraph, while a
32 member of a volunteer company in Kent County.

1 (2) The Board of County Commissioners of Kent County shall impose
2 annually a tax on assessable property in the county in an amount that is sufficient to
3 pay for coverage under this subsection.

4 (3) The Board of County Commissioners of Kent County may limit the
5 number of members in a volunteer company in the county.

6 (q) A member of a volunteer company in Montgomery County is a covered
7 employee while on duty.

8 (r) An individual is a covered employee:

9 (1) while on duty as a member of the Laurel volunteer rescue squad in
10 Prince George's County; or

11 (2) while a member of a volunteer company in Prince George's County.

12 (s) A member of a volunteer company in Queen Anne's County is a covered
13 employee while on duty.

14 (t) (1) Unless an election is made under paragraph (2) of this subsection,
15 a member of a volunteer company in St. Mary's County is not a covered employee.

16 (2) The Board of County Commissioners for St. Mary's County may
17 provide by resolution for the members of a volunteer company in the county to be
18 covered employees while on duty.

19 (u) (1) Unless an election is made under paragraph (2) of this subsection,
20 a member of a volunteer company in Somerset County is not a covered employee.

21 (2) The Board of County Commissioners for Somerset County may
22 provide by resolution for members of a volunteer company in the county to be covered
23 employees while on duty.

24 (v) (1) A member of a volunteer company in Talbot County is a covered
25 employee.

26 (2) The County Council of Talbot County may provide by resolution for
27 members of a volunteer company in the county to be covered employees while on duty.

28 (w) (1) Unless an election is made under paragraph (2) of this subsection,
29 a member of a volunteer company in Washington County is not a covered employee.

30 (2) The Board of County Commissioners for Washington County may
31 provide by resolution for members of a volunteer company in the county to be covered
32 employees while on duty.

1 (x) (1) A member of a volunteer company in Wicomico County is a covered
2 employee.

3 (2) The County Council of Wicomico County may provide by resolution
4 for members of a volunteer company in the county to be covered employees while on
5 duty.

6 (y) (1) Unless an election is made under paragraph (2) of this subsection,
7 a member of a volunteer company in Worcester County is not a covered employee.

8 (2) The Board of County Commissioners for Worcester County may
9 provide by resolution for members of a volunteer company in the county to be covered
10 employees while on duty.

11 (z) (1) For the purposes of this title, a member of a volunteer company
12 who is a covered employee under this section is an employee of the political
13 subdivision of the State where the volunteer company is organized.

14 (2) A member of a volunteer company shall be covered while on duty
15 by a policy of workers' compensation insurance.

16 (aa) A member of a volunteer company who is a covered employee under this
17 section may not be considered a paid covered employee of the volunteer company for
18 receiving as a membership benefit a yearly stipend of \$5,200 or less to help offset
19 out-of-pocket expenses.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2014.
