## A BILL ENTITLED

1 AN ACT concerning

2 **State Government – Display of the POW/MIA Flag on State Building Grounds**

3 FOR the purpose of requiring the Secretary of General Services and the Secretary of  
4 Transportation to cause the POW/MIA flag to be flown on the grounds of certain  
5 State buildings whenever the flag of the United States is flown; providing for the  
6 application of a certain provision of this Act; defining a certain term; and generally  
7 relating to the display of the POW/MIA flag on the grounds of State buildings.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – State Finance and Procurement**

16 **4–210.**

17 (A) IN THIS SECTION, “POW/MIA FLAG” MEANS THE POW/MIA FLAG OF  
18 THE NATIONAL LEAGUE OF FAMILIES OF AMERICAN PRISONERS AND MISSING IN  
19 SOUTHEAST ASIA.

20 (B) THIS SECTION DOES NOT APPLY TO:

21 (1) THE STATE HOUSE; OR

- 1           **(2) A STATE BUILDING THAT:**
- 2                   **(I) IS A HISTORIC BUILDING; OR**
- 3                   **(II) 1. HAS A FLAGPOLE ATTACHED TO THE BUILDING; AND**
- 4                               **2. IS DETERMINED TO BE STRUCTURALLY UNABLE TO**  
5 **WITHSTAND ADDITIONAL FLAGS BEING FLOWN FROM THE FLAGPOLE.**

6           **(C) THE SECRETARY OF GENERAL SERVICES AND THE SECRETARY OF**  
7 **TRANSPORTATION SHALL CAUSE THE POW/MIA FLAG TO BE FLOWN ON THE**  
8 **GROUNDS OF ALL STATE BUILDINGS UNDER THEIR CONTROL WHENEVER THE FLAG**  
9 **OF THE UNITED STATES IS FLOWN.**

10           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 October 1, 2016.
