1 AN ACT concerning

Plastic Bag Reduction Act

3 FOR the purpose of prohibiting, on or after a certain date, a certain retail establishment 4 from distributing plastic carryout bags to a customer at the point of sale; providing 5 that, on or after a certain date, only the State may enact a law or take other action 6 to prohibit, restrict, or regulate the use of certain plastic bags by a retail 7 establishment, that certain authority of a county or municipality is preempted, and 8 that certain laws or ordinances are superseded; establishing a certain maximum civil 9 penalty for a violation of this Act; establishing that the distribution of a certain 10 number of plastic carryout bags at a single point of sale constitutes a single violation; 11 prohibiting the imposition of a penalty under this Act unless certain conditions are 12 met; authorizing a unit of county government to grant a certain waiver under certain 13 circumstances; providing for the enforcement of this Act; prohibiting a county or 14 municipality from adopting or enforcing a certain law or ordinance unless certain 15 conditions are met; requiring the Maryland Department of Labor to adopt certain 16 regulations; defining certain terms; and generally relating to carryout bags.

- 13 (B) ON OR AFTER JULY 1, 2022, A RETAIL ESTABLISHMENT MAY NOT
- 14 PROVIDE A PLASTIC CARRYOUT BAG TO A CUSTOMER.
- 15 (C) SUBJECT TO SUBSECTION (D) OF THIS SECTION, A RETAIL
- 16 ESTABLISHMENT THAT VIOLATES THIS SECTION IS SUBJECT TO A CIVIL PENALTY
- 17 NOT EXCEEDING \$500.
- 18 (D) (1) THE PROVISION OF ONE OR MORE PLASTIC CARRYOUT BAGS AT A
- 19 SINGLE POINT OF SALE IS A SINGLE VIOLATION.
- 20 (2) A PENALTY MAY NOT BE IMPOSED UNDER THIS SECTION UNLESS

- (G) 15 **(1)** NOTWITHSTANDING ANY OTHER LAW AND EXCEPT AS PROVIDED 16 IN PARAGRAPH (2) OF THIS SUBSECTION, A COUNTY OR MUNICIPALITY MAY NOT 17 ADOPT OR ENFORCE A LAW OR AN ORDINANCE THAT REQUIRES A RETAIL ESTABLISHMENT TO CHARGE AND COLLECT A FEE, A TAX, OR ANY OTHER CHARGE 18 19 FOR THE USE OF CARRYOUT BAGS AT THE POINT OF SALE UNLESS THE LAW OR 20 ORDINANCE IS AUTHORIZED BY A STATE LAW ENACTED ON OR AFTER JANUARY 1, 2022. 21
- 22 (2) WITH RESPECT TO A COUNTY OR MUNICIPALITY THAT, ON OR
 23 BEFORE FEBRUARY 1, 2021, ADOPTED A LAW OR AN ORDINANCE THAT REQUIRES A
 24 RETAIL ESTABLISHMENT TO CHARGE AND COLLECT A FEE, A TAX, OR ANY OTHER
 25 CHARGE FOR THE USE OF CARRYOUT BAGS AT THE POINT OF SALE, THIS
 26 SUBSECTION DOES NOT AFFECT THE AUTHORITY OF THE COUNTY OR MUNICIPALITY
