Frederick Center for Research and Education in Science and Technology

3 FOR the purpose of establishing the Frederick Center for Research and Education in Science and Technology; altering the name of the Frederick Center for Research and 4 5 Education in Science and Technology (CREST); altering the name of the Frederick 6 Center for Research and Education in Science and Technology Governing Board; 7 altering the powers and duties of the Board to require the Board to operate and 8 exercise general control over the Frederick CREST; authorizing the Board to fix the salaries and terms of employment of the Director and other employees of Frederick 9 10 CREST; authorizing the Board to purchase, lease, sell, or otherwise acquire or 11 dispose of certain property; authorizing the Director of Frederick CREST or the chair 12 of the Board to execute certain legal documents under certain circumstances; 13 requiring the Board to submit an adopted mission statement to the Maryland Higher 14 Education Committee Commission subject to certain Commission policies and 15 guidelines; making this Act an emergency measure; and generally relating to the Frederick Center for Research and Education in Science and Technology. 16
