## State Board of Examiners of Psychologists - License Renewal

- 3 FOR the purpose of altering the time period before a license expires by which the 4 Board of Examiners of Psychologists is required to send a renewal notice to a 5 licensee; requiring the Board, under certain circumstances, to send a renewal 6 notice by electronic means to a certain electronic mail address of a licensee; 7 requiring the Board, under certain circumstances, to send a renewal notice to a 8 licensee by first-class mail to a certain address of the licensee; requiring each 9 licensee to notify the Board in writing of any change in address or electronic 10 mail address within a certain number of days after the change occurs; making certain stylistic changes; and generally relating to license renewal by the State 11 Board of Examiners of Psychologists. 12

A license expires on the date set by the Board, unless it is renewed 22(a) **(1)** for an additional term as provided in this section. 23

1	(2) A license may not be renewed for a term longer than 2 years.

15	(1) The date on which the current license expires;
