A BILL ENTITLED

1 AN ACT concerning

2 **Alcoholic Beverages – Definition of Beer – Hard Cider**

3 FOR the purpose of altering the alcoholic content of hard cider that is part of the definition
4 of beer used in the Alcoholic Beverages Article; and generally relating to the
5 definition of beer under the Alcoholic Beverages Article.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 1–101.

20 (a) In this article the following words have the meanings indicated.

21 (c) (1) “Beer” means a brewed alcoholic beverage.

22 (2) “Beer” includes:

- 1 (i) ale;
- 2 (ii) porter;
- 3 (iii) stout;
- 4 (iv) hard cider that:
- 5 1. is derived primarily from apples, apple concentrate and
6 water, pears, or pear concentrate and water; and
- 7 2. contains no other fruit product but contains at least
8 one-half of 1% and less than ~~[7%]~~ **8.5%** of alcohol by volume; and
- 9 (v) an alcoholic beverage that contains:
- 10 1. 6% or less alcohol by volume, derived primarily from the
11 fermentation of grain, with not more than 49% of the alcoholic beverage's overall alcohol
12 content by volume obtained from flavors and other added nonbeverage ingredients
13 containing alcohol; or
- 14 2. more than 6% alcohol by volume, derived primarily from
15 the fermentation of grain, with not more than 1.5% of the alcoholic beverage's overall
16 alcohol content by volume obtained from flavors and other added nonbeverage ingredients
17 containing alcohol.
- 18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
19 1, 2017.
