CHAPTER _____

1 AN ACT concerning

2 **Health Occupations Boards – Revisions**

3 FOR the purpose of requiring certain health occupations boards to provide certain
4 notification to certain licensees or certificate holders of board vacancies;
5 requiring certain health occupations boards to collect certain racial and ethnic
6 information; requiring that, to the extent practicable, certain members of
7 certain health occupations boards reasonably reflect certain geographic, racial,
8 ethnic, cultural, and gender diversity; requiring certain health occupations
9 boards to develop collaboratively certain training and materials for certain
10 board members; requiring the Secretary of Health and Mental Hygiene to
11 confirm the appointment of certain directors; requiring that after certain
12 consultation and to the extent permitted by certain resources, certain health
13 occupations boards establish certain subcommittees to be responsible for certain
14 investigations, determine whether certain charges should be brought, and
15 participate in certain preadjudication case resolution conferences; prohibiting

2 certain complaints the board receives after a certain period of time; requiring
3 certain health occupations boards that are authorized to use peer review to
4 provide certain licensees and certificate holders an opportunity to review and
5 respond to certain reports; requiring certain health occupations boards to
6 consider certain reports and responses before taking certain action; authorizing
7 certain health occupations boards to establish certain programs to provide
8 certain training, mentoring, or other remediation for certain licensees or
9 certificate holders who commit a certain number of standard of care violations;
10 requiring certain health occupations boards to adopt certain sanctioning
11 guidelines; requiring certain health occupations boards to post certain orders for

33 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
34 MARYLAND, That the Laws of Maryland read as follows:

17 THE COMPLAINT.

18 (B) THIS SECTION DOES NOT APPLY TO A COMPLAINT BASED ON:

19 (1) CRIMINAL CONVICTIONS OR SEXUAL MISCONDUCT OR OTHER
20 SIMILAR BOUNDARY VIOLATIONS;

21 (2) RECIPROCAL DISCIPLINE MATTERS;

22 (3) ONGOING SUBSTANCE ABUSE;

23 (4) FRAUDULENT CONCEALMENT OF MATERIAL INFORMATION;

24 OR

25 (5) ~~ACTS THAT WERE PART OF A PATIENT'S REPRESSED MEMORY;~~

27 ~~(6)~~ ACTS THAT OCCUR WHILE A PATIENT IS A MINOR.

1 (A) IF A STATUTE AUTHORIZES A HEALTH OCCUPATIONS BOARD TO USE
2 A SYSTEM OF PEER REVIEW IN STANDARD OF CARE CASES AND THE PEER
3 REVIEWER OR PEER REVIEWERS DETERMINE THAT THERE HAS BEEN A
4 VIOLATION OF A STANDARD OF CARE, THE BOARD SHALL PROVIDE THE
5 LICENSEE OR CERTIFICATE HOLDER UNDER INVESTIGATION WITH AN
6 OPPORTUNITY TO REVIEW THE FINAL PEER REVIEW REPORT AND PROVIDE THE
7 BOARD WITH A WRITTEN RESPONSE WITHIN 10 BUSINESS DAYS AFTER THE
8 REPORT WAS SENT TO THE LICENSEE OR CERTIFICATE HOLDER.

9 (B) IF A HEALTH OCCUPATIONS BOARD RECEIVES A WRITTEN
10 RESPONSE TO A FINAL PEER REVIEW REPORT, THE BOARD SHALL CONSIDER
11 BOTH THE REPORT AND RESPONSE BEFORE TAKING ANY ACTION.

13 (A) AS AN ALTERNATIVE TO A FORMAL HEARING, EACH HEALTH
14 OCCUPATIONS BOARD MAY ESTABLISH A PROGRAM FOR LICENSEES OR
15 CERTIFICATE HOLDERS WHO COMMIT A SINGLE STANDARD OF CARE VIOLATION.

16 (B) A PROGRAM ESTABLISHED UNDER THIS SECTION SHALL PROVIDE
17 TRAINING, MENTORING, OR OTHER FORMS OF REMEDIATION AS DETERMINED
18 BY THE HEALTH OCCUPATIONS BOARD.

19 (C) A HEALTH OCCUPATIONS BOARD MAY REFER A LICENSEE TO THE
20 PROGRAM.

22 (A) EACH HEALTH OCCUPATIONS BOARD SHALL ADOPT SPECIFIC
23 SANCTIONING GUIDELINES, INCLUDING:

24 (1) A RANGE OF SANCTIONS THAT IS BASED ON HISTORICAL DATA
25 OR A NORMATIVE PROCESS FOR EACH TYPE OF VIOLATION; AND

26 (2) A LIST OF MITIGATING AND AGGRAVATING CIRCUMSTANCES
27 THAT MAY BE USED TO DECIDE IF A SANCTION FALLS WITHIN OR OUTSIDE THE
28 ESTABLISHED RANGE OF SANCTIONS.

29 (B) SANCTIONING GUIDELINES ADOPTED UNDER THIS SECTION SHALL:

30 (1) CONFORM TO A GENERAL FRAMEWORK OR INCORPORATE A
31 COMMON SET OF ELEMENTS; AND

1 **(2) BE USED AS A GUIDE FOR SANCTIONING LICENSEES AND**
2 **CERTIFICATE HOLDERS IN FORMAL AND INFORMAL PROCEEDINGS.**

3 **(C) (1) TO THE EXTENT A HEALTH OCCUPATIONS BOARD DEPARTS**
4 **FROM THE SANCTIONING GUIDELINES ADOPTED UNDER THIS SECTION, THE**
5 **BOARD SHALL STATE ITS REASONS.**

6 **(2) A DEPARTURE FROM THE GUIDELINES ALONE IS NOT**
7 **GROUND FOR ANY HEARING OR APPEAL OF ANY BOARD ACTION.**

9 **EACH HEALTH OCCUPATIONS BOARD SHALL POST ON THE BOARD'S**
10 **WEBSITE EACH FINAL, PUBLIC ORDER FOR A DISCIPLINARY SANCTION ISSUED**
11 **TO A LICENSEE OR CERTIFICATE HOLDER.**

13 **(A) THE SECRETARY SHALL MONITOR THE TIMELINESS OF COMPLAINT**
14 **RESOLUTION FOR EACH HEALTH OCCUPATIONS BOARD.**

16 **ESTABLISH GOALS FOR THE TIMELINESS OF COMPLAINT RESOLUTION FOR ALL**

21 **(II) AFTER A BOARD MAKES A DECISION TO CHARGE, A**

23 **(III) AFTER A BOARD ISSUES CHARGES, A GOAL FOR THE**
24 **LENGTH OF TIME A BOARD HAS TO SCHEDULE A HEARING; AND**

25 **(IV) AFTER THE DATE OF AN OPINION FROM THE OFFICE OF**
26 **ADMINISTRATIVE HEARINGS, OR THE FINAL DAY OF ANY HEARING, A GOAL FOR**
27 **THE LENGTH OF TIME A BOARD HAS TO ISSUE A FINAL DECISION.**

28 **(2) WHEN DETERMINING THE TIME FRAMES FOR COMPLAINT**
29 **RESOLUTION, THE SECRETARY SHALL CONSIDER:**

30 **(I) THE ADMINISTRATIVE AND FISCAL CONSTRAINTS OF**
31 **EACH HEALTH OCCUPATIONS BOARD; AND**

1 **(II) THE RECOMMENDATIONS FROM THE TASK FORCE ON**
2 **DISCIPLINE OF HEALTH CARE PROFESSIONALS AND IMPROVED PATIENT**
3 **CARE.**

4 **(3) THE GOALS ESTABLISHED BY THE SECRETARY IN**
5 **ACCORDANCE WITH THIS SECTION ARE NONBINDING AND FAILURE TO MEET**
6 **THE GOALS MAY NOT BE USED AS GROUNDS FOR ANY HEARING OR APPEAL OF**
7 **ANY BOARD ACTION.**

8 **(C) ON OR BEFORE OCTOBER 1, 2012, THE SECRETARY OF HEALTH**
9 **AND MENTAL HYGIENE SHALL, IN ACCORDANCE WITH § 2-1246 OF THE STATE**
10 **GOVERNMENT ARTICLE, REPORT TO THE SENATE EDUCATION, HEALTH, AND**
11 **ENVIRONMENTAL AFFAIRS COMMITTEE AND THE HOUSE HEALTH AND**
12 **GOVERNMENT OPERATIONS COMMITTEE ON THE GOALS FOR THE TIMELINESS**
13 **OF COMPLAINT RESOLUTION ESTABLISHED UNDER THIS SECTION.**

15 **(A) EACH HEALTH OCCUPATIONS BOARD SHALL COLLABORATE WITH**
16 **THE OFFICE OF THE ATTORNEY GENERAL TO MAKE GUIDELINES AVAILABLE TO**
17 **THE PUBLIC CONCERNING THE SEPARATE ROLES FOR ASSISTANT ATTORNEYS**
18 **GENERAL AS COUNSEL AND PROSECUTOR FOR THE BOARD.**

19 **(B) NONCOMPLIANCE WITH THE GUIDELINES MADE AVAILABLE UNDER**
20 **THIS SECTION MAY NOT BE USED AS GROUNDS FOR ANY HEARING OR APPEAL OF**
21 **ANY BOARD ACTION.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December
23 31, 2011, each health occupations board shall report to the Senate Education, Health,
24 and Environmental Affairs Committee and the House Health and Government
25 Operations Committee, in accordance with § 2-1246 of the State Government Article,
26 on:

27 (1) its success in meeting the goals and requirements of this Act; and

28 (2) ways in which separation of the board's disciplinary functions can
29 be further achieved.

30 SECTION 3. AND BE IT FURTHER ENACTED, That, on or before December
31 31, 2011, the health occupations boards in collaboration with the Department of
32 Health and Mental Hygiene shall jointly:

1 (1) study whether under certain circumstances it may be appropriate
2 to expunge disciplinary proceedings from a licensee’s file after a specified period of
3 time; and

4 (2) report the findings of the study to the Senate Education, Health,
5 and Environmental Affairs Committee and the House Health and Government
6 Operations Committee, in accordance with § 2–1246 of the State Government Article.

7 SECTION 4. AND BE IT FURTHER ENACTED, That this Act may not be
8 construed to diminish, alter, or enhance the existing authority of any party to exercise
9 any responsibility in the appointment of membership to any health occupations board,
10 as provided by the Health Occupations Article.

11 SECTION 5. AND BE IT FURTHER ENACTED, That, except as otherwise
12 provided by law, this Act shall be construed to apply only prospectively and may not be
13 applied or interpreted to have any effect on or application to any complaint made to a
14 health occupations board before the effective date of this Act.

15 SECTION 6. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2010.
