Education – Public and Nonpublic Schools – Seizure Action Plans (Brynleigh's Act)

4 FOR the purpose of requiring a county board of education and authorizing a nonpublic 5 school, beginning in a certain school year, to require a certain number of school 6 personnel at the school to be trained in certain seizure recognition and response 7 methods; requiring a public school, beginning in a certain school year, to provide 8 online or in-person training with a certain frequency to school personnel with direct 9 contact and supervision of students on certain seizure recognition and response methods; requiring the State Department of Education and the Maryland 10 11 Department of Health, in consultation with a certain entity and stakeholders, to 12 develop guidelines and a training program for school personnel on the health care 13 needs of a student diagnosed with a seizure disorder; requiring the parent or 14 guardian of a student diagnosed with a seizure disorder to collaborate with school 15 personnel to create a seizure action plan and provide the school with certain 16 information; requiring the State Department of Education, in collaboration with the 17 Maryland Department of Health, to ensure health guidelines include certain 18 information on seizures; and generally relating to responding to seizure symptoms 19 and emergencies in schools in the State.
