A BILL ENTITLED

1 AN ACT concerning

2 **Commercial Northern Snakehead License – Gear**

3 FOR the purpose of repealing certain buffer zones within which a commercial northern
4 snakehead licensee may not fish using bowfishing gear; requiring a licensee who
5 fishes for northern snakehead to comply with Department of Natural Resources
6 regulations governing the use of gear; and generally relating to gear used under the
7 commercial northern snakehead license.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Natural Resources**

16 4–701.1.

17 (a) There is a commercial northern snakehead license.

18 (b) **[(1)]** The license authorizes the holder to catch for sale northern snakeheads
19 in the tidal waters of the State using:

20 **[(i)] (1)** A bow and arrow attached to a retrieval line; or

1 **[(ii)] (2)** Hook and line.

2 **[(2)** A licensee may not fish with a bow and arrow under the license within
3 100 yards of:

4 (i) Another person or vessel;

5 (ii) A public or private swimming area;

6 (iii) A diver down flag; or

7 (iv) An occupied offshore stationary blind.]

8 (c) An applicant for a license does not need to hold a tidal fish license under §
9 4–701 of this subtitle to be eligible for the license.

10 (d) A person who wishes to obtain a license shall complete and submit an
11 application for the license to the Department or any person designated by the Department.

12 (e) The term of the license is 1 year from September 1 through August 31 of the
13 following year.

14 (f) The annual license fee is \$15.

15 (g) A licensee may not transfer a license issued under this section.

16 (h) A licensee who fishes for northern snakehead under the license shall possess
17 the license.

18 **(I) A LICENSEE WHO FISHES FOR NORTHERN SNAKEHEAD UNDER THE**
19 **LICENSE SHALL COMPLY WITH ALL DEPARTMENT REGULATIONS GOVERNING THE**
20 **USE OF GEAR.**

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2024.
