1 AN ACT concerning

2 **Queen Anne's County – Beer, Wine and Liquor Tasting License**

3 FOR the purpose of creating in Queen Anne's County a beer, wine and liquor tasting
4 license; specifying to whom the license may be issued; setting maximum limits
5 on the amounts of certain individual servings; specifying that the license may be
6 issued for tasting purposes only; establishing a license fee; and generally
7 relating to alcoholic beverages licenses in Queen Anne's County.

3 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
4 read as follows:

5 **Article 2B – Alcoholic Beverages**

6 **8–410.2.**

7 **(A) THIS SECTION APPLIES ONLY IN QUEEN ANNE’S COUNTY.**

8 **(B) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A BEER, WINE**
9 **AND LIQUOR TASTING (BWLTL) LICENSE.**

10 **(C) A BWLTL LICENSE MAY BE ISSUED ONLY TO A HOLDER OF A CLASS**
11 **A BEER, WINE AND LIQUOR LICENSE.**

12 **(D) (1) A BWLTL LICENSE AUTHORIZES THE CONSUMPTION FOR**
13 **TASTING PURPOSES ONLY OF:**

14 **(I) NOT MORE THAN 1 OUNCE OF BEER FROM EACH GIVEN**
15 **BRAND AND 4 OUNCES FROM ALL BRANDS;**

16 **(II) NOT MORE THAN 2 OUNCES OF WINE FROM EACH GIVEN**
17 **BRAND AND 4 OUNCES FROM ALL BRANDS; AND**

18 **(III) NOT MORE THAN ONE–HALF OUNCE OF LIQUOR FROM**
19 **EACH GIVEN BRAND AND 1.5 OUNCES FROM ALL BRANDS.**

20 **(2) THE LIMITS ON CONSUMPTION SPECIFIED IN PARAGRAPH (1)**
21 **OF THIS SUBSECTION APPLY TO ONE INDIVIDUAL IN A SINGLE DAY.**

22 **(E) THE ANNUAL LICENSE FEE FOR THE BWLTL LICENSE IS \$100 IN**
23 **ADDITION TO THE FEE FOR ANY OTHER ALCOHOLIC BEVERAGES LICENSE HELD**
24 **BY THE LICENSE HOLDER.**

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 July 1, 2013.
